GENERAL RULES:

Solvancy certificate shall in the prescribed Performa given and should be in the Enlisting person's Banker's letter head to the concerned enlisting authority.(OR) The Solvancy should be in the name of the applicant or any of the partner and should be obtained from the Revenue Department official not below the rank of Tahsildar and issued not earlier than one year from the date of 01.06.2010.

The validity of registration is only for **Three** years and is to be renewed. If status is changed on account of any reason, the registered vendor shall inform the designated authority of BAP within 15 days of such Change. Otherwise their registration shall liable for cancellation.

Those who have enlisted with BAP will also to apply for fresh Registration Number with required Documents.

All the contractors are required to apply to the Income Tax officers of the area in which they are assessed for grant of Income Tax Clearance Certificate in the month of May every year. The tax clearance certificate in original should be submitted to the department who has enlisted the contractor by the end of June every year.

The contractors, who will fail to submit the Tax Clearance Certificate or fail to show any justifiable reasons for nonsupply of the Income Tax Clearance Certificate in their names will be liable to be removed from the approved list of contractors.

Contractors will be required to certify that they will not get themselves registered under more than one name.

Contractors who are near relatives to Officers responsible for award of work and execution of contract will not be allowed to enlistment.

The list of approved contractors will be reviewed periodically for their satisfactory performance.

Registered Contractors are required to respond for all enquiries. In case they fail to respond for five consecutive enquiry their Registration will automatically stand for Cancellation of their registration status.

Contractors are required to possess ESI Account with the code numbers where ever applicable allotted to them by ESI authorities .They will comply with the all statutory requirements including minimum wages declared by BHEL. On award of contract ,they shall obtain necessary license under contract Labour Regulation and Abolition Act and Comply with the provision of the said Act.
