- The Bidder should be fully conversant with the site condition.
- The bidders must visit site to appraise himself of the site / intake system condition and given confirmation in writing declaring that site visit has been done before submission of bid.
- The Bidder has to follow all the safety compliances and statutory regulations in practice at site as per approved methodology. Proper earthing to electrical machines, PPE's for labour shall be arranged by Bidder. However, required safety manpower to supervise the work shall be arranged by BHEL.

- The product quality shall be responsibility of the bidder and joint protocol to be signed after installation of the chairs.
