8.0 VALIDITY:-

- 8.1 This rate contract will be valid for a period of **ONE YEAR.** If services found satisfactory the contract may be extended further as per terms.
- 8.2 Contract can be terminated at any time by BHEL with 2 weeks' prior notice under following circumstances.
 - 8.2.1 Failure to pay salary to the security guards by stipulated time.
 - 8.2.2 Failure to provide proof of statutory remittance like PF & ESI.
 - 8.2.3 Failure to provide proof of GST remittance.
 - 8.2.4 Any misconduct by the security staff employed by the contractor.

9.0 SECURITY DEPOSIT:

- 9.1 Successful bidder shall furnish the security deposit immediately on issue of the Letter of Intent/ Work Order and before the commencement of work. Security deposit will be released only after one month after completion of contract period. Successful bidder shall submit no dues signed by all security guards engaged by them for releasing Security Deposit amount.
- 9.2 The total amount of security deposit will be 5% of the contract value. EMD of the successful tenderer shall be converted and adjusted towards the required amount of Security Deposit.
- 9.3 Modes of deposit:

The balance amount (after converting EMD to security deposit) to make up the required Security Deposit (i.e. 5% of the contract value) may be accepted in the following forms:

- i) Cash (as permissible under the extant Income Tax Act)
- ii) Local cheques of Scheduled Banks (subject to realization)/ Pay Order/Demand Draft/ Electronic Fund Transfer in favour of BHEL

- 9.4 At least 50% of the Security Deposit, including the EMD, shall be collected before start of the work. Balance 50% of the Security Deposit shall be collected by deducting 10% of the gross amount progressively from each of the running bills of the successful bidder till the total amount of the security deposit is collected.
- 9.5 Security deposit will be refunded one month after completion of contract period.
- 9.6 The security deposit shall not carry any interest.

10.0 STATUATORY REQUIREMENTS:

- 10.1 Contractor has to submit the proof of PF, ESI and GST remittance etc.
- 10.2 The contractor shall comply with contract labour (R&A) act and shall possess the registers & forms as stipulated in the Act in a neat and complete manner for verification of statutory authorities and the company officials.

11.0 TAXES AND DUTIES

11.1 All taxes and duty other than GST & Cess and BOCW Cess

The successful bidder shall pay all (save the specific exclusions as enumerated in this contract) taxes, fees, license charges, deposits, duties, tolls, royalty, commissions, Stamp Duties, or other charges / levies, which may be levied on the input goods & services consumed and output goods & services delivered in course of his operations in executing the contract. In case BHEL is forced to pay any of such taxes, BHEL shall have the right to recover the same from his bills or otherwise as deemed fit.

11.2 Goods and service Tax (GST) & Cess

Bidder's price/rates shall be exclusive of GST & Cess (if applicable) (herein after termed as GST). Successful bidder shall submit to BHEL the GST compliant tax invoice/debit note/revised tax invoice on the basis of which BHEL will claim the input tax credit in its return.

Agency shall furnish proof of GST registration with GSTN Portal covering the services under this contract. Registration should also bear endorsement for the premises from where the billing shall be done by the successful bidder on BHEL for this project/ work.

Bidder shall note that the GST Tax Invoice complying with GST Invoice Rules wherein the 'Bill To' details as per Clause 7.0.

GST charged in the tax invoice/debit note/revised tax invoice by the successful bidder shall be released separately to the successful bidder only after successful bidder files the outward supply details in GSTR-1 on GSTN portal and input tax credit of such invoice is matched with corresponding details of outward supply of the successful bidder and has paid the GST at the time of filing the monthly return.

In case BHEL has to incur any liability (like interest etc.) due to denial/reversal of input tax credit in respect of the invoice submitted by the successful bidder, for the reasons attributable to the successful bidder, the same shall be recovered from the successful bidder.

In case BHEL is deprived of the Input tax credit due to any reason attributable to successful bidder, the same shall not be paid to the successful bidder. Tax invoice/debit Note/revised tax invoice shall contain the particulars as prescribed in GST law.

TDS under GST is applicable and shall be deducted at prevailing rates on gross invoice value from the running bills. E-way bills / Transit passes / Road Permits, if required for materials / T&P etc., bought into the project site is to be arranged by the successful bidder only.

If RCM is applicable, GST will be paid by BHEL to the department at applicable rate.

Statutory Variations

Statutory variations are applicable under the GST Acts, against production of proof. The changes implemented by the Central / State Government during the tenure of the contract viz. increase / decrease in the rate of taxes, applicability, etc. and its impact on upward revision / downward revision are to be suitably paid/ adjusted from the date of respective variation. The bidder shall give the benefit of downward revision in favour of BHEL. No other variations shall be allowed during the tenure of the contract.

11.3 Direct Tax

BHEL shall not be liable towards Income Tax of whatever nature including variations thereof arising out of this contract as well as tax liability of the

bidder and their personnel. Deduction of tax at source at the prevailing rates shall be effected by BHEL before release of payment as a statutory obligation, unless exemption certificate is produced by the bidder. TDS certificate will be issued by BHEL as per the provisions of Income Tax Act.

12.0 SPECIAL TERMS & CONDITIONS:

- 12.1 Presently we require 06 (Six) Nos. of security guards (02 persons for each shift). However, payment shall be made on the actual deployment of manpower, verified as per time sheet during the month.
- 12.2 In addition to payment of wages, two pairs of uniform (with logo) once in a year and one pair of shoes with two pairs of socks to be provided by the contractor to security guards.
- 12.3 Contractor shall pay wages to his guards immediately on conclusion of the month or in any case not later than 05th of the succeeding month only through NEFT.
- 12.4 Delayed, non-payment or short payment of wages to his employees by the contractor shall be taken seriously by BHEL and contract may be terminated if no valid reason is found.
- 12.5 The contractor shall pay Basic, VDA, HRA, Bonus and relieving OT charges every month to all the security guards deployed on prorate basis as per the duties performed.
- 12.6 Whenever there is any increase of wages or DA over and above the wages mentioned above the same will be borne by BHEL including the consequential benefits like PF, ESI etc., (Company contribution). The hike in Wages/DA/Consequential payments will be paid by you in the first place and reimbursement sought from BHEL without any additional service charges. GST at applicable rates will be paid extra by BHEL over the bill amount on proof of remittance of GST (to be submitted to BHEL every month).
- 12.7 In case of any dispute (or) differences arises between the parties under the contract, the decision of BHEL will be final and binding on the contractor.
- 12.8 Any Accommodation and medical facilities shall not be provided by BHEL for the Security personnel engaged by the Contractor.

TERMS AND CONDITIONS:

- a) To provide Security services round the clock on all the **365** days of the year at the aforesaid premises/ buildings/ gates/ installations/ boundary walls. Security personnel (Civil guard) deployed to carry out the job preferably age group of 38 to 58 years and they should know languages Telugu, Hindi and English and should be physically fit.
- b) To provide effective surveillance of the security services.
- c) To guard/patrol/check during day and night and ensure that no theft, pilferage, trespass, accident, nuisance, disturbance of peace and disorderliness etc. takes place in the area.
- d) To man all entry/exit points, regulate and check the flow of men/material and ensure that every entry/exit is as per valid documents and a record of the same be maintained. To guard the premises in such a manner that no property is taken away by any one unauthorized.
- e) To apprehend immediately any trespasser or person moving unauthorized and under suspicious circumstances and deal as per law in consultation with designated office of BHEL.
- f) To search the person and his belongings on a random basis as well as in suspicious cases both during entry and exit and inform the designated officer in case the person is found carrying any unauthorized property of the Company.
- g) To watch habitual offenders and mischief makers and inform the designated officer of BHEL if anything unusual is noticed.
- h) To provide protection in case of assault/apprehension of assault to any employee of BHEL.
- i) To seize goods suspected to be stolen and hand them over to the designated office of BHEL.
- j) To bring any untoward occurrence/incidents in the company premises to the notice of designated officer of BHEL without delay.
