SCOPE OF WORK

1. Brief Scope of Work: -

- a) Manufacture of Steel Boxes inside BHEL, Ranipet factory premises with BHEL material as per the BHEL Drawings Annexure-I page no 55-62, with one coat of Red Oxide/any other similar paint as stated by BHEL.
- b) Where in BHEL Scope is restricted to providing Open Yard space, EB Power Supply and Consumables restricted to Compressed air, Welding Electrodes, Paints and Thinner. Facilities and equipment required for fabrication, cutting, grinding like electric welding m/c, gas welding, Oxygen, LPG, Acetylene and other consumables are in Vendor's scope.
- c) Adherence to Safety practices including protective equipment, by fitters, welders & laborers is in Vendor's scope.
- d) Collection of Raw materials (from RM Stores/disposal yard inside BHEL factory Premises), handling of job during fabrication, loading / unloading and transportation of finished goods to shipping department (Inside BHEL Factory premises, S3 Yard and S4 Yard), transportation of scrap material and Empty Tins to Disposal Stores yard (inside BHEL factory Premises) are under Vendor's scope.
- e) Ensuring social distancing. usage of protective mask, gloves and hand sanitizer is in Vendor's scope.

2. Scope of Contractor:

- a) The fabrication has to be done in BHEL factory premises as allotted by BHEL.
- b) Engagement of adequate manpower to cater shipping delivery requirement.
- c) Consumables like oxygen and acetylene cylinders as required for welding
- d) Internal and external transportation of raw material, paint and any such material needed for fabrication to the allotted fabrication area
- e) Fabrication of structural steel Components / items including power tool cleaning, grinding, cutting, painting and stenciling etc. as per BHEL drawings and specifications.
- f) The contractors shall bring all other accessories like welding machines (high efficiency and less power consumption) including welding electrodes, gas cutting sets including gas, grinding machine with grinding wheels, drilling machine with drill bits, tools &

tackles, crane(s), safety equipment, ladders, tools required for spray painting, male & female collectors from power source etc. to carry out the fabrication work

- g) Any consumables which are not mentioned in BHEL scope
- h) Delivery of fabricated boxes to various yards (S3 and S4 yards which are located outside factory premises) based on Shipping department need
- i) Adhering to statutory norms and safety guidelines issued from time to time by BHEL
- j) Coordination for material collection, inspection and billing is under contractor scope
- k) Returning of any excess materials including prime material / big size scrap/cut bits/ scrap/fasteners/empty paint drums etc. to BHEL stores as instructed by BHEL Engineer.
- l) Material accounting and bill coordination with various departments.
- m) Requirement of any handling devices viz., cranes, tools etc.,

Note : The raw materials includes cut bits and other materials from disposable yard which are identified for box fabrication

3. Scope of BHEL:

- a) Providing open yard space with welding points for ease of fabrication.
- b) All materials required as per BOM of the drawings.
- c) Paint and welding electrodes as per requirement will be provided
- d) Stress relieving of the welded components (if required) is in BHEL scope.
- e) Compressed air for painting of boxes will be made available
- f) Power supply will be provided at free of cost for fabrication needs.

4. Loading & Counter Offering: It is proposed to award the contract to a maximum of **four contractors** by counteroffering finalized L1 rate to other technically qualified bidders in seriatim basis to divide the work load and faster delivery of boxes.

- a) If any other three bidders accept counteroffered L1 rate, load sharing will be 35% for L1 bidder and 30%, 20% & 15% other three bidders respectively in seriatim basis as per ranking.
- b) If only two bidders accept counteroffered L1 rate, load sharing will be 40% for L1 bidder and 35% & 25% to other two bidders respectively in seriatim basis as per ranking

- c) If only one bidder accepts counteroffered L1 rate load sharing will be in the ratio of 60:40 for L1 & other counteroffer accepted bidder respectively.
- d) If no other bidders accept counteroffered L1 rate, entire 100% load has to be taken by L1 bidder.
- e) If only one bidder qualified, entire 100% load has to be taken by L1 bidder.

- 6. Delivery Schedule:** The details w.r.t delivery will be provided to each awardee along with LOA based on the percentage of awarded work. The total work will be distributed throughout the contract period. The distributed fabrication work will be sequentially awarded through PO with a specific delivery time.

7. Work Related Special Conditions

- a) The works are to be carried out and/or to be completed within the stipulated period and if necessary the contractor shall take necessary steps to augment the work force.
- b) *BHEL will allocate suitable open yard space inside BHEL premises to carry out the scope of work covered in this Tender. Sufficient levelled open area will be provided by BHEL. Further levelling, consolidation if required will have to be carried out by the Contractor.*
- c) For manufacturing of Steel Boxes inside BHEL's Factory Premises with BHEL material as per BHEL drawing, apart from providing of Open Yard-Space, Power supply and Consumables Restricting to Compressed Air, Welding Electrode and Paints are to be supplied by BHEL. Oxygen and Acetylene required for welding, arrangement of internal transport for movement of materials within factory premises and any other consumables required are with Vendor's scope.
- d) The contractor shall be solely responsible for the safe custody of the materials from the time the documents are handed over to him till the materials are delivered at the places specified by BHEL and will indemnify the BHEL against loss, damage, breakage, shortage

and pilferage of any materials while in their custody. BHEL norms shall be followed for all BHEL free issue items. Transport insurance if any has to be paid by the contractor as may be directed by BHEL.

- e) The period of the contract is One year and this may be reduced, renewed or extended at the discretion of BHEL.
- f) In case of any neglect or refusal on the part of the contractor to provide and non-readiness, insufficient readiness, insufficient labour for the aforesaid work or if in the opinion of Officer-in-charge, the services provided by the contractor are not satisfactory, the Officer-in-charge shall be at liberty to make such arrangement as he may deem fit at the cost and expenses of the contractor. The contractor shall be advised of the amount so incurred and he shall be bound to remit the sum within three days from the date of receipt of such advice. Failure to do so will entitle the Officer-in-charge to deduct the sum from the Security Deposit or from any money due to the contractor. Also BHEL reserves the right to cancel the contract and initiate alternate action at the Cost & Risk of such tenderer.
- g) The contractor shall either supervise the work or provide a supervisor to supervise the work of their staff. The supervisor employed by the contractor shall ensure proper out-turn of work and the discipline by the labour to be put on the job and in general see that the works are carried out in a safe and proper manner. The supervisor shall have technical qualification and experience to carry out the jobs.
- h) The contractor shall withdraw their labour only after obtaining the prior approval of the Officer-in charge and they shall arrange to re-employ the labour within a day from the date of intimation to them.
- i) BHEL is not responsible for the idle labour of the contractor for whatever reasons.
- j) Should any error or ambiguity be discovered in the specification or information, the contractor shall forthwith bring the same to the notice of BHEL before commencement of work. The BHEL's interpretation in such cases shall be final and binding on the contractor.
- k) In case the labour strength has to be increased to complete the work within the stipulated period, no extra claim for payment under any circumstances will be entertained.

- l) BHEL reserves the right to decide the suitability of the workers and other personnel who may be employed by the contractor. All movements of Men & Material are to be done through BHEL-East Gate/Shipping Gate only
- m) In case of damage or loss to any equipment's or components or any property of BHEL caused due to the negligence and carelessness of the contractor's men, the responsibility shall rest with the contractor. The actual cost of the damage or loss together with the overhead will be recovered from the contractor's bill. The decision of BHEL regarding the cost as well as the extent of cost of damage shall be final and conclusive. Necessary insurance coverage for all the risks to be taken by contractor.
- n) The contractor if required has to work in late hours with sufficient manpower to complete the task within the specified schedule date; BHEL will provide the necessary permission. All the other things are to be taken care by the contractor.
- o) Onsite Inspection: The awarded fabrication work will be done in the factory premises; hence progress will be periodically monitored by concern agencies.
- p) Job Inspection: The job will be inspected by the third party inspector assigned by Quality department of BHEL, Ranipet.

PRE-QUALIFICATION REQUIREMENTS (PQR)

An essential qualification requirement of the contractor for tender submission shall be as under:

- A. Average annual financial turnover of any 3 Financial Years out of last 5 financial years (beginning from 01.04.2017-31.03.2022) should not be less than Rs.5.75 lakhs.
- a. The bidder has to submit financial accounts (audited, if applicable comprising of Audit report, Balance Sheet, Profit & Loss A/c Statement and Notes/Schedules pertaining to Turnover/Sales/Revenue), for 5 years (or from the date of incorporation, whichever is less) as on tender due date to review the above criteria. In case the incorporation of vendor is less than 3 years, average annual financial turnover shall be calculated based on available information as below: -
 - i. If the accounts are available for ≤ 1 Financial Year, the Average Annual Turnover shall be calculated based on available information divided by 1 (One)
 - ii. If the accounts are available for >1 but ≤ 2 Financial Years, the Average Annual Turnover shall be calculated based on available information divided by 2 (Two)
 - iii. If the accounts are available for >2 but ≤ 3 Financial Years, the Average Annual Turnover shall be calculated based on available information divided by 3 (Three).
 - b. While calculating Annual Turnover / Sales, other operating income and other income shall not be considered.
- B. The contractors should have experience of successfully execution of Fabrication of steel packing boxes / steel components/structures” during the last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:
- a. Three similar completed works each costing not less than the amount equal to Rs.7.67 Lakhs (excluding GST).
 - b. Two similar completed works each costing not less than the amount equal to Rs.9.56 Lakhs (excluding GST).
 - c. One similar completed work costing not less than the amount equal to Rs.15.34 Lakhs (excluding GST).

Documents Required: Bidder has to submit LOA's of the works completed and corresponding work completion certificate. The work executed in the own name of the bidder only will be considered for similar works executed for meeting the eligibility criteria.

- v) Offers of the Contractors/Suppliers, against who, any unit of BHEL had initiated process for banning or already banned will summarily be rejected.
- vi) Possession of PF registration number is not mandatory. However, the successful tenderer has to register with PF authorities and furnish the registration number before first Running Account Bill.

INSTRUCTIONS TO BIDDER

1. **Earnest Money Deposit (EMD) amount: NIL**
2. **Bidders have to submit their offers through BHEL e-procurement portal (<https://eprocurebhel.co.in/nicgep/app>) only.**
3. **Bidder has to quote total lump sum value excluding GST & GST % as per BOQ.**
4. Should a tenderer or a contractor has a relative or in the case of a firm or company of contractors, any of its shareholders or shareholder's relative, employed in Bharat Heavy Electricals Limited, the authority inviting tenders shall be informed of this fact at the time of submission of the offer, failing which the offer may be disqualified or if such fact subsequently come to light, the contract may be cancelled.
5. BHEL employees and their dependents are NOT eligible to submit their offer against this contract. Even if they submit out of ignorance, the offer shall be disqualified.
6. If the contractor deliberately, gives wrong information in his tender or creates conditions favourable for the acceptance of his tender, Bharat heavy Electricals Limited reserves the right to reject such tender at any stage.
7. Canvassing in any form in connection with the tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
8. The tender documents must be signed physically / digitally by Director / Partner of the Firm or by the person holding the Power of Attorney on behalf of the Firm concerned. In the latter case, a copy of Power of Attorney, duly attested by a Notary Public must accompany the tender.
9. **The tender schedule and the tender shall be deemed to form an integral part of the contract to be entered into for this work.**
10. Tender can be cancelled at any stage due to unavoidable circumstances.
11. The evaluation currency for this tender shall be INR.
12. Multiple Bids: -

The bidder in his own interest shall submit only one id. If a bidder submits multiple bids, all the bids are liable for rejection. Bids shall be considered "Multiple" in the following circumstances:

- a) Two bids by the same party
- b) If one bidder is the affiliate of another bidder.

For the purpose of this clause "Affiliate" shall mean with respect to any person, any other person that directly or indirectly, controls, is controlled by, or is under direct or indirect common control with, such person, or is a director/ member/ office/ employee of such person or of any person who would otherwise qualify as an affiliate of such person pursuant to this definition.

"Person" for the purposes of this definition shall mean any natural person, individual, corporation, limited partnership, co-operative, general partnership, joint stock company, joint venture, association, company, trust bank, trust company, land trust, business trust, corporate body or other organization, whether or not a legal entity.

13. Offers of the Contractors/Suppliers, against whom, any unit of BHEL had initiated process for "Suspension of Business Dealings" or already done will summarily be rejected.
14. If at any stage, the document(s) submitted by contractor is/are found incorrect/ false/ manipulated, the necessary action will be taken by BHEL against contractor as per the "Guidelines for suspension of Business dealings".
15. **Suspension of Business dealings with Suppliers:**
Any supplier against whom action has been initiated under "suspension of business dealings with suppliers" are not qualified to participate in this tender. Before submitting offer, prospective bidders are advised to visit our web-site www.bhel.com / supplier registration to familiarize themselves with BHEL's policy and procedures of Suspension of Business Dealings with Suppliers. Submission of offer shall be deemed to be evidence of the Bidder to have read and understood the above said policy.
16. **Treatment of Debarment / Under-performing Vendors:**
Any supplier who has been put on "Debarment" from having business dealings with BHEL, Ranipet or any other unit of BHEL shall not submit their offer against this tender. If any such offers are received they would be summarily rejected and sent back. During the processing of tender, if any unit of BHEL puts a supplier on "Debarment" then further processing of the offer will not be taken up and in case an order is placed, BHEL, Ranipet may resort at their discretion to cancel the PO either fully or partially.
17. In quoting the rates, the tenderers are advised to take into account of all the factors including any fluctuations in the market rates etc. No claim shall be entertained on this account after acceptance of the tender or during the currency of the contract.
18. **QUOTING:** The tenderer should quote the total lumpsum price for the entire contract scope. Percentage allocation against each rate schedule is provided in NIT for quoting purpose. Individual schedule rates so derived based on the total lumpsum price shall be deemed to be the contract rate for all purpose. No claim for extra payment shall be admitted. GST will be paid extra as applicable on production of relevant documents along with the bills.
19. **The price quoted for this tender must be inclusive of all taxes and duties and exclusive of GST.**
20. **Reverse Auction:**
BHEL shall be resorting to Reverse Auction (RA) (Guidelines as available on www.bhel.com) for this tender. RA shall be conducted among the techno-commercially qualified bidders. Load Sharing

- If any other three bidders accept counteroffered L1 rate, load sharing will be 35% for L1 bidder and 30%, 20% & 15% other three bidders respectively in seriatim basis as per ranking.

23. Clause in case of Tie:

In case more than one bidder happens to occupy L-1 status even after soliciting discounts, L-1 bidder shall be decided by a toss / draw of lots, in the presence of the respective L-1 bidder(s) or their representative(s) - If available, otherwise the same procedures will be carried out to arrive for L1 ranking) Ranking will be done accordingly. BHEL’s decision in such situations shall be final and binding.’

In the event of tie in L2 /L3..... Ln offers, Ranking shall be decided by a toss / draw of lots. BHEL’s decision in such situations shall be final and binding.

24. The following points shall be taken note while quoting the rates:

- a. PPE to be given (under contractor’s scope) to all contract employees and must be ensured employees are working with PPE only.
- b. Contractor has to provide the Group Personal Accidental Insurance policy covering all employees to be engaged by the vendor under this contract for the following
 - a) In the event of death or permanent disability resulting from loss of both limbs Rs.10.00 Lakhs (Rupees Ten Lakhs).
 - b) In the event of other permanent disability Rs.7.00 Lakhs (Rupees Seven lakhs)
- c. PVC Clause: “During contract period, Adhoc amount for contract workmen will be subsumed with any increase in Dearness Allowance / Basic wages. After subsuming of BHEL Adhoc fully, any further increase in minimum wages by the state government have to be borne by the contractor”
- d. Contractor should not claim for any variation in quantity. At the end of completion, the contract may be extended on mutual agreement.
- e. The price quoted for this tender must be inclusive of all taxes and duties and exclusive of GST.

25. **The rates quoted in the tender shall remain valid for a period of three months from the date of technical bid opening for acceptance by BHEL.** No unsolicited revision in the tender offer shall be entertained after opening of tenders and till expiry of the validity period.
26. Any deviation to this tender terms & conditions and schedules of this tender will lead to total rejection of the offer submitted.
27. The bidders shall closely pursue all the clauses and specifications indicated in the tender documents before quoting. Should the bidder have any doubt the meanings of any portion of the tender specification or find discrepancies or omission in the drawings or the tender documents issued are in complete or shall require clarification on any of the technical aspect, scope of work etc., he shall at once contact the authority inviting the tender for clarification before the submission of the tender.
28. **Before tendering, the bidders are advised to inspect the site of work and the environments and be well acquainted with the actual working and other prevalent conditions, facilities available, position of material and labour. No claim will be entertained later, on the ground of lack of knowledge.**
29. **The bidder participating in the tender shall visit BHEL and discuss with concerned officials for clear understanding of the work requirement/Manpower before submitting their offers.**
30. The tenderers can visit BHEL on working days during office working hours for any clarifications before submitting their offer.

- r) The contractor shall submit the returns required under the Contract Labour (Regulation and Abolition) Act 1970 periodically to BHEL management.
- s) The contractor shall without fail give up to date information in writing of the attendance of the workers employed by him/her.
- t) The contractor shall ensure that his/her workers keep and produce their employment card when coming to duty and take them back when leaving duty.
- u) All the above registers and records shall be preserved in original for a period of three years. All the registers, records and notice maintained under the Act and Rules shall be produced on demand by Inspector or any Authority under the Act.
- v) No workers shall be required or allowed to work on Sunday unless he has or will have a Holiday or any one of the three days before or after the said day.
- w) The contractor shall inform BHEL Management in the prescribed form details or the contract workers scheduled to work on Sunday, the day of rest and also indicate the substituted holiday in lieu thereof. This shall be intimated two days in advance before his/her workmen are booked for work on Sunday.
- x) The contract labour working for more than nine hours in any day or for more than 48 hours in any week shall be paid wages at the rate of twice the ordinary rates of wages in accordance with the provisions of section 59 of the Factories Act 1948 and any amendment thereof.
- y) The contractor shall provide all safety devices and personal protective equipment to his workmen at his/her own cost and shall ensure that his workmen wear/use such devices or equipment provided to them while doing the work and there should not be any relaxation on this.
- z) The contractor shall give four paid national holidays to his workers, viz. 26th January, 1st May, 15th August and 2nd October. The contractor shall ensure that his/her workmen vacate the premises after the shift is over.
- aa) The contractor shall give leave with wages to his/her workmen who have worked for a period of 240 days or more in the factory premises during a calendar year. This leave shall be allowed during the subsequent calendar year at the rate of one day for every 20 days or work performed by the worker during the previous calendar year. The worker whose service commences on a day other than the first of January shall be entitled to leave with wages at the above rate (one day for every 20 days or work) only if he had worked for a minimum of 2/3 of the total number of days in the remainder of the calendar year. This leave will be admissible only during the subsequent calendar year.
- bb) The contractor shall comply with the provisions relating to welfare and health facilities as provided to the Contract Labour (Regulation and Abolition) Act 1970 read with the Tamilnadu contract labour Rules.
- cc) Notwithstanding anything contrary to this, in the event of accident the contractor shall be required to fill injury report and submit the Engineer In-charge immediately and ensure the compliance of ESI/Workmen's Compensation Act, Factories Act and Rules made there under. He shall also maintain a register of accident as per the Act.
- dd) The contractor shall get the contract labour engaged by him insured under Workmen's Compensation Policy from General Insurance Corporation of India before actually starting the work of contract. The insurance coverage should

The contractor is also liable to pay any administrative charges in this behalf that may be decided from time to time. It will be the responsibility of the contractor to ensure such contribution payable in respect of workmen employed through sub-contractors also.
- jj) The contractor shall take note of any amendment in the rate of contribution payable under the scheme from time to time.
- kk) The contractor shall within seven days of the close of every month submit to BHEL a statement showing the amount of contribution payable/paid for employees engaged by him or through him and shall also furnish to BHEL such information, as principal employer is required to furnish under the provisions of the ESI Act and PF as well as the scheme made there under to the authorities concerned.
- ll) Whenever any sum of money is found to be recoverable from or payable by the contractor under the above acts, the same shall be deducted from any sum that may be due or which at any time thereafter may become due to the contractor under this contract or under any other contract or from his security deposit. In case the recoveries are not sufficient to satisfy the claims the contractor shall pay the balance thereof on demand. In case any recoveries are made under this clause from the security deposit the contractor shall immediately thereafter pay such further sums as may be required to recoup the shortage caused by such recoveries in the amount of security deposit.
- mm) The contractor shall abide by all the labour and other laws applicable to contract labour/worker under this contract and shall at all times keep BHEL, indemnified against all losses, claims, prosecution under any law.

- nn) In case of noncompliance of any of the provisions of the acts and in case BHEL having complied with the same, BHEL will be entitled to recover the same from the contractor/sub-contractor.
 - oo) Non exercise of any of the powers or rights available to BHEL hereunder or under any law, shall not in any way operate as waiver thereof.
 - pp) Contractor should follow all the provisions of labour legislation and statutory obligations. Provisions as and when amended will also apply.

 - j) All temporary electrical connections shall be properly earthed, insulated and periodically checked.

43. BHEL will not bound by any power of Attorney granted by the tenderer or changes in the composition of the firm made subsequent to the execution of the contract. They may, however, recognize such power of attorney and changes after obtaining proper legal advice, the cost of which will be chargeable to the contract concerned.
44. Words imparting the singular number shall have deemed to include the plural number and vice versa where the context so require.
45. The expenses for completing and stamping the agreement shall be to the contractor's account.
46. The general and special conditions of contract are complementary to each other and where they are in conflict, the special conditions shall prevail. In regard to matters not covered by the General or Special conditions of contract, those contained in the specifications approved by BHEL, shall apply.
47. The "GENERAL CONDITIONS OF CONTRACT" and "SPECIAL CONDITIONS OF THE CONTRACT" shall be deemed to form an integral part of contract for the work to be entered into.
48. The filled ESI declaration forms shall be submitted to the Executive of HRM Dept. In the Declaration Form full address of the contractor shall be mentioned. Whenever a fresh and unregistered worker is engaged during the operation of contract, declaration form in respect of that workman which should be submitted to Human Resources Department within two days of such engagement.
49. ESI contributions (0.75% employee's contribution + 3.25% employer contribution of the total monthly wages) before 20th day of every following month. Prescribed challans are available at ESI local office, Ranipet (near Sipcot). Contractors who have got their own code number can remit the contributions on that number. Along with the challan copy, the details of remittance shall be submitted to the concerned HRM Executive in the ESI compliance form.
50. The contractor should deduct Provident Fund and ESI amount as per the provisions and amount so deducted along with the matching contribution of the contractor shall be remitted to the authorities concerned within the stipulated time. The statement of deduction along with the challans evidencing remittance shall be submitted to Officer-in-charge. If the evidences are not shown, further bills of the contractor will not be paid. BHEL have the right to withhold the payment of his bills. Submission of statutory returns such as Half Yearly returns of ESI (Form 6), P.F. return (Form 12A), Form 5 and Form 10, Form 3A & Form 6A should be send to the concerned officers in time.
51. The workers' particulars such as Name, Age, Father's name, address, Phone no, etc., and their daily attendance have to be maintained by the contractor. The details of Provident Fund and ESI compliance have to be maintained by the contractor in the prescribed format/register.

All registers are required to be maintained as above and shall be produced as and when Government Officials and Statutory Authorities to make inspection from time to time.

53. In case a contract labourers meets with an accident while on duty, the contractor shall immediately intimate the information to Safety Department, Contracting Agency and Human Resources Department and submit the Accident Report duly filled in all respect and send a copy to ESI local office, ESI Dispensary and Inspector of Factories (for major accidents) within 24 hours of accident through Safety and Human Resources Departments. All assistance for the injured workman such as to taking him to ESI Dispensary for treatment must be rendered by the contractor.
54. Compliance of the above provisions does not absolve the obligation of contractor arising out of other statutory obligations.
55. Contractor should employ only persons having sound health and not above the age of 60 years, and not below the age of 18 years.
56. The Contractor agrees that no claim for interest or damages will be entertained or be payable by BHEL in respect of any money or balances or amounts of whatsoever nature which may be lying with BHEL owing to any disputes or differences between the parties irrespective of whether the same is decided by any authority to be paid or returned to the Contractor."
57. Certificate by the executing department that all statutory requirements including PF, ESI, Minimum wages, Insurance, GST, etc. are complied with by the Contractor. This should be duly backed by the relevant documents".
58. If the contractor is not able to provide the sufficient manpower for a period of continuous period of 15 days, BHEL reserves the right to terminate the contract and to take appropriate action against the contractor. In the event of contract termination, security deposit paid by the contractor will be forfeited.
59. In case of breach of any or whole of the above terms and conditions by the contractor BHEL will have the liberty to cancel the registration and contract either in part or in full and entrust in part or in full of the work to any contractor and the contractor shall be liable to pay extra cost involved in the execution of cancelled part of the contract.
60. **LD/PENALTY:** To claim compensation for losses sustained including BHEL's supervision charges and overheads for completion on termination of contract and to impose penalty for delay in completion of the work against the delivery date mentioned in PO copy is imposed at the rate of ½% of the PO value per week of delay or part thereof subject to a ceiling of 10% of the respective PO value.
61. **PAYMENT TERMS:** Monthly post payment shall be paid based on the actual work done by the contractor as per BOQ after Certifying by engineer in charge and duly submit the necessary statutory documents (PF, ESI).
For MSE vendor payment will be made within 45 days and for non-MSE payment will be made within 90 days from the date of bill submission along with all supporting documents.

GENERAL CONDITIONS OF CONTRACT

1. DEFINITION: -

In these General Conditions of Contract, the following terms shall have the meaning hereby assigned to them, except where the context otherwise requires: -

- a) The “Contract” means, the documents forming the tender and acceptance thereof, together with all the documents referred to therein including general and special conditions to contract. All these documents as applicable taken together shall be deemed to form one contract and shall be complementary to one another.
- b) The “Work” means, the work described in the tender documents in individual work-orders as may be issued from time to time to the contractor by the officer-in charge with in the power conferred upon him including all notified or additional items of works and obligations to be carried out as required for the performance of contract.
- c) The “Contractor” means, the individual firm or company whether incorporated or not, undertaking the work and shall include the legal personal representatives of such individuals or the persons composing the firm or company or the successors of the form or company and the permitted assigns of such individual or firm or company.
- d) “The officer-in charge” means, the office deputed by the AGM/WCM to supervise the work or part of the work.
- e) “Approved” and “Directed” means, the approval or direction of AGM/WCM, or person deputed by him for the particular purposes.
- f) “BHARAT HEAVY ELECTRICAL LIMITED” (herein after referred to as BHEL) shall mean the Board of Directors, Chairman, Executive Director, General Manager or other administrative office of the sad company including AGM/WCM authorized to invite tenders and enter into contract for works on behalf of the company.
- g) The “Contract sum” means, the sum accepted or the sun calculated in accordance with the prices accepted in tender and / or the contract rates as payable to the contractor for the execution of work during the currency of the contract.
- h) A “week” means, seven days, without regard to the number of hours worked or not worked in ay day in that week.
- i) A “day” means, the day of 24 hours (Twenty-Four) irrespective of the number of hours worked or not worked in that day.
- j) A “working day” means, any day other than that prescribed by the NEGOTIABLE INSTRUMENTS ACT as being a holiday, and consists of the number of hours of labour as commonly recognized by good employers in the trade in

the district where the work is carried out or as laid down in the BHEL regulation.

2. **HEADING TO THE CONTRACT CONDITIONS:** -

The heading to these conditions shall not affect the interpretations thereof.

3. **WORK TO BE CARRIED OUT:** -

The contract shall, include all labour, materials, tools, plant, equipment and transport which may be required for the execution of work. 6. **PLANT AND EQUIPMENT:** -

The contractor shall at his own expense, supply all tools, plant and equipment (herein after referred to as T&P) required for the execution of the contract.

7. **ASSIGNMENT OF TRANSFER OF CONTRACT:** -

The contractor shall not without the prior written approval of the BHEL, assign or transfer the contract or any part thereof, or any share, or interest thereon to any other persons. No sum of money which may become payable under the contract shall be payable to any person, other than the contractor unless the prior written approval of the BHEL to the assignment or transfer of such money is given.

8. **SUB-CONTRACT:** -

The contractor shall not sub-let any portion of the contract without the prior written approval of the BHEL.

9. **COMPLIANCE TO REGULATIONS AND BYE-LAWS:** -

The contractor shall confirm to the provisions of any statute relating to the work and regulations and bye-laws of any local authority. The contractor shall be bound to give all notices required by statute regulations or by-laws as aforesaid and to pay all fees and taxes payable to any authority in respect thereof.

- a) Offer or give or agree to give to any person in BHEL service any gift or consideration of any kind, as an inducement or reward for doing or for bearing to do or for having done or for borne to do any act, in relation to the obtaining or execution of this or any other contract for BHEL service.

(OR)

- b) enter in to a contract with BHEL in connection with which commission has been paid or agreed to be paid by him or with his knowledge, unless the particulars of any such commission and the terms of payment thereof have previously been disclosed in writing to BHEL.

(OR)

- c) obtain a contract with BHEL as a result of ring tendering or by non-bonfire methods of competitive tendering, without first disclosing the fact in writing to BHEL.

23. RISK PURCHASE CLAUSE AS PER BHEL SOP DT. 10.10.2017: -

If the contractor fails to carry out the specified works as per the contract scope of work within the timeframe as directed by AGM/WCM or his authorized officials and continues in that state after a reasonable notice from AGM/WCM or his authorized officials, BHEL reserves the right to have the work done by any means at the Contractor's risk and expenses provided always that in the event of the cost of the work so done (as certified by authorized officials of User department which is final and conclusive) being less than the contract cost, the advantage shall accrue to the BHEL and if the cost exceeds the money due to Contractor under the contract, the Contractor shall either pay the excess amount ordered by AGM/WCM or the same shall be recovered from the Contractor by other means.

24. CANCELLATION OF CONTRACT FOR INSOLVENCY ASSIGNMENT OF TRANSFER OR SUBLETTING OF CONTRACT: -

BHEL, without prejudice to any other right or remedy, which shall have accrued or shall accrue thereafter to BHEL shall cancel the contract in any of the following cases:
If the contractor,

- a) being an individual or if a firm any partner thereof shall at any time be adjudged bankrupt or have a receiving order for administration of his estate, made against him or shall take any proceedings for liquidation or composition under any bankruptcy Act or assignment of his effects of composition or arrangement for the benefit of his creditors or purport to do so, or if any application made under any Bankruptcy Act for the time being in force for the

25. CANCELLATION OF CONTRACT IN PART OF FULL FOR CONTRACTOR'S DEFAULT: -

If the contractor,

- a) makes default in carrying out the work as directed and continues in that state after a reasonable notice from AGM/WCM or his authorised representative.
- b) fails to comply with any of the Terms and Conditions of the contract or after reasonable notice in writing with orders properly issued thereunder.
- c) BHEL, may without prejudice to any other right or remedy which shall have accrued or shall accrue thereafter to BHEL CANCEL the contract as whole or in part thereof or only such work order or items of work in default from the contract. Whenever BHEL exercise the authority to cancel the contract as whole or part under this condition BHEL may complete the work at the contractor's risk and cost (as certified by concerned executive of User dept. which is final and conclusive) being less than the contract cost, the advantage shall accrue to the BHEL. If the cost exceeds the moneys due to the Contractor under this contract the Contractor shall either pay the excess amount ordered

28. RECOVERY FROM CONTRACTOR: -

Whenever under the contract, any sum of money, shall be recoverable from or payable by the Contractors, the same may be deducted from or any sum then due or which at any time thereafter may become due to Contractor under the contract or under any other contract with BHEL or from his Security Deposit or he shall pay the claim on demand.

Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.

30. POST TECHNICAL AUDIT OF WORK AND BILLS: -

BHEL reserves the right to carry out the post-payment Audit and technical examination of the work and final bill including all supporting vouchers, abstracts etc., and enforce recovery of any sum becoming due as a result thereof in the manner

If the performance in whole or part of any obligation under this Contract is prevented or delayed by reason of any such event, claims for extension of time shall be granted for periods considered reasonable by the AGM/WCM subject to prompt notification by the contractor.

33. ARBITRATION: -

All disputes between the parties to the contract, arising out of or relating to the contract, other than those for which the decision of the AGM/WCM or Accepting Officer or any other person is by the contract expressed to be final and conclusive. All disputes between the parties to the Contract, arising out of or relation to the Contract shall after written notice by either party to the Contract to the other party be referred and resolved by an Arbitrator nominated by the Unit Head of BHEL, Ranipet.
