- 2. Contractor has to prepare cutting plan and cut the material before rolling and bending of sheet to avoid the wastage of fresh material. All enclosure/conductor sheet and plate to be first cut as per cutting plan before rolling. Cutting of rolled sheet/plate are not allowed for making window opening/ tap-off cut outs and saddle plate fixing pad. If bidders are found responsible for any wastage of fresh material at any stage of fabrication, the cost fresh material along with company overhead shall be recovered from his due payment.


