SUB: TENDER FOR "RECEIPT OF EQUIPMENT/ MATERIAL AT SITE, UNLOADING, RECONCILIATION, INSPECTION, VERIFICATION, STORAGE, UP-KEEPING DURING STORAGE, ERECTION, TESTING, COMMISSIONING AND HANDING OVER OF 400 KV GIS SWITCHYARD AT 2 X660 MW UDANGUDI SUPERCRITICAL THERMAL POWER PROJECT IN TAMILNADU.

Only those bidders who are technically and financially capable to execute the subject Job and who fulfil the Pre-Qualifying Requirements [PQR] given under are eligible to quote against the above NIT. Tenderers should submit their offer along with credentials in a sealed envelope as per the procedure specified in tender documents.

The PQR for subject tender shall be as under:

Sl. No.	Criteria	Description
a.	Turn Over	Vendors should have a minimum average annual turnover of Rs. 82,25,946/- for last three fin. Years (2016-17, 2017-18 & 2018-19 OR 2017-18, 2018-19 & 2019-20) and should submit audited balance sheet and Profit & Loss Account Sheet of these years. In case audited balance sheet is not available due to turnover being less than statutory requirement of audit, bidder should furnish self-certified copies of Balance Sheet, Profit & Loss account along with income tax returns
b.	Profit	Vendor should have earned profit in at least one year during last three financial years as mentioned in 'a' above.
c.	Similar Job	Vendor should have successfully executed similar* job (ref note below) during last seven years ending 31.12.2020 and should be either of the following: i. Three similar jobs executed costing (except service tax/GST) not less than Rs. 109,67,928/- each. OR ii. Two similar jobs executed costing (except service tax/GST) not less than Rs. 137,09,910/- each. OR iii. One similar job executed costing (except service tax/ GST) not less than Rs. 219,35,855/-.

Notes:

1. **Similar* job shall mean:**

Bidder should have successfully executed:-

(i) ETC works of 400 kV or above Air Insulated Substation (AIS)/ ETC works of 220 kV or above Gas Insulated Substation (GIS) .

(Refer note 1 below for other conditions)

Note:-1:- ETC means erection testing and commissioning / pre-commissioning.

2. The bidder shall submit the following documents in compliance of above mentioned requirement along with technical bid in support of qualification
 - i) Contract Agreement/ Work Order/LOI alongwith BOQ
 - ii) performance/ completion/ execution certificate issued by Customer/ Contractor
3. The word 'executed' means the bidder should have achieved the criteria specified in the PQR even if the total contract has not been completed or closed. Executed value of erection portion of work order shall be considered for evaluation against PQR.
4. If the job is executed in the last seven years period, as specified above (job mentioned at Sl. No. c), even if it has been started earlier, the same will also be considered meeting the qualifying requirements..
5. **Consortium/ JV bidding is allowed under this NIT.**
6. **The conditions for meeting the Prequalifying requirement for standalone bidder or Consortium bidders are as below:-**

6.1 For Standalone bidding :-

The bidder who fulfils all the PQR stipulated above standalone on their own without any consortium partner

- Similar job shall mean:

The Bidder should have successfully executed

- i)ETC works of 400 kV or above Air Insulated Substation (AIS)/ ETC works of 220 kV or above Gas Insulated Substation (GIS) ..**

Note: - * ETC means successful erection, testing and commissioning /Pre-commissioning

6.2 For Consortium Bidding:- The bidder who enters into a consortium agreement with another bidder in order to fulfill the PQR.

- 6.2.1 If a bidder is not qualified on standalone basis, then the Prime bidder can have a consortium with another bidder to meet the PQR.
- 6.2.2 Consortium bidder should specify the Prime bidder of consortium in their bid, else the bidder who has the major share of work shall be considered as prime bidder.
- 6.2.3 Prime Bidder and Consortium Partner are required to enter into a consortium agreement with a validity period of six months initially. In case the consortium is awarded the contract, then the Consortium Agreement between the Prime Bidder and Consortium Partner shall be extended till contractual completion period including extension periods if any applicable.
- 6.2.4 Both partners of consortium bidder should submit audited balance sheet and Profit & Loss Account Sheet of last three fin. Years (2016-17, 2017-18 & 2018-19 **OR** 2017-18, 2018-19 & 2019-20). The combined Turn Over of both consortium partners shall be considered for minimum average annual turnover mentioned at Sl. No. "a. For the purpose of meeting the criteria mentioned at Sl. No. "b" is considered for Prime bidder only.
- 6.2.5 Number of partners including prime bidder shall not be more than 2 (Two).
- 6.2.6 Prime Bidder shall be responsible for the overall execution of the contract.
- 6.2.7 In case the Consortium partner back out, other consortium partner meeting the PQR have to be engaged by the Prime Bidder immediately, and if not, the respective work will be withdrawn and executed on risk and cost basis of the Prime Bidder.

- 6.2.8 In case the prime bidder withdraws, the whole contract shall be considered cancelled and balance work will be executed at risk & cost of Prime bidder. Further, necessary actions shall be taken as per BHEL Extant guidelines against the prime bidder.
- 6.2.9 In case customer approval is required, then customer approval of Prime bidder shall be taken from Customer and regarding the consortium bidder information shall be given to customer.

6.3 Similar Job Meaning in case of Consortium bidding:-

- i) **In case of Consortium bidding**, for the similar work experience following modality is applicable to meet the PQ requirement as mentioned in “c” above :-:-

- 6.4 Standalone bidder cannot become a ‘Prime Bidder’ or a ‘Consortium bidder’ in consortium bidding. Prime bidder shall neither be a consortium partner to other prime bidder nor take any other consortium partners. However, consortium partner may enter into consortium agreement with other prime bidders. In case of non-compliance, consortium bids of such Prime bidders will be rejected.

- 6.5 BHEL’s decisions for the all clauses pertains to point no. 06 is final & binding to the contractor.

7. In order to technically qualify in this tender, Standalone bidder/consortium should meet all criteria i.e. a, b & c mentioned above.

8. BHEL reserves the right to:

- (a) Accept or reject any bid received at its discretion without assigning any reasons whatsoever.
- (b) Postpone the above mentioned date, split and distribute the work among more than one bidder without assigning any reason whatsoever.
- (c) May ask for further qualification during techno commercial scrutiny of bids received.
- (d) May ask for further proofs including TDS certificates/ Final bill/Form 26AS/ payment detail for the said job for cross- verification.

9. BHEL shall not be responsible for any delay, loss, damage for bids sent by post.

10. BHEL shall not be liable for any expenses incurred by bidder in preparation of bid irrespective of whether it is accepted or not.

11. Quotations received from bidders who do not fulfil the PQR shall be summarily rejected without any further evaluation and information to bidders.

12. Canvassing i.e. soliciting favour, seeking advantage etc. in any form is strictly prohibited and any bidder found to have engaged in canvassing shall be liable to have his bid rejected summarily.

13. If the bidder deliberately gives any wrong information in his tender to create in circumstances for the acceptance to his bid, BHEL reserves the right to reject such application.

14. Bidder's selection is subject to approval of BHEL's customer for this work.
