SUB: EXECUTION AND HANDING OVER OF METAL SPREADING WORKS OF 400/220 KV SUBSTATION AT KORADI & 400/220KV SUBSTATION AT EXTENSION AT KHAPERKHEDA IN MAHARASHTRA.

Sealed Tenders (Under two part bid system) are invited from competent civil contractors for execution and Handing over of Metal Spreading Works of 400/220 kV Substation at Koradi & 400/220kV substation extension at Khaperkheda in Maharashtra. Only those who are technically and financially capable to execute the Job and who fulfil the Pre-Qualifying Requirements [PQR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The PQR of contractor for tender submission shall be as under:

A. Vendors should have a minimum average annual turnover of ₹ 50 lacs for last three years (2009-10, 2010-11 & 2011-12) and should submit audited balance sheet and Profit & Loss Account Sheet of these years. In case of audited balance sheet for 2011-12 is not available, audited balance sheet and Profit & Loss Account for 2008-09 can be considered and is to be submitted.

B. Vendor should have successfully executed similar job (**ref note 1 & 2 below**) during last seven years ending on 31.08.12. Vendor should produce certification/proof in support of execution of similar package from user/end user and should be either of the following:

i. Three similar jobs executed costing (except service tax) not less than ₹ 65 lacs each

OR

ii. Two similar jobs executed costing (except service tax) not less than ₹ 85 lacs each.

OR

iii. One similar job executed costing (except service tax) not less than ₹ 135 lacs.

C. Vendor should have earned profit in at least one year during last three financial years (2009-10, 2010-11 & 2011-12)

NOTE:

1. Similar job shall mean: Bidder should have successfully executed any type of civil works predominantly involving supply and spreading of stone metal or civil works of 132 kV and above substation/switchyard.

2. The word 'executed' means the bidder should have achieved the criteria specified in the PQR even if the total contract has not been completed or closed.

Important Notes

- 1) BHEL reserves the right to:
 - (a) Accept or reject any bid received at its discretion without assigning any reasons whatsoever.
 - (b) Postpone the above mentioned date, split and distribute the work among more than one bidder without assigning any reason whatsoever.
 - (c) May ask for further qualification during techno commercial scrutiny of the bids received.
- 2) BHEL shall not be responsible for any delay, loss, damage for bids sent by post.
- 3) BHEL shall not be liable for any expenses incurred by bidder in preparation of bid irrespective of whether it is accepted or not.
- 4) Quotations received from bidders who do not fulfil the PQR shall be summarily rejected without any further evaluation and information to bidders.
- 5) Canvassing i.e. soliciting favour, seeking advantage etc. in any form is strictly prohibited and any bidder found to have engaged in canvassing shall be liable to have his bid rejected summarily.
- 6) If the bidder deliberately gives any wrong information in his tender to create in circumstances for the acceptance to his bid, BHEL reserves the right to reject such application.
- 7) Bidder's selection is subject to approval of BHEL/BHEL's customer/ Customer's consultant for this work.
