- a. In case rates quoted by more than one vendor are same then vendors having higher SPR will be considered above in the raking compared to vendor having lower SPR. SPR as on date of tender opening (1st part) will be taken for consideration.
- b. In case vendors are having same SPR then the vendors whose machining capacity, is more will be considered above in the raking compared to vendor having lower machining capacity."

#### **Revised Clause:**

"18.20

- a. In case any bidder(s) do(es) not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking."
