We require approximately **360** Ltrs of Curd per day with a minimum of 4.5% Fat and 9.0% solids - Not-Fat at competitive firm rate (*PVC applicable, refer. point no:5 under Special Terms & conditions) for BHEL canteens. **Required quantity may vary based on our actual requirement and Quantity mentioned in the purchase order shall be final.** We have enclosed necessary tender documents towards the same. We request you to quote your most competitive firm rate valid for one year for the supply of Curd to BHEL Canteens. The supply should be as per the indented quantity and normally the supply should be made daily (Morning at 6.30 AM) unless otherwise mentioned in the indent.

Tender will be in two part bid basis. Please note that Tender documents and necessary supporting documents to be signed and sealed by authorised person and to be submitted as Technical bid. Technical bid & Price bid should be kept separately in a wax sealed cover and both the covers should be kept in a common cover sealed with wax super scribing the enquiry ref no, date and description and addressed to The Tender Opening Cell / MM, Room No: 26, Ground Floor, Bharat Heavy Electricals Limited, Trichy – 620 014 on or before 14:00 Hrs on 25/06/2022 thro Registered Post / Courier / Speed Post also in person. Technical bid will be opened on 25/06/2022 at 14:30 Hrs in the presence of available tenderers. The technical bids which are found acceptable alone after evaluation will be considered for Price bid opening and Price bid opening schedule will be intimated later through email given in the technical bid. BHEL may place order on the lowest quoted vendor and the rate is firm (PVC applicable) and valid for a period of one year.

Before quoting we request the tenderers to go through the enclosed terms & conditions and abide all the conditions without fail. Tenderers who do not comply with any of the stipulated conditions will not be considered and their offer will be summarily rejected.

Kindly note that Price bid should be followed by the below mentioned quote and duly signed under. "We are accepting all the terms and conditions of this BHEL tender without any deviation" In the absence of the above statement, BHEL will presume that all terms and conditions of this tender are accepted by the vendor.

INSTRUCTIONS TO THE TENDERER

- (1) Any deviation to this tender terms & conditions and schedules of this tender will lead to total rejection of the offer submitted.
- (2) Tenderer who have been suspended or black listed or issued with "Show Cause Notice" by BHEL, Tiruchirappalli 620014 or any other unit of BHEL or Government of India will not be allowed to participate in the tender and bidder should declare the same in the tender. Even during the course of evaluation/ finalization of tender if it is found that some of the parties are black listed/ barred from business transaction/ under business hold, BHEL will not consider them for further participation in the tender.
- (3) Should a tenderer find discrepancies or omissions in the tender documents, or should there be any doubt as to their meaning, he should at once address the authority inviting the tender, for clarification well before the due date, so as to submit his tender in time. No extension of time shall be given for submission of the tender on any account.
- (4) Rates should be quoted as per Price Bid Format only and the Rate quoted is inclusive of GST, other Taxes if any, Transportation, Loading, Unloading, etc. No additional claim will be allowed. Rates quoted in any other form will not be accepted and will be rejected.
- (5) The tender documents must be signed physically by authorized person on behalf of the Firm concerned.
- (6) If a tenderer deliberately gives wrong information in his tender or creates conditions favorable for the acceptance of his tender, the BHEL will reject such tender at any stage.
- (7) Words imparting singular number shall be deemed to include plural number and vice-versa where the context so requires.
- (8) Canvassing in any form in connection with tenders is strictly prohibited and the tenders submitted by the Contractors who resort to canvassing will be liable for rejection.
- (9) The tender schedule and the tender shall be deemed to form an integral part of the contract to be entered into for this work.
- (10) Tenderer shall sign and affix the seal in each page of the tender documents for having accepted the conditions and submit the same along with Technical Bid. In case of corrigendum issued to the tender, corrigendum shall also to be signed and seal affixed by tenderer and to be submitted along with Technical bid. All the supporting documents must be self-attested by tenderer.
- (11) Tender can be cancelled at any stage due to unavoidable circumstances.
- (12) Bidder are advised not to wait till the last minute or last few seconds w.r.t tender closing time to submit their offer to avoid complications related with Road Traffic or any other condition.
- (13) Corrigendum related to this tender if any will be posted in BHEL Website and Central Public Procurement Portal only. Tenderers are advised to regularly visit both the BHEL Website and Central Public Procurement Portal for corrigendum.
- (14) Price bid shall be valid up to Three month from the date of Tender opening.
- (15) BHEL does not guarantee any minimum quantity.



- 23. All the entries in the tender documents should be in one ink. Erasing and overwriting are not permitted. Cancellations and insertions, if any shall be authenticated by the tenderer by signing affixing his seal. After submitting the tender, the tenderer is not entitled to recall his/its offer of modify the terms and conditions thereof.
- 24. These general terms and conditions shall be applicable for the bids, however BHEL reserve rights to add, cancel or modify the same at any time without assigning reasons.
- 25. BHEL reserves the right to
 - Increase or decrease the tendered quantity.
 - Cancel the tender enquiry at any stage or cancel the contract at any time during the execution of contract without assigning any reason.
 - Negotiate or re-float the tender opened if L1 price is not the lowest acceptable price to them inter-alia other reasons. The decision of BHEL in awarding the contract is final and BHEL reserves the right to reject any or all tenders without assigning any reasons.
 - ➤ In case more than one bidder happens to occupy L-1 status, effective L1 will be decided by soliciting discounts from the respective L1 bidders. In case more than one bidder happens to occupy the L-1 status even after soliciting discounts, the L-1 bidder shall be decided by a toss / draw of lots, in the presence of L-1 bidders or their representatives(In the event of non-availability of L1 bidder or bidders, BHEL will decide by toss / draw of lots). Ranking will be done accordingly. BHEL's decision in such situations shall be final and binding.
- 26. Disputes or differences arising from this tender or in any manner connected therewith shall be subject to the following disputes resolution mechanism:
 - Any dispute shall initially be discussed amongst parties and settled amicably.
 - If no amicable settlement or if there is no scope for amicable settlement, then any party may refer the dispute to sole arbitrator to be nominated by the Head of HR, BHEL, Trichy. The place of arbitration shall be at Trichy. All arbitration proceedings shall be conducted in English in accordance with the provisions of the Arbitration and Conciliation Act, 1996.
 - The arbitration award shall be final and binding upon the parties and each party will bear its own costs of arbitration and equally share the fees of the arbitral tribunal.
- 27. All disputes shall be subject to the exclusive jurisdiction of courts at Trichy.

28. Fraud prevention policy:

The bidder along with its associate / collaborators / sub-contractors / sub-vendors / consultants / service providers shall strictly adhere to BHEL fraud prevention policy displayed on BHEL website http://www.bhel.com and shall immediately bring to the notice of BHEL management about any fraud or suspected fraud as soon as it comes to their notice.

Fraud Prevention Policy and List of Nodal officers shall be hosted on BHEL Website, Vendor Portals of Units/Regions intranet.

29. SPECIAL PROVISIONS FOR MICRO AND SMALL ENTERPRISES (MSE) BIDDERS REGISTERED AS PER MSME ACT:

- 25% of the tendered quantity is earmarked for MSE suppliers (Manufacturers Only) as per the latest MSE guidelines.
- II. If L1 is MSE vendor, this provision is not applicable. Total tendered quantity shall be awarded to L1 vendor.

III. If L1 is Non-MSE vendor, in case MSE vendor participating in the tender quotes within the price band of L1 + 15%, they will be allowed to supply the portion of the requirement subject to acceptance of L1 price by MSE vendor. In case of more than one such MSE, the supply shall be shared equally.

IV. In case of none of the MSE vendor participates or none of the eligible MSE vendor accept

the L1 price, total quantity will be ordered on L1 Non-MSE vendor.

- V. For availing MSE benefit, MSE vendor under manufacturer for tendered items should submit copy of Udyam Registration number along with Technical bid. Without the production of Udyam Registration number, your offer will be considered as non-MSE category and not eligible for availing MSE benefits.
- VI. Non submission of Udyam Registration number will lead to consideration of their bids at par with other bidders and No benefits shall be applicable for the enquiry if any deficiency in the above required documents is not submitted before the price bid opening. This provision for MSE will apply subject to the condition that the participating MSE meets the tender requirements.
- VII. In case of any change in the MSE status of the bidder, it shall be the responsibility of the bidder to notify the change as a part of the bid document. If at a later date it comes to the knowledge of BHEL, that the change in the status has not been intimated by the bidder and the order is obtained under the premise of an MSE then BHEL would cancel the pending order against this tender and take necessary steps for suspension of the business dealing with the bidder as per the procurement policy of BHEL

30. Vendor Eligibility Criteria

- 1. Must have an average turnover of 120 lakh per Annum for any two consecutive years out of the last four financial years ending on 31st March 2022 (2018-19, 2019-20, 2020-21 & 2021-22).
- 2. Vendor must possess PANCARD, GST, FSSAI certificate (Must be valid as on the date of opening of Technical Bid).
- 3. Vendor must have made supply of Curd for a minimum of 200 Ltrs in a single day to any organisation / institution / Factory / Company / etc on or after 01/04/2018. Vendor must submit the proof for having supplied Curd for a minimum period of 5 days in any one of the financial quarters on or after 01/04/2018. (Proof to be attached like PO or WO along with proof for supply completion / Supply completion certificate from buyer / Vendor invoice along with proof for receipt of payment from the purchaser as the case may be).
- 4. Vendor office / Manufacturing unit / Cold Storage Unit / Office of authorised Distributor must be within the radius of 200 Km from BHEL Trichy since Curd is very essential item and to be supplied daily. Proof to be provided. (Distance will be calculated by using Google Maps)
- 5. Vendor must submit the copy of test report obtained CFTRI, Mysore or any one of the NABL accredited food testing laboratory about the quality standards of the CURD with FAT 4.5% (min) & SNF 9.0% (min). Date of collection of sample and Date of issuance of test report must be on or after 01/04/2022. Also Proof for NABL accreditation of Lab to be provided for the labs tested other than CFTRI, Mysore along with their Technical Bid.

31. Liquidate Damages

Supplier shall supply the curd as per PO / BHEL requirement. If the vendor fails to complete the delivery / replace the materials as per PO / BHEL requirement, Liquidated Damages of a sum equivalent to 10% of the failed supply value of curd will be deducted from the supplier's bill and Risk Purchase Clause will be activated for the smooth canteen services. LD shall be subject to a maximum of 10% of the total supply value curd during the entire contract period.

SPECIAL TERMS AND CONDITIONS

- 1. Based on commitment, requirement and suppliers' capability in terms of delivery and quality in order to ensure uninterrupted supply, BHEL reserves the right to increase or decrease the tendered quantity.
- 2. In case the Lowest priced item does not meet the specifications of the tender, BHEL reserves the right not to consider the same.
- 3. BHEL reserves the right to negotiate the rate or re-float the tender opened if L1 price is not the lowest acceptable price to them inter-alia other reasons.
- 4. Ordering will be on made as per General Terms and conditions mentioned in Clause 29.
- 5. Price variation clause is applicable and price will be decided based on Aavin announcement. The price will be proportionally enhanced / reduced as per the Aavin's increase/decrease of milk rate. Present Aavin rate of milk is Rs.44.00 and it will be taken as base rate (Maximum retail price of Half litre of Standardised milk is Rs.22.00 which is converted to Rs.44.00 per Litre). Any increase/decrease will be proportionally applicable as below:-.

Where,

A is Future milk rate announced by Aavin

B is present milk rate of Aavin (Rs.44.00)

C is Finalised rate for supply of Curd

6. Incase Aavin changes the rate after issue of this tender and on or before submission schedule of of Techincal bid, Aavin's Maximum retail price of Standardised milk on the date of tender opening will be taken as base /Present rate. Price variation clause is applicable, if Aavin changes the rate after the date of opening of Technical Bid.

Note – The word Aavin, wherever mentioned in the tender document stands for Tamilnadu Co-op Milk Producer's Federation Ltd

- 9. The successful tenderer shall daily report at 6.30 AM in the morning and complete the delivery of Curd at the respective canteens on the scheduled date as per quantity ordered. Along with the daily supply, delivery Challan should be produced. Supply timing may get change as per BHEL requirement.
- 10. The successful tenderer shall also arrange his own INSULATED VEHICLE and load men, to unload the entire quantity of Curd at the respective canteens receipt area, measure each can, keep the cans inside the Cold Storage room and get the Delivery Challan duly signed by the Canteen Officials. The process of Curd delivery to BHEL Canteens is said to be completed if the above activities are completed.
- 11. It shall be the responsibility of the successful tenderer to measure the Curd quantity properly and count the cans also prior to loading them at their loading point for supply to BHEL Canteens/ Stores. Delivery Challan in duplicate should accompany the supply and the same is to be affixed with the Security "permitted in" seal at the Security Entrance Gate. Any excess materials brought inside the canteen will not be returned at any cost.
- 12. The supply should be made in standard Food grade materials (Stainless Steel Cans / Aluminium Cans / Food grade Plastic Cans of 40 Litres Capacity only). The can should be properly closed with SS / Aluminium / Plastic Lids and with Lead / Plastic seal on it. At any point of time no Supplier should take other supplier's Cans.
- 13. The ordered quantity will have to be delivered daily at various places of BHEL Canteens namely 18 (SSTP),19,24,11 (Unit II) and 58 Canteens.
- 14. The 40 Litre Cans used by the supplier should be painted in a distinctive colour with the incorporation of tenderer's name to identify the owner amidst more than one supplier.
- 15. The daily requirement of Curd supply will be consolidated and purchase order issued once in a month. Daily requirement may vary based on consumption. However, any change in requirement of quantity, the requirement will be informed over telephone or email.
- 16. If the supply is found to be defective before consumption, the full quantity is to be replaced by the successful tenderer within two hours. The rejected quantity of Curd will not be returned and will be disposed by BHEL.
- 17. In the event of failure in supply of curd or the replacement in time, risk purchase clause will be operated and difference including transport & handling charges if any in the price procured by BHEL in the open market to meet the immediate requirement of such occasions, shall be recovered from the pending bills of the successful tenderer.
- 18. The supplier may quote his / her most competitive and firm rate (PVC applicable, ref. point no:5 under special terms & conditions) for a period of one year for the Curd to be supplied. The rate should include loading, unloading, packing, handling, transport, profit margin, GST, all taxes etc. and inclusive of delivery of Curd at various BHEL Canteens.
- 19. The payment for the supply of Curd shall normally be made within 45 days from the date of receipt of the Consolidated statement of bills within 1st week of every month for the supply made for one month by the supplier to BHEL canteens/ stores and the payment will be made thro' EFT (Electronic Fund Transfer) mode only.
- 20. The decision of BHEL in awarding the contract is final and BHEL reserves the right to reject any or all tenders without assigning any reasons.
- 21. Clarification, if any, before quoting may please be had from Sr.Manager (HR- Welfare & Canteens) or The Secretary, Canteen Managing Committee, Canteens, HRM Department, BHEL, Trichy 620014. Contact Nos. 0431-2577372 / 7067.
- 22. Price quoted will be firm & valid for a period of one year from 01/08/2022 to 31/07/2023 or One year from the date of award of contract. The contract may be extended after one year also, if needed with mutual consent.



GENERAL CONDITIONS

- 1. Tender should be submitted in Two Parts viz, a) technical bid (enclosing duly signed Tender documents & necessary supporting documents along with copy of Test report) and b) price bid (firm rate for one year) in separate covers sealed with wax and both the covers should be kept in a common cover sealed with wax super scribed with the Enquiry No, Date and description on the top of the cover and addressed to The Tender Opening Cell/MM, Room No:26, Building 24, Ground Floor, BHARAT Heavy Electricals Ltd., Trichy 620 014 well in advance before the tender submission date as indicated in the Tender Enquiry. These documents should be sent either by Registered post / Speed Post / courier / in person.
- 2. Tenderer should affix their official seal and signature in all the tender documents and necessary supporting documents. The subject matter in the price bid must be duly typed in your letter head, legibly signed and also affixed with official seal.
- 3. Bid should be free from correction, overwriting, using corrective fluid, etc. Any interlineation, cutting, erasure or overwriting shall be valid only if they are attested under full signature(s) of person(s) signing the bid else bid shall be liable for rejection. All overwriting/cutting, etc will be numbered by bid opening officials and announced during bid opening. In case of any difference in the amount written in figures and the amount written in words, then the amount written in words will be treated as the amount quoted.
- 4. Bids received after the scheduled date and time will not be considered. The tender will be opened on the scheduled dates and time as stated in our covering letter. In case the tenderer would like to depute a representative, suitable authorization letter should be sent along with representative at the time of tender opening.
- 5. Besides, the tenderer has to obtain a fresh test report in the name of the tenderer from CFTRI, Mysore or NABL accredited food testing laboratory about the quality standards of the Curd (Fat & SNF) and duly attach the copy of test report along with the Technical Bid. The tenderer who fails to submit the laboratory test report along with Technical Bid, Price bid will not be considered for further process. In case, FAT & SNF are not as per standards specified in the tender, their Price Bid will also be disqualified. Date of collection of sample and Date of issuance of test report must be on or after 01/04/2022. Also Proof for NABL accreditation of Lab to be provided for the labs tested other than CFTRI, Mysore along with their Technical Bid.
- 6. After opening the technical bid, technical documents will be verified and Technical bids found acceptable alone will be considered for the Price bid opening and price bids of technically qualified vendors will be opened after getting approval from Competent Authority and the decision of results made by BHEL, Trichy is final & binding on the tenderer. No claim shall be entertained.
- 7. As and when needed, BHEL will select sample at random from the supplied quantity of Curd by the successful Tenderer to BHEL Canteens for testing the conformity of the supply with the standards specified in the "Prevention of Food Adulteration Rules 1955 by CFTRI, Mysore or NABL accredited food testing laboratory and also as per the specifications mentioned in the tender. If the quality or specification is not as per the standards specified in the tender, payment will be proportionately deducted (4.5% Fat & 9.0% SNF = 100% payment at the rate of 50% weightage for each). Also in case of such repetitions of deficiency in quality during the contract period, the annual tender will be cancelled at the third occasion and suitable action will be initiated as per extant Policy guidelines of BHEL. The defective Curd will not be returned to the Tenderer.
- 8. During the contract period quality test have to be conducted mandatorily once in a 3 month (i.e, Aug-22, Nov-22, Feb-23 & May-23). Vendor is required to send their Curd for quality test to CFTRI, Mysore or any one of the NABL accredited food testing laboratory and copy of the test report to be submitted to BHEL.
