- Average minimum annual financial turnover of the bidder, during last 3 (three) years, ending on 31-03-2021 should be **Rs 3 Lakhs (Rupees Three Lakhs Only)**
- Audited balance sheet and profit & loss account for last 3 (three) years, ending on 31-03-2021 need to be submitted in support of above requirement.
- In case audited financial statements have not been submitted for all the three years as indicated above, then the applicable audited statements submitted by the bidders against the requisite three years, will be averaged for three years. However, audited financial statement for FY 2019-20 is necessarily required to be submitted for determining net worth.
- If financial statements are not required to be audited statutorily, then instead of audited financial statements, financial statements are required to be certified by chartered accountant.
- No consortium arrangement will be allowed for the job.
