 - **2.1** Average Annual Financial Turnover during the last 3 years, ending 31st March of 2021, should be at least Rs 35.60 lakhs. If all balance sheets/ Financial Statements are not available for all three years, then the average shall be calculated by dividing the sum of turnover of submitted balance Sheet/ Certificate from CA/ Financial statement by three.
 - **2.2 Experience** of having successfully completed similar works during last 7 years ending 31st July'2021 should be either of the following: -

Three similar completed works each costing not less than Rs 47.46 lakhs

Or

Two similar completed works each costing not less than Rs 59.33 lakhs
