7.8	In case of raising any Supplementary Tax Invoice (Debit / Credit Note), successful bidder shall issue the same containing all the details as referred to in Section 34 read with Section 31 of GST Act & Rules referred there under

7.11	Successful bidder shall upload the invoices raised on BHEL in GSTR-1 within the prescribed time as given in the GST Act. Bidder shall note that in case of delay in declaring such invoice in your return and GST credit availed by BHEL is denied or reversed subsequently as per GST Law, GST amount paid by BHEL towards such ITC reversal as per GST law shall be recoverable from the successful bidder along with interest levied / leviable on BHEL.

9.0	<u>TERMINATION OF CONTRACT:</u> BHEL may terminate this contract at any time by informing the vendor by giving notice without assigning any reasons whatsoever. In such case no payment will be given for the contract including period of unsatisfactory services, if any.
10.0	<u>LIQUIDATED DAMAGE (LD):</u> It is to be clearly understood that the scope of work as specified in the work/purchase order should be made within the time limit as prescribed by BHEL. If the contractor fails to maintain the required progress of work /supply which results in delay in the completion of the work as per the contractual completion period, BHEL shall have the right to impose Liquidated Damage/Penalty at the rate of 0.5% of the contract value, per week of delay or part thereof subject to a maximum of 10% of the contract value. The liability for delay shall not in any case exceed 10% (ten percent) of the respective item value. For this purpose, the period of delay shall be the delay attributable to vendor for completion of job as per contract/PO.


