





- 2.0 The work shall be carried out as per specifications, descriptions of the items in the schedule and as per engineer's instructions.
- 3.0 Unless specifically mentioned otherwise in the tender document, the tenderer shall quote for the finished items and shall provide for the complete cost towards supply of materials including consumables, labour & other misc. elements that may be required for carrying out the job including transport, layout, rectification, maintenance till handing over, supervision, overheads, profits etc. including all incidental items complete.
- 4.0 The quantities in this schedule are approximate and may vary to any extent or may be deleted altogether. The rate quoted against each item of the schedule shall remain firm till the contract value remains within "+" or "-" 15%.
- 5.0 The rates shall be quoted both in figures & words in clear legible writing. No overwriting is allowed. All scoring and cancellations should be countersigned and in case of illegibility, the interpretation of engineer shall be final. All entries shall be in English. The rates quoted are inclusive of all taxes and duties, etc.
- 6.0 The tenderer shall be deemed to have studied detailed specifications and terms & conditions of the tender.






SL.	TECHNICAL CONDITION OF CONTRACT
1.1	SCOPE OF WORK: REPAIRING OF EXISTING ROAD WITH BRICK BATS & MILL REJECTS AT CHP AREA AT 1X660MW, SAGARDIGHI, UNIT-5 SAGARDIGHI EXTENSION PROJECT, WEST BENGAL.
1.2	The Following shall be under the scope of successful Bidder: a) Bidder has to obtain all statutory compliances as required for working at project site. b) Bidder has to maintain at site, suitable number of supervisors, as may be required, for taking care of statutory compliances including payment to workers on regular / monthly basis, etc. c) Bidder has to bear the cost on account of food, cooking & eating utensils etc. for the deployed manpower within the quoted rates d) Bidder has to arrange brick bats and mill rejects. e) All T&Ps like tractor, JCB, Road Roller, all safety PPEs shall be provided by the agency within the quoted rates. f) Providing all PPE Kits such as safety helmet, safety shoes, safety jacket, gloves, lifelines, fall arrestor ropes, guy ropes etc.
1.3	The following shall be provided by BHEL free of cost: a. Not Applicable
2.0	MOBILIZATION SCHEDULE
3.1	Contractor has to mobilize the workers & T&P at site within 2 days from the date of issuance of work order. The mobilization and demobilization of labour shall be at the cost of successful bidder. No separate rate or any other additional amount shall be payable by BHEL on this account.
3.2	Scope of work: Cutting bushes, leveling, grading and repairing existing road with brick bats and mill rejects. Proper compaction shall be carried out with static road roller. Shoulder shall be also filled up with local available soil and well compacted to protect the road. Guarantee /Maintenance period of this contract is Three months .
4.0	Contract Duration: It shall be for a period of Three months . However, if required BHEL at its discretion may extend the contract further as per requirement.
5.0	TERMS OF PAYMENT: A) 95% of the payable amount as applicable, would be released within 30 days on verification and acceptance of the GST invoice subject to its completeness in all respects including statutory compliances, certification by BHEL EIC along with submission of following documents: B) Balance payment of 5% shall be released after successful completion of Three Month Guarantee period of the contract. C) Payment will be released within 30 days of submission of documents as mentioned above. D) Paying Authority: RAO, BHEL Site Office, 1 x 660 MW Unit-V, Sagardighi TPP extension E) No advance shall be paid. Payment shall be made on the basis of actual execution at site.
5.1	PRICE VARIATION CLAUSE / RATE REVISION
	The accepted rates shall remain firm throughout the execution period including extension period, if any, and no escalation / revision shall be payable.
6.0	TAXES & DUTIES, ETC.
6.1	All taxes excluding GST (as specified elsewhere in the tender) but including, Charges, Royalties, any State or Central Levy and other taxes for materials if any obtained for the work and for execution of the contract shall be

Any increase of above at any stage during execution of contract, including extension of the contract, shall have to be borne by successful bidder contractor. Bidder's quoted/accepted rates/ price shall be inclusive of all such requirements.
6.2	GST (as applicable) legally leviable & payable by successful bidder as per GST Law shall be paid by BHEL, extra. Hence, bidder shall not include GST (as applicable) in their quoted rates/ price.

6.10	Successful bidder shall comply with the Time Limit prescribed under the GST Law and rules thereof for raising of the Tax Invoice. If any supply of goods is applicable, successful bidder shall also ensure prompt delivery of goods after dispatch.
6.11	Bidder shall note that in case GST credit is delayed / denied to BHEL due to delayed / non receipt of goods and / or Tax Invoice or expiry of the timeline prescribed in GST Law for availing such ITC, or any other reasons, not attributable to BHEL, GST amount shall be recoverable from successful bidder along with interest levied/ leviable on BHEL, as the case may be
6.12	Successful bidder shall upload the invoices raised on BHEL in GSTR-1 within the prescribed time as given in the GST Act. Bidder shall note that in case of delay in declaring such invoice in your return and GST credit availed by BHEL is denied or reversed subsequently as per GST Law, GST amount paid by BHEL towards such ITC reversal as per GST law shall be recoverable from the successful bidder along with interest levied / leviable on BHEL.
6.13	Any new taxes & duties, if imposed subsequent to due date of offer submission as per NIT & TCN, by statutory authority during contract period (including extension, if the same is not attributable to you), shall be reimbursed by BHEL on production of relevant supporting document to the satisfaction of BHEL. However, you shall obtain prior approval from BHEL before depositing new taxes and duties
6.14	Benefits and / or abolition of existing taxes must be passed on to BHEL against new taxes, if any, proposed to be introduced at a later date.

8.0	TERMINATION OF CONTRACT: If at any time during the execution of the order, it is noted that the contractor is not discharging his obligations according to the terms of this contract, then BHEL will be at liberty to terminate the contract after giving 7 days notice by issuing contractual letter and the tenderer shall comply with the requirement of such notice. In such case no payment will be given for the balance work of contract including unsatisfactory services, if any.
9.0	LIQUIDATED DAMAGE (LD): It is to be clearly understood that the scope of work as specified in the work order should be made within the time limit as prescribed by BHEL. If the contractor fails to maintain the required progress of work which results in delay in the completion of the work as per the contractual completion period, BHEL shall have the right to impose Liquidated Damage/Penalty at the rate of 0.5% of the contract value, per week of delay or part thereof subject to a maximum of 10% of the contract value.
10.0	OTHER TERMS & CONDITIONS
10.1	The successful bidder has to abide by all the rules of SGTPP site including HSE plan related rules.
10.2	The representative of the vendor should be available as per requirement at SGTPP Site for continuous supervision of the workmen as per the productivity, safety and quality norms of the BHEL standard.
10.3	Contractor shall ensure that no IR issues or problem is created at site and if any such issue is created at site, then BHEL reserves the right to immediately terminate the contract. Contractor shall obtain undertaking from each worker in this line before mobilization of any such worker to site.
10.4	BHEL reserve the right to cancel the order in case of delay in mobilization of workmen by successful bidder and failure to comply with quality, HSE and productivity requirements.
10.5	The Contractor shall be responsible for safety of his workmen, materials and equipment deployed at site.
10.6	Refreshment and drinking water for the workmen, has be arranged by the contractor.
10.7	All labour rules, factories act, statutory requirements to be strictly adhered by the contractor.
10.8	Sub-letting of jobs within the agreed scope of work, in any way is not permitted.

10.11	BHEL reserves the right to short close the contract/reduce the scope upon giving 7 days' notice, depending upon requirement. In such cases, the payment shall be made for the completed scope of work and part thereof on pro-rata basis, based upon approved rate of the contractor and no other compensation will be granted by BHEL. The quantities of job in this schedule are approximate and may vary to any extent (upward / downward) or may be deleted altogether. The rate quoted against each item of the schedule shall remain firm till the contract value remains within "+" or "-"15%.
10.12	Contractor's personnel posted at site shall not move outstation without the prior permission of Construction Manager of BHEL.
10.13	This contract shall also be governed by the standard General Condition of Contract (GCC) of BHEL, a copy of which is available in BHEL office for familiarization of the contractor and the Contractor is supposed to go through the same, failing which it will be presumed that the contractor accepts all the conditions.




