2.0 SCOPE OF WORK

- 2.1 Rewinding of ceiling fan motors shall be done in party's work shop.
- 2.2 All the material used by party in ceiling fan motor rewinding including winding wire insulating material and insulating varnish etc should be of a good quality.
- 2.3 The re-winded ceiling fan motors shall be covered under a guarantee for a minimum period of 06 months.
- 2.4 Transportation of damaged and re-winded/ repaired motors shall be arranged by the party.
- 2.5 Damaged ceiling fan motors shall be issued to the party through returnable material gate pass (in a lot of maximum 20 ceiling fan motors) by Test Plant Maint Ctr of Factory.
- 2.6 Fresh lot of Damaged ceiling fan motors shall be issued to the party by BHEL only after handing over the previous lot of re-winded/ repaired ceiling fan motors to BHEL, by the party.
- 2.7 **Burnt copper wires of damage winding will be at bidder's disposal. However this shall be taken care of while quoting the rate of item no 01 of BOQ.**

3.0 URGENT WORK

The contractor shall have to comply with the priorities fixed by the maintenance in charge for taking urgent rewinding work other than schedule rewinding work.

4.0 PERIOD OF CONTRACT

The period of contract will be for twelve months or completion of total work whichever is earlier from the date of issue of work order.

5.0 Special term and condition

The work of repair and rewinding of sealing fan motors shall be done by the vendor in their own workshop therefore compliance like PF and ESI will not be applicable.

QUALIFYING REQUIREMENTS

1) Average Financial Turnover:

1.1) Average Annual financial turnover during the last 3 years, ending 31st March, 2020 should be at least Rs. 0.48 Lakh of the estimated cost. Duly audited Financial Statement/ Balance sheet / Certificate from CA to be submitted as a supporting document.

1.2) If all balance sheets are not available for all three years then the average shall be calculated by dividing the sum of turnover of submitted balance sheets by three.

2. Experience of having successfully completed similar work (means **Repair and rewinding of ceiling fan motors/3 phase induction motors/Ac & DC motors**) during last 7 years ending on the last day of the month previous to the one in which applications are invited should be either of the following:

- Three similar completed works contracts each costing not less than the amount equal to Rs.0.65 Lakh.
Or
- Two similar completed works contracts each costing not less than the amount equal to Rs. 0.81 Lakh
Or
- One similar completed work contracts each Costing not less than the amount equal to Rs. 1.30 Lakh

3.
