- 1.1 Light decoration in Factory Main gate : Scope includes to supply and fixing/connecting of Good quality and sufficient quantity of electrical decoration lights in the front side of the factory main gate towards N.H-26 two small parks in front of factory main gate. The period of decoration shall be three days.

1.1) Average Annual financial turnover from during the last 3 years, ending 31st March, 2021 should be at least Rs. 0.23 Lakh of the estimated cost. Duly audited Financial Statement/ Balance sheet / Certificate from CA to be submitted as a supporting document.

1.2) If all balance sheets are not available for all three years than the average shall be calculated by dividing the sum of turnover of submitted balance sheets by three.

Bidder not having statutory obligation to get financial statement audited must submit following documents as evidence for turnover:

a. Complete ITR with all annexure as filled online as proof to verify turnover.

OR

b. A certificate from CA duly vetting turnover.

c. Audited balance sheet & profit and loss amount.
