- a) The required documents/ drawing/E.S can be seen at our works.
- b) Contractor shall have to collect all required material, drawings and information's from BHEL store/ shop/ office. Required space, tools, tackles, and facilities like material handling equipment's fixture and crane will be provided by BHEL subject to its availability in normal working conditions. Consumables like resin glass tape, araldite, varnish, paint cotton waste, feviquik etc. will be issued by BHEL as available, and these will be collected by contractor. Contractor will check for any defect in material and get it rectified/ replaced before starting work.
- c) All the material, electricity, compressed air, consumable and tools available with BHEL shall be provided by BHEL (tool store) free of cost on returnable basis. No dues certificate to be taken from the tool store at the end of the contract.
- d) The contractor has to complete coil winding as per corresponding coil winding E.S & drawing. The coil will be treated as complete only when all the compliance w.r.t corresponding drawing is fulfilled.
