- Lifting the DG set from base by crane, loading it on trailer to transport the same to the predefined site in BHEL Township, off-loading it by crane and positioning it on prebuild platform.
- Transporting the canopy panels from existing site along with AMF panel to BHEL Township and reassembling the same at new site i.e installation of the same as per requirement.
- Commissioning of DG set after connecting the outgoing cable from alternator to AMF panel for outgoing supply, testing and commissioning completion as per requirement.
