2.0 SCOPE OF WORK

1.1 Cable laying work will be done as per instructions given by maintenance in charge. It includes transportation of cable drums from store to work place , laying of cable in a buried cable trench sized 450X1000mm deep duly covered with bricks and re-filling with excavated earth and finish up to the existing ground level in all respect.

1.2 Cable will be issued to the contractor free of cost form WE&S store.

1.3 After cable laying the empty cable drums or remaining cable in drums should be handed-over in WE&S store.

2. SCOPE OF CONTRACT WORK FACILITY

2.1 Sufficient work force shall be maintained by the contractor for the work mentioned above. Work shall be done in First shift. However, work in second shift may also be done subject to availability of work front and priority of work if any as instructed by the erection in charge.

2.2 Contractor shall maintain all records pertaining to his work.

2.3 All the basic tools shall be arranged by the contractor however welding facilities (cutting/welding machines and welding rods) shall be provided by BHEL free of cost.
