A. INSTRUCTIONS FOR THE BIDDERS/TENDERERS:

- 1. The offer shall be submitted as per the instructions of tender document. Only one set of tender document duly signed & stamped on each page shall be submitted as detailed further. Tenderer should note specifically that all pages of tender document, including the NIT page for this particular tender shall be submitted by them (after signing/ stamping on each page) as a part of their offer. Price shall not be mentioned by them anywhere in the techno-commercial portion of offer, except in the relevant price bid and submitted in separate sealed envelope. In case of any clarification, bidder may contact this office.
- Tender documents are also available on BHEL web site (<u>www.bhel.com</u>) & on CPP Portal (http://eprocure.gov.in/cppp/) which can be downloaded and used as tender document for submitting the bid.
- 3. All documents submitted by the Tenderer in his tender may be accompanied with a covering letter giving index interlinking all the documents.
- 4. No overwriting / correction in tender documents by tenderer shall be allowed. However, if correction is unavoidable, the same must be signed.
- 5. Tender must be submitted in two parts, i.e., (i) Techno-Commercial Bid along with un-price bid (Annexure-E-1) and (ii) sealed Price Bid. The tenderer must submit their tenders in three separate sealed envelopes prominently super scribed as 'EMD Deposit', Part A 'Techno- commercial bid' and Part-B 'Price Bid' along with NIT No. & due date written on each of the envelope. These three separate envelopes shall together be kept in fourth envelop super scribed with name of Work, NIT No. & due date of opening.
- Techno-commercial bid should contain all the documents in proof of Pre- qualifying criteria, signed tender document having NIT page, Instructions for tenderer, general conditions, Special Conditions, Contractor's Obligations, un-price bid, all the annexure duly filled & signed by the tenderer and the envelope containing EMD.
- 7. The tenderer shall submit the Bank details along with a cancelled cheque for payment through NEFT/RTGS.
- 8. Price Bid should contain only the "Part-B, Price Bid Format" after quoting the rates/percentages/amount as specified in the Price bid format.
- 9. On the date of opening of tender, only Techno-Commercial Bid shall alone be opened.
- 10. BHEL reserves the right to accept or reject any or all offers without assigning any reason thereof. Also BHEL shall not entertain any correspondence from bidders in this matter (except for the refund of EMD).
- 11. In case any typing error/other clerical errors is noticed by the tenderer, in the tender documents, the same must be pointed out and got clarified before submission of offer, or else, BHEL's interpretation shall prevail & shall be binding on the tenderer.
- 12. The Tenderer should accept all terms & conditions of the tender unconditionally. Tenders with deviations from terms and conditions are likely to be rejected.
- 13. In case any document required as per PQR is not submitted in techno-commercial bid (part-A) the party shall be asked to submit the same within 48 hours by email, etc. If the document(s) is/are not received within 48 hours the offer may be rejected.
- 14. Tenderers are requested to go through the scope of work, visit the site/location etc. and get fully acquainted with the work place and prevailing working conditions to get all their doubts clarified regarding the above work before submitting the offer. Engineer-in-charge's decision will be full and final in the event of any. Any queries regarding this tender may be clarified from Dy. - 15. The tenderers or their representative may attend the opening of techno-commercial bid (Part-A) and the technically qualified tenderers or their representative may attend the opening of Price bid (Part B), if they so desire. The tenders (both the parts) shall be opened on schedule date & time even if the bidders or their representative are not present.

B. PRE QUALIFYING CRITERIA:

- 1) The Earnest Money Deposit (EMD) of **Rs 28,100***l* (Rupees Twenty-Eight Thousands One Hundred Only) only in the following forms in favour of BHEL, payable at New Delhi, must be submitted in a separate envelope:
 - a) Cash deposit as permissible under the extant Income Tax Act (before tender opening)
 - b) Electronic Fund Transfer credited in BHEL account (before tender opening)
 - c) Banker's cheque/ Pay order/ Demand draft, in favour of BHEL (along with offer)
 - d) Fixed Deposit Receipt (FDR) issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Bidder, a/c BHEL).
- 2) The bidder should have PAN Card.
- 3) The bidder's average annual financial turnover should be Rs 4.21 Lakhs or above for the last three Financial Years (2018-19, 2019-20 & 2020-21).
- 4) The copies of work orders along with Certificate of Satisfactorily completion of Similar Works (Similar completed Works shall mean Repairing of Air conditioners as per the values mentioned below) during last 7 years ending on 28.02.2022 should be either of the following: -
 - (i) Three similar completed Works costing not less than Rs. 5.61 Lakhs each

Or

(ii) Two similar completed jobs/ services costing not less than Rs. 7.01 Lakhs each

Or

(iii) One similar completed jobs/ services costing not less than Rs. 11.22 Lakhs.

5. DOCUMENTS REQUIRED IN SUPPORT OF PRE-QUALIFYING REQUIREMENT:

- a) Complete tender document in all respects duly signed & stamped on each and every page as a token of acceptance of all the terms and conditions of tender.
- b) Self-attested copies of CA certificate OR Balance Sheet with Profits & Loss Account statements of last three financial years i.e. 2018-19, 2019-20 & 2020-21.
- c) Self-attested copies of acknowledgements of IT return of last three financial years i.e. 2018-19, 2019-20 & 2020-21.
- d) Self-attested copies of Work Orders/ Award letters along with certificates of completion in support of proof of experience for the works executed by the bidders during last 7 years ending on 28.02.2022. BHEL reserves the right to cross check the documents from the issuing department/ company.
- e) Self-attested copy of the PAN Card.
- f) The Bidder must Submit a declaration (enclosed at Annexure –E2), that no case is pending with the police/ court against the proprietor/ firm/ partner or the company (Agency). As well as the bidder has not been suspended / blacklisted by any organization.
- g) No deviation certificate as per Annexure -E3 (enclosed) must be signed and stamped.
- h) Bidder must submit the technical details in the enclosed format (Annexure-E4).
- i) Bidder must submit the bidder's details in the enclosed format (Annexure-E5)
- Bidder must submit the Check-list enclosed at Annexure-E6 after duly filled and signed.

C. SPECIAL TERMS & CONDITIONS RELATED TO THE SUBJECT WORK:

- All the ACs are installed at different locations in the same premises of BHEL Township, Sector-17, Noida.
- b. The bidders are advised to visit the premises and get the ACs checked thoroughly before quoting the rates for repairing.

- c. The ACs are to be repaired in totality and are to be brought to good working and running condition by supply and installation of the parts/ spares if any. After installation of required parts, the AC must function upto the satisfaction of Engineer in charge.
- d. Gas charging of ACs shall include repairing of coils, pressure leak testing, vacuuming and finally gas charging etc. Cost of any part(s) pertaining to repairing work will be included in above rates.
- e. The sufficient manpower such as Service Engineer/ technicians/ supervisors must be deployed by the contractor to complete the work within stipulated time. They will carry out instructions of Engineer-in-charge during the progress of work.
- f. Any AC damaged by the negligence of the contractor's representative shall be repaired up to its original condition at no extra cost to BHEL.
- g. All the spare parts supplied and installed by vendor should be genuine, brand new and of Original Equipment Manufacturer or equivalent make. In case of any doubt whether the spares are new or not, the BHEL may ask the contractor to furnish the bill or any relevant documents. In this case, the decision of BHEL shall be final and binding on the contractor.
- h. The bidder shall consider the cost impact of the parts which are not mentioned in price bid but are required for running of Air Conditioners. Nothing extra will be payable for supply and installation of these parts.
- The contractor will maintain a logbook of the work and write all parameters of repaired ACs on daily basis and get countersigned by the Engineer in charge.
- j. The repairing work of all ACs shall be under warranty of 3 months in totality and the warranty of parts/ spares shall be as description mentioned in the price bid.

D. GENERAL TERMS & CONDITIONS: -

- 1) Tenders received late /in open condition/without EMD/ not meeting the tender condition / incomplete in any respect are likely to be rejected.
- 2) BHEL will not be responsible for the postal delay under any circumstances for non-receipt of Tenders by due date & time.
- 3) BHEL has the right to reject all or any of the tenders and accept any tender(s) irrespective of its / their being the lowest / highest.
- 4) If any information/ documents submitted by the tenderer are found false/fake at any stage, the tender will be cancelled and Earnest Money deposited (EMD) shall be forfeited.
- 5) The offer of the bidders who are on the banned list as also the offer of the bidders, who engage the services of the banned firms, shall be rejected. The list of the banned firms is available on BHEL web site www.bhel.in.
- 6) The evaluation currency for this tender shall be INR (Indian National Rupee).
- 7) The Tenderers are required to quote for the complete scope of work. Tenders for part of the work or incomplete in any respect shall be rejected.
- 8) Rates/amount/percentage quoted by the bidder will be firm for the contract period or extended period of contract. No price variation and escalation due to increase in labour / material cost will be allowed.
- 9) The rates/amount quoted by the bidder are deemed to be inclusive of all, cost of site clearance and any other incidental works required to complete the work and inclusive of all the taxes but excluding GST. GST shall be quoted extra in the same price bid format.
- 10) If GST is applicable to the vendor, then the vendor should provide the GST registration Certificate also.
- 11) **VALIDITY OF RATES:** Validity of rates will be **90 days** from the date of opening of the technocommercial bid.
- 12) Estimated rates have been disclosed and firm & fixed in the tender documents and only percentage rate tenders are invited. Accordingly, the basic amount as per basic rates has been calculated against each item. Bidders have to quote only a single overall percentage, (+) above, (-) below or at par with the tender rates at S. No. 09 of Price Bid format. The same quoted percentage will be applied on every item of the BOQ. Any deviation by means of changing the estimated rate of an individual item or modification of quantity to be supplied will be treated as non-acceptance of tender terms and bid will be rejected.

13) **EVALUTION CRITERIA:** The criteria of evaluation of techno-commercial bids shall be on the basis of documents submitted by the tenderers.

Estimated rates have been disclosed in the tender documents and percentage rate tenders are invited. Accordingly, the basic amount as per basic rates has been calculated against each item. Bidders have to quote a single overall percentage, (+) above, (-) below or at par with the tender rates at S. No. 9 of Price Bid format. The same quoted percentage will be applied on every item of the BOQ. Evaluation of Price Bid will be done on overall L-1 rate inclusive of all including all taxes and duties (i.e. on Sl.No.-13 of Price Bid).

BHEL shall finalize successful tenderer by conducting online Reverse Auction. Date of conduction of online Reverse Auction will be intimated, by post or e-mail separately to the Tenderers who qualify in the Techno-Commercial bid, the decision of BHEL will be final in this regard.

14) REVERSE AUCTION:

"BHEL shall be resorting to Reverse Auction (RA) (Guidelines as available on www.bhel.com) for this tender. RA shall be conducted among all the techno-commercially qualified bidders.

Price bids of all techno-commercially qualified bidders shall be opened and same shall be considered as initial bids of bidders in RA. In case any bidder(s) do(es) not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking."

- 15) CORRECTION OF ARITHMETIC ERRORS: Provided that the bid is substantially responsive, BHEL shall correct arithmetical errors on the following basis:
 - a) If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the BHEL there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected.
 - b) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected.
 - c) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (a) and (b) above.
 - d) If any bidder does not accept the correction of errors, their bids are liable to be disqualified.
- 16) <u>COMPLETION PERIOD:</u> The completion period will be 20 Days from the date of award or the Start date as specified in the Work Order.
- 17) **QUANTITY VARIATION:** The quantity of any item mentioned in the Price Format may vary ±10% during execution of work as per the direction of Engineer-in-charge
- 18) **SUBLETING:** The Contractor shall not sublet, transfer or assign the full work or any part thereof to any other person/company/organization. In case it is found that the work has been subletted, the contract shall be terminated immediately & Security Deposit shall be forfeited.
- 19) The contractor should have PF code number & ESI code number before the start of work. However, in case of not having any or both the documents, the contractor shall arrange & submit the documents before claiming first running bill.
- 20) Accommodation in any manner will not be provided to the workers of the contractor deployed in the execution of work.
- 21) **PERIOD OF GUARANTEE/ MAINTENANCE:** The contractor will be responsible for the quality of the work/services and it is to be guaranteed for a period of 3 months from the date of actual completion of contract.
- 22) WATER & ELECTRICITY: Water and electricity shall be supplied to the contractor by BHEL subject to the following conditions:
 - a) Water & Electricity shall be provided free of cost.
 - b) Contractor shall make his/ their own arrangement of water/ electricity connection and laying of pipelines/ connection from existing main of source of supply as directed by Engineer in charge.

c) BHEL do not guaranty to maintain uninterrupted supply of water/ electricity and it will be incumbent on the contractor to make alternative arrangement for proper supply of the same at his/ their own cost in the event of any break down in the government water/ electricity mains so that the progress of his/ their work is not held up for the want of the same. No claim of damage or refund will be entertained on account of such break down.

23) STORES AND MATERIALS ON SITE:

- a) The contractor shall, during the progress of work, provide, erect and maintain at his own expense all necessary temporary work-shops, stores etc. required for the proper and efficient execution of work. The location & size of the store shall have the approval of the Engineerin-Charge and the contractor shall at all times keep them tidy in a clean and sanitary condition to the entire satisfaction of the Engineer-in-Charge.
- b) All materials for the work are to be deposited by the contractor only in places to be indicated by the Engineer-in-Charge.
- c) The safety & security of the contractor's materials will be the responsibility of contractor himself. BHEL will not provide any compensation due to theft or loss of contractor's materials.
- d) The stores provided by the contractor will not be utilized as the accommodation for the workers or for any other purpose.
- e) Contractor will remove the temporary stores/ structure before claiming the final bill.

24) TERMS OF PAYMENT: -

- a) No advance payment or the payment for mobilization of work will be made to the Contractors.
- b) Payment shall be made for the actual executed quantity of items/ works of price format.
- c) The payment of bill will be made only after satisfactory completion of work, clearance of the site & clearance of all the liabilities on Contractors' part.
- d) The contractor shall not be entitled to any interest with respect to any money which may be due to him for BHEL.
- e) Bills raised by the Contractor shall be certified by the official in-charge of BHEL and the payments will be made against bill, within 21 days by NEFT from the date of receipt of bill without any discrepancies, subject to conditions mentioned at SI. No. 25 (Taxes & Duties).

25) TAXES & DUTIES: -

- a) To enable BHEL to avail GST input tax credit, contractor shall submit GST compliant Tax invoice containing all the particulars as stipulated under invoice Rules of GST Law. Payment shall be made to the contractor only after submission of GST complaint Tax invoice. The successful bidder shall raise GST compliant invoice affixing GSTIN of BHEL's unit availing the services.
- b) BHEL reserves the right to protect its interest against any loss on account of availability of GST credit.
- c) GSTIN of BHEL will be provided to the contractor along with the work order.
- d) Any new/ change in statutory levy as and when made applicable by the Government shall become applicable against documentary evidence.
- e) Payment to the contractor will be subjected to TDS as per rules in force from time to time. The Tax Deduction at Source (TDS) shall be done as per the provisions of Income Tax Act & GST, as amended from time to time and a certificate to this effect shall be provided to the contractor by BHEL.
- f) Applicable GST shall also be recoverable from the contractor in case of LD recovery/ penalty on account of breach of terms of contract.
- g) Invoice submitted should be in the format as specified under GST Laws viz. all details as mentioned in Invoice Rules like GSTIN registration number, invoice number, quantiy, rate, value, taxes with nomenclature CGST, SGST, IGST mentioned separately, HSN (Harmonized System of Nomenclature) Code/ SAC (Services Accounting Code) Code etc.
- h) The Contractor has to give an undertaking that GST as mentioned in the invoice has been/ will be paid and also file returns as per respective extant rule.

26) PROGRESS OF WORK AND PENALITY FOR DELAY (L.D.):

a. The project is time bound and works shall have to be carried out at desired pace throughout the execution period. The completion time is 20 days from the date of award of contract.

- b. In case of delay, a penalty of 0.5 % per week delay will be deducted from the bill. However, the total penalty due to delay will be upto maximum 10 % of total contract value. L.D. will be calculated on the total contract value. For the purpose of Total LD calculation, the contract value shall be the total contract value of work.
- c. In case of LD/Penalty recovery, the applicable GST shall be recovered from the contractor.
- 27) Bonus Clause, PVC & ORC are not applicable.

28) **EARNEST MONEY DEPOSIT (EMD):**

- (3) Banker's cheque/ Pay order/ Demand draft, in favour of BHEL (along with offer)
- (4) Fixed Deposit Receipt (FDR) issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Bidder, a/c BHEL).
- b) EMD of the tenderer will be forfeited if:
 - (1) After opening of the tender the tenderer revokes his tender within the validity period or increase his earlier quoted rates.

29) **SECURITY DEPOSIT:**

- b) Security deposit may be furnished in any one of the following forms:
 - i) Cash (as permissible under the Income Tax Act)
 - ii) Pay order / demand draft in favour of BHEL.
 - iii) Local cheques of schedule banks, subject to realization.
 - iv) Securities available from Post Offices such as National Saving Certificates, Kisan Vikas Patras etc. (Certificate should be held in the name of the contractor furnishing the security and duly pledged in favour of BHEL and discharged on the back).
 - v) Bank Guarantee from Schedule Banks/ Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL.

- c) Bidder agrees to submit performance security required for execution of the contract within 7 working days. In case of delay in submission of performance security, enhanced performance security which would include interest (SBI rate + 6 %) for the delayed period, shall be submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT/ contract, from the bills along with due interest.
- d) The security deposit will be released only after completion of Guarantee/ Maintenance period of 3 months from the date of actual completion of work.
- e) Failure to pay the security deposit shall be treated as failure to discharge the duties under the contract and may result in cancellation of the contract and the contractor shall be liable to compensate BHEL for any losses incurred by BHEL. BHEL reserves the right to appropriate any part / whole of the amount of the security deposit without prejudice to other claims against the contractor for losses suffered by BHEL due to failures on the part of the contractor, due to termination of contract or contractor becoming disqualified because of liquidation / insolvency. - 30) <u>TERMINATION OF CONTRACT:</u> BHEL may terminate the contract by giving not less than Seven day's written notice of termination to the successful tenderer, if the successful tenderer does not remedy a failure in performance of their obligation under the contract or without assigning any reason, within thirty days after being notified and without prejudice to the rights of the Company to recover any amount becoming due under this Contract.
- 31) <u>TERMINATION OF CONTRACT ON DEATH:</u> Without prejudice to any of the rights or remedies under this contract, if the contractor dies, the accepting officer shall have the option of terminating the contract without compensation to the contractor's survivors.
- 32) RECOVERY.FROM CONTRACTOR: Whenever under the contract, any sum of money shall be recoverable from or payable by the contractor, the same may be deducted from any sum then due or which at any time thereafter may become due to the contractor under the contract or under any other contract with BHEL or from his security deposit, or the contractor shall pay the claim on demand without any terms & conditions.
