Your competitive offer is invited in a sealed tender cover for filling up of medical oxygen gas for use in Medical department. The tender cover should be superscripted as "TENDER FOR FILLING & SUPPLY OF MEDICAL OXYGEN GAS IN TYPE B BHEL CYLINDERS" on the top.

- 1. Tenders will be received by M/s Bharat Heavy Electricals Ltd, Main hospital, Ranipet-6 up to 14:00 Hrs of 11.10.2024 in the prescribed form and will be opened on 11.10.2024 at 14:30 Hrs. or immediately on receipt of the offer in the presence of tenderer or their agent, who may choose to attend, with authorization letter from the tender.
- 2. Tenders must be submitted in sealed covers and should be addressed to DM/MEDICAL, BHEL/BAP/MAIN HOSPITAL/RANIPET, with full name and address of the tenderer and the name of the work being super scribed on the cover
 - **IMPORTANT NOTE**
- 3. The tender shall be submitted as given below.
 - Cover-1: Signed copy of tender document
 - Cover-2: Price Bid in BHEL Format

Each of the above covers shall be super scribed with tender number, respective cover content detail Technical bid, Price bid and with full name and address of the tenderer.

Finally, both the covers shall be put in one single large cover and super scribed with the tender number, due date, name of the supply and with full name and address of the tenderer.

All entries in the tender documents should be in one ink. Erasures and over-writings are not permitted. All correspondences and insertions should be duly signed by the tenderers concerned.

- **4.** Tenderers should fill their rates in figures and words in the blank spaces provided for this purpose in the schedule of rates format enclosed along with these documents and also sign each and every page of the tender documents.
- 5. Tenderer has to put sign and seal at the bottom right side in all the pages of tender documents.
- **6.** The tenderer should fill and sign the "checklist of this Tender document" which forms part of the technical bid.
- 7. Earnest Money Deposit (EMD) amount: NIL
- **8.** Conditional tenders, tender containing absurd rates and amounts, tenders which are incomplete or other wise considered defective and tenders not in acceptance with the tender conditions laid down by the Accepting Officer, are liable for rejection.
- **9.** In quoting the rates, the tenderers are advised to take into account of all the factors including any fluctuations in the market rates etc. No claim shall be entertained on this account after acceptance of the tender or during the currency of the contract.
- **10.** The rates quoted in the tender shall remain valid for a period of three months from the date of technical bid opening for acceptance by BHEL. No unsolicited revision in the tender offer shall be entertained after opening of tenders and till expiry of the validity period.
- 11. Tenders submitted by post should be sent through "REGISTERED POST WITH ACKNOWLEDGEMENT DUE/Speed Post/Courier". The tender should be posted with due allowance for any delay in postal delivery. The tenders received after the due date and time schedule specified in the tender will not be considered for further processing.
- **12.** If the vendor deliberately, gives wrong information in his tender or creates conditions favorable for the acceptance of his tender, Bharat heavy Electricals Limited reserves the right to reject such tender at any stage.
- **13.** Canvassing in any form in connection with the tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.

- **14.** The tender documents must be signed physically / digitally by Director / Partner of the Firm or by the person holding the Power of Attorney on behalf of the Firm concerned. In the latter case, a copy of Power of Attorney, duly attested by a Notary Public must accompany the tender.
- **15.** The tender schedule, and the tender shall be deemed to form an integral part of the contract to be entered into for this work/service/supply.
- 16. Tender can be cancelled at any stage due to unavoidable circumstances.
- 17. The evaluation currency for this tender shall be INR.
- 18. Multiple Bids: -
- **19.** The bidder in his own interest shall submit only one bid. If a bidder submits multiple bids, all the bids are liable for rejection. Bids shall be considered "Multiple" in the following circumstances:
 - a) Two bids by the same party-
 - b) If one bidder is the affiliate of another bidder.

For the purpose of this clause "Affiliate" shall mean with respect to any person, any other person that directly or indirectly, controls, is controlled by, or is under direct or indirect common control with, such person, or is a director/ member/ office/ employee of such person or of any person who would otherwise qualify as an affiliate of such person pursuant to this definition.

"Person" for the purposes of this definition shall mean any natural person, individual, corporation, limited partnership, co-operative, general partnership, joint stock company, joint venture, association, company, trust bank, trust company, land trust, business trust, corporate body or other organization, whether or not a legal entity.

- **20.** Offers of the Contractors/Suppliers, against whom, any unit of BHEL had initiated process for "Suspension of Business Dealings" or already done will summarily be rejected.
- 21. If at any stage, the document(s) submitted by contractor is/are found incorrect/ false/ manipulated, the necessary action will be taken by BHEL against contractor as per the "Guidelines for suspension of Business dealings".
- 22. Suspension of Business dealings with Suppliers:

Any supplier against whom action has been initiated under "suspension of business dealings with suppliers" are not qualified to participate in this tender. Before submitting offer, prospective bidders are advised to visit our web-site www.bhel.com / supplier registration to familiarize themselves with BHEL's policy and procedures of Suspension of Business Dealings with Suppliers. Submission of offer shall be deemed to be evidence of the Bidder to have read and understood the above said policy.

- 23. Treatment of Debarment / Under-performing Vendors:
 - Any supplier who has been put on "Debarment" from having business dealings with BHEL, Ranipet or any other unit of BHEL shall not submit their offer against this tender. If any such offers are received they would be summarily rejected and sent back. During the processing of tender, if any unit of BHEL puts a supplier on "Debarment" then further processing of the offer will not be taken up and in case an order is placed, BHEL, Ranipet may resort at their discretion to cancel the PO either fully or partially.
- **24.** In quoting the rates, the tenderers are advised to take into account of all the factors including any fluctuations in the market rates etc. No claim shall be entertained on this account after acceptance of the tender or during the currency of the contract.
- **25.** Any deviation to this tender terms & conditions and schedules of this tender will lead to total rejection of the offer submitted.
- **26.** The tenderers can visit BHEL on working days during office working hours for any clarifications before submitting their offer.
- 27. BHEL reserves the right to reject any tender on the basis of unsatisfactory performance of the bidder in any ongoing job or any similar job in the past.

- 28. Incomplete offers shall become liable for rejection.
- **29.** Conditional tenders, tender containing absurd rates and amounts, tenders which are incomplete or otherwise considered defective and tenders not in acceptance with the tender conditions laid down by the Accepting Officer, are liable for rejection.
- **30.** If a tenderer expires after submission of his offer, the Bharat Heavy Electricals Ltd., may be at their discretion to reject such offer.
- **31.** BHEL reserves the right to negotiate with L1 bidder.
- **32.** Tenderers shall not increase their quoted rates in case BHEL negotiate for reduction of rates, such negotiations shall not amount to cancellation or withdrawn of the original offer and the rates originally quoted shall be binding on the tenderers for a period of three months from the date of opening of tenders.
- **33.** The tenderer should be present if called for negotiation. In case, the tenderer's authorized person is attending the negotiation such person should have the authorization letter and he should be capable of taking spot decisions.
- **34.** MSE CLAUSE: MSE bidders can avail the intended benefits only if they submit attested copies of UDYAM Certificate, along with the offer. No benefit shall be applicable for this enquiry if required documents are not submitted before price bid opening.
- 35. Discrepancy in "words "& "Figures ":
 - a) If, in the price structure quoted for the required goods/services/works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
 - b) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
 - c) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (a) and (b) above.
 - d) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
- **36.** The tenderers are requested to bear in mind the entire operations involved, and the conditions during currency of the contract, and request for rate revision of any kind will not be entertained.
- **37.** BHEL will not be bound by any Power of Attorney granted by the tenderer or on their behalf or changes in the composition of the firm made subsequent to the execution of the contract. They may, however, recognize such power of attorney and changes after obtaining proper legal advice, the cost of which will be chargeable to the contractor concerned.
- **38.** The general and special conditions of contract are complementary to each other and where there is a conflict, the special conditions shall prevail. In regard to matters not covered by the General or Special Conditions of Contract, those contained in the specifications approved by BHEL shall apply.
- **39.** The "GENERAL CONDITIONS, INSTRUCTIONS TO BIDDERS AND SPECIAL CONDITIONS OF CONTRACT" shall be deemed to form an integral part of contract for the work to be entered into.
- **40.** If a ring formation is suspected, BHEL may reject all offers or retender or call new sources who have not been contacted or responded against this tender.

- **41.** BHEL reserves the right to accept or reject the lowest or any other tender or accept or reject any part of such tender without assigning any reasons therefor.
- **42.** All the information as called for in the various clauses and annexure of tender specification should be furnished. The details so furnished should be complete in all respects and as per the formats prescribed in the Tender specification (Statutory requirement of Contract). The bidder may have to produce original documents for verification, if so decided by BHEL.
- 43. Offers received with any deviation or without relevant information are liable to be rejected.
- **44.** <u>AGREEMENT</u>: The tenderer after award of work by BHEL through letter of intent/PO shall execute an agreement in the form and the manner as specified by BHEL on non-judicial stamp paper of value not less than Rs.100.00. The cost of stamp paper will be borne by contractor.
- **45.** <u>STAMPING THE AGREEMENT</u>: The expenses of completing and stamping the agreement are borne by the contractor.

SPECIAL TERMS AND CONDITIONS OF CONTRACT

- 1. BHEL reserves the right to use the driver as per requirement.
- 2. The tender will be finalized awarded to L1 bidder based on the overall cost to BHEL.
- 3. Conditional tenders are liable for rejection. No conditions shall be acceptable after tender opening or during negotiation. If tender is cancelled due to conditions imposed by the tenderer after tender opening, offer will be rejected & the tenderer will be delisted.
- 4. The contractor should not sub-contract the works.
- **5.** Delivery period: The delivery period shall be 02 days from the date of acknowledging receipt of cylinder at vendor premises.
- **6.** Contract validity: Rate contract (frame work agreement) will be valid for a period of ONE year from the date of award (LOA). Purchase order will be released within the validity of RC as per BHEL requirement. Moreover, validity of contract is subject to further extension with mutual consent. PO placed under this contract shall be governed by the T&C's of this contract till the completion of PO and settlement of all dues with the vendor.
- 7. L.D Clause: In case of failure in supply by the Bidder as per schedule, a penalty of 0.5% per week for undelivered portion shall be deducted subject to a maximum of 10% of total purchase order value from the bills during payment.
- 8. Payment Terms:100% direct EFT payment within 90 days from the date of receipt of items at BHEL Medical stores, Ranipet and acceptance of medicines based on original / copy of self-attested Lab batch test reports. For MSE vendor payment will be within 45 days & for Medium Enterprises payment will be within 60 days. Any deviation in the above payment terms or any other Payment terms will not be accepted.

9. GST:

Registration & GST Rate

- (i) Bidder should indicate GSTIN No. (Copy of GST registration to be enclosed) and PAN No. (copy of PAN to be enclosed).
- (ii) Central Tax/ State Tax/ Integrated Tax/ Union Territory tax to be quoted as extra in %.
- (iii) Bidders to ensure correct applicability of Central Tax/ State Tax/ Integrated Tax/ Union Territory tax based on the Inter / Intra state movement Supply of goods and provision services or both.

Invoicing & Payment

- (v) Reimbursement of GST (if applicable) to the vendor is contingent upon complying with the following condition by the service provider:
 - i. Uploading the onward GST Return (GSTR-1) in GSTN Network portal within the statutory time period.
 - ii. Discharging the GST tax liability to the Government.
 - iii. Submission of Tax Invoice to BHEL.
 - iv. Submission of proof of payment of GST to BHEL.

Penalty for Non-compliance of GST Act
