1. 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
  - i. If number of technically qualified bidders are only 2 or 3.
  - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
  - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
  - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
  - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

### 1. Buyer Added Bid Specific ATC

PRE- QUALIFICATION REQUIREMENT (PQR):

I) Average annual turnover of the contractor should be at least ₹2.19 Lakh during the last 3 years ending 31st March 2024.

Tenderer should enclose Certificate of incorporation / Firm registration, EPF, ESI/Employee Group Insurance, PAN, GSTIN registration no., Income tax returns for last three years (AY 2022-23, 2023-24 & 2024-25), Profit & Loss account and Balance Sheet certified by the Practicing Chartered Accountant for the last 3 years

II) The Contractor should have experience of completing similar works during the last 7 years ending 31st January 2025 as given below: -

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
