- (G) SPLITTING: CONDITION FOR QUANTITY SPLIT BETWEEN TWO VENDORS IN THE RATIO OF 60:40:-
- (a) BHEL WILL SPLIT THE TENDERED QUANTITY BETWEEN TWO VENDORS IN RATIO OF 60:40.
- (b) THE EQUATED L1 PRICE ON TOTAL COST TO BHEL BASIS WOULD BE COUNTER OFFERED TO THE NEXT HIGHER BIDDER IN THE ORDER OF THEIR RANKING AND THE QUANTITY SPLIT WOULD BE GIVEN TO THE BIDDER WHO ACCEPT THE EQUATED L1 PRICE ON THE BASIS OF THEIR RANKING IN THE PRICE BID.
- (c) IF NONE OF THE OTHER BIDDERS ACCEPTS THE L1 PRICE FOR 40% OF QTY, THEN THE ENTIRE QUANTITY OF THE TENDER WOULD BE CONSIDERED FOR PLACEMENT OF ORDER ON L1 VENDOR ONLY.
- (d) AT ANY POINT OF TIME, THE ABOVE DISTRIBUTION MAY BE CANCELLED OR CHANGED BY BHEL, HOWEVER EFFORTS SHALL BE MADE TO ENSURE DISTRIBUTION OF TOTAL ORDER AS PER ABOVE CRITERIA.
