SPECIAL CONDITIONS OF CONTRACT FOR WORK

- **1. Location of Site –** BHEL Jhansi Township. The contractor is advised to visit the site and meet the officials of TCX department for any clarifications before quoting their rates for the work.
- 2. Time allowed for completion of work 12 months.
- 3. **Defect Liability period –** Not applicable
- **4.** Payment Terms Measurement of completed work to be done monthly and bill to submitted by Contractor to department by 8th of next month. Payment will be done as per GTC Clause (X) (6).
- 5. Penalty for delayed work The work will be divided into 12 milestones i.e one for every month and for every milestone performance shall be evaluated by the formula

Performance Delay Index = (Number of working days – Number of service days)/7. Here 0 is the desired level for performance.

If the Performance Delay Index in a month is more than 0 then LD equal to (Performance Delay Index * 0.5 % of contract value) will be deducted from the monthly bill of the contractor. The LD will be subject to maximum limit of 10 % of the contract value

6. PVC & ORC - Not applicable

- 7. Taxes & Duties The contractor shall submit their offer inclusive of all duties, royalty, entry tax etc except GST. If GST is applicable for the work, the contractor shall claim GST extra as per actual over the quoted price of the work. However the contractor must make payment of GST before claiming the same from BHEL
- **8. Award of work** –The work will be awarded to overall lowest bidder who has submitted the lowest total price for the work
- 9. The above contract will be covered under the BHEL CONCILIATION SCHEME, 2018.
- 10. Work Inspection shall be done by BHEL representative and payment shall be made on the basis of measurement only as per unit given in schedule. The contractor or his supervisor /authorized person will maintain a register and record the work / measurement immediately and get verified the satisfactory completion of work by BHEL personnel.
- 12. The contractor will be fully responsible for the preparation of bill and submission to

Engineer-in-charge.

- 11. The measurements of completed works and preparation of bill's related procedure will be govern by as per CPWD norms and guidelines. Contractor will comply with all CPWD's Norms, specifications, and guidelines related to work execution and billing.
 - 12. Final bill shall be prepared within 3 months after successful completion of work in the Performa prescribed for the purpose, based on the certificate issued by the Engineer that the entire work as stipulated in the tender Specifications has been completed in all respect to the entire satisfaction of BHEL. The Contractor shall give unqualified 'No claim' and 'no demand' certificate. The abstract of final quantities and financial values shall also be entered in the measurement book and signed by both the parties. The final bill shall be paid within a reasonable time after

After the payment of final bill, only the guarantee obligation percentage value (Security deposit) shall remain unpaid, which will be released after completion of defect liability period on submission of no-dues certificate.

- The contractor shall take necessary precautions for the safety of his workmen and provide them with all safety equipment like gloves, gum-boots etc. as per requirement. BHEL shall not be liable to pay any additional amount on account of any safety equipment / PPE.
- 14. The contractor shall take proper care to avoid any damage to BHEL property. If any damage does take place, the contractor will be fully responsible for the same .The decision of Engineer in charge is such case shall be final and binding on contractor.
- 15. The contractor will follow all safety rules required in connection with execution of such type of works.
