

Special terms & conditions for Enquiry no. E3823000

Please refer General terms and conditions of enquiry form no. BP 200102A. If any deviations, please mention in your quotation otherwise it shall be taken that all terms and conditions are accepted by you.

1. Please quote your best rate through your DSC (Digital Signature Certificate) in our E-Tender system through <https://eprocurebhel.co.in/nicgep/app> on or before due date. Paper bid to be not accepted in E-Tender.
2. **Pre-qualification criteria (PQC): -**
 - (i) Bidders may be either Manufacturers or authorized Dealer / Agent etc. If the bidder is not Manufacturer, then he has to submit the valid Authorization Dealer / Agent certificate directly from Manufacturer.
 - (ii) Offers of those parties will be considered who or their Manufacturer has supplied "Gases" of minimum value ₹ 40,000.00 in last 5 years from the date of tender opening. Proof of supply (Invoice copy / Challan copy / Completion certificate etc.) to be submitted with technical offer.

Startups and Micro & Small Enterprises (Manufacturer of quoted item) are exempted for above clause 2 (ii) of submission of proof of supply of prior experience.

3. **Delivery Terms: -**

Delivery Terms should be **F O R Destination** on Door delivery basis at CRX, BHEL Bhopal. The same is mentioned in Part – A (Techno-commercial bid) of your offer otherwise it shall be taken FOR destination. Offers on **F O R Destination** on Door delivery basis at CRX, BHEL Bhopal will only be accepted, **if you quote Ex-Works, freight by BHEL or Ex-Works, freight prepaid your quotation will be commercially rejected.**

4. **Delivery Period: -**

Delivery indicated in tender / enquiry is tentative. Supplier have to supply the filled Hydrogen Gas cylinder in BHEL own Cylinder on returnable basis in part quantity as and when requirement basis within 10 days of intimation of BHEL Bhopal. BHEL will provide Minimum 25 empty cylinder to supplier in one trip and same cylinders will be supplied by supplier after filling of Hydrogen Gas.

BHEL reserves the rights to reject the offer of suppliers who does not accept delivery period as per above.

5. **Tender Fees: -**

Suppliers must submit tender document fees of ₹ 200/- (Two hundred only) through online only through following link as mentioned below: -

E-receipt must be submitted along with offer.

Without tender fees offer shall be rejected. MSE suppliers (Manufacturer of quoted item) are exempted from tender fees.

Procedure of submission of tender fees: -

- Step 1 - Click on "Proceed Direct to Bank Site for payment"
Step 2 - Tick on "I have read and accepted the terms and conditions stated above" and Click on "Proceed".
Step 3 - Select State of Corporate / Institution – "Madhya Pradesh".
Step 4 - Select Type of Corporate / Institution – "Industry".
Step 5 - Select Industry Name – "BHARAT HEAVYELECTRICALS LIMITED BHOPAL".
Step 6 - Select Payment Category – "Deposit of Tender Cost".
Step 7 - Filled required data and Submit.

6. **Test Certificate (TC) :-**

Supplier to furnish Test Certificate (TC) at the time of each supply. In case non-receipt of TC with any supply, the supply is liable for rejection. Hence, any deviation for TC requirement be given in your quotation otherwise it is presumed that TC will be furnished with the supply as required.

7. **Loading / Unloading of cylinder at BHEL premises: -**

Lifting of empty cylinder from BHEL premises and loading / unloading of empty cylinder during lifting of empty cylinder, will be done by supplier only. However unloading of filled cylinder at BHEL premises, during supply of filled cylinder, will be done by BHEL.

8. **Bank Guarantee (BG)**

- BG (in lieu of SECURITY DEPOSIT) of ₹ 1.00 Lacs will have to be furnished after Purchase Order (PO) placement.
- BG will be issued on any BHEL consortium bank will be furnished along with PO.
- Initially, BG will be valid for one year from the date of PO. As supply is tentative, depending on requirement and if the supply is not completed in 1 year, BG is to be extended up to firm / tentative date of last supply of PO.
- BG will be returned after successful completion of PO.
- Format of BG and list of BHEL consortium bank will be furnished along with PO.

9. **Cylinder Repair & Maintenance Charges: -**

Cylinder repair & maintenance charges (if necessary), if found damage in BHEL premises, must be mentioned in your techno-commercial offer. Preferably following charges: -

- (1) Cylinder valve charges - per valve.
- (2) Cylinder cap charges – per cap.
- (3) Cylinder cleaning and painting charges - per cylinder
- (4) Cylinder valve gland nut charges – per valve.
- (5) Cylinder valve spindle charges – per spindle.
- (6) Hydraulic testing charges of cylinder – per cylinder

10. **Un-registered suppliers of BHEL, Bhopal :-**

Suppliers who are not yet registered with BHEL, Bhopal must submit following documents for temporary registration with BHEL, Bhopal along with Part – A (Techno-commercial bid) of your offer: -

- (1) Copy of PAN no.
- (2) Copy of GSTIN No.

RTGS/EFT details as per BHEL format must be submitted immediately after placement of order who have yet not submitted to BHEL, Bhopal. Format of RTSG / EFT detail can be obtained from us or downloaded from link <https://bpl.bhel.com/mm/>

11. Advance payment and Overdue interest (ODI) is not acceptable to BHEL in any circumstances.
12. Payment will be processed only after reflection of the invoice in GSTR 2A/2B.
13. Compressed Argon Gas should be supplied in BHEL own cylinder on returnable basis
14. **All the above points must be explicitly confirmed in the “Techno-Commercial Bid” of offer. If any point not confirmed in “Techno-Commercial Bid” of your offer, it shall be taken that it is acceptable to you. In case of non-acceptance above points and General terms and conditions of enquiry form no. BP 200102A / fail to submit sample / documents as per our tender / specification requirement, your offer may be rejected.**

Note: - MSE suppliers can avail the MSE benefit only if they are manufacturer of quoted item (s) and submit valid MSE certificate (NSIC/Udyam etc.) along with the offer.
