- 3.1 Cable laying work will be done as per instructions given by In-charge, DTG. It includes transportation of cable drums from store to work place, laying of cable in a buried cable trench sized 200X400mm deep duly covered with bricks and re-filling with excavated earth and finish up to the existing ground level in all respect. Overhead/underground laying will be done either through conduit pipe or simple wiring as instructed by In-charge.
- 3.2 Cable, conduit pipe, clamps, nails, etc. will be issued to the contractor free of cost from DTG store.
- 3.3 After cable laying the empty cable drums or remaining cable in drums should be handed-over in DTG store.
