Special Terms & Conditions

- Contractor/Operator will have to fulfill all legal obligations regarding Pollution Norms, Motor Vehicle Act (Amendment) - 2019, GST etc. as may be applicable to him. The vehicles should have valid taxi permit issued by R.T.O. The vehicle must be comprehensively insured for driver, passengers & the third party for the period of the contract.
- 2. The contractor has to abide by all laws, rules & regulations of Government, applicable to this type of work. Ignorance of the same does not entitle him to any concessions or claims.
- 3. The vehicle(s) may be required to go outside Jhansi. Permit charges/Toll tax of other States shall be reimbursed against documentary proof.
- 4. The Vehicle should have to be properly maintained as per RTO norms, dust proof and in good running condition,
- 5. Monthly Bills will have to be submitted to Transport Pool. Certified bill will be routed for payment to CPR department & CPR will make appropriate necessary corrections (if required) before forwarding the bills for payment to finance dept.

Air Condition, Fasting shall remain functional all the time and any breakdown shall be attended immediately without any delay otherwise penalty as above shall be imposed.

- 7. All minor repairs such as puncture, car perfume, providing seat towels and washing charges for seat towels shall be in the scope of BHEL.
- 8. All other repair works apart from clause no.7(above) works shall be in the scope of the supplier and shall be attended as and when required without any delay. 
