- a) The scope covers providing required number of pumps and related accessories with manpower to make pumps operational for following works :

- b) Pumps can be deployed at Day shift or night shift or both as per requirement of BHEL. - c. 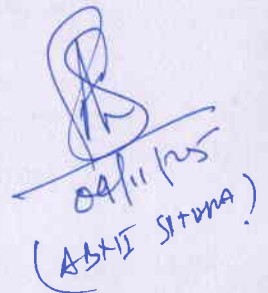
