SPECIAL TERMS & CONDITIONS OF CONTRACT

Tenders are invited for Hiring of one Ambulance: Tata Winger/Force Traveler /Maxi Van/Maruti Eeco or equivalent high roof model, “**2017 MODEL or Later (driven under 75,000 kms)**”, AC with Heater.

01. Minimum fix payment for running of 1200 KM per month shall be ensured (including AC and non AC operation). However if the minimum fix payment exceeds because of operation, the same shall be paid. The assured minimum KM are subjected to monthly running of the Ambulance, otherwise minimum assured KM will be given on prorata basis. This condition is however subjected to satisfactory fulfillment of all other terms & conditions. The billing period will begin from the 1st day of a calendar month.
02. **Penalty/ LD** : In case of breakdown of the ambulance on any day, another ambulance will have to be provided immediately. In case of failure to provide another ambulance, a penalty @ Rs.1000/- per day will be imposed and at the same time cost of hiring the alternate ambulance will be charged to the contractor's account. This will be allowed only for maximum 15 days in a year, after which management reserves the right to terminate the contract.

In case of Ambulance absent for reporting for duty a penalty of Rs. 1000/- will be imposed.

Ambulance should have cleaned & ironed white seat covers. In case of failure to do so, BHEL will get the same prepared and deduct the amount from the bills apart from recovering a penalty of Rs.100/-.

If the contractor is not able to provide the ambulance originally offered for a continuous period of 10 days without prior intimation and acceptance, BHEL reserve the right to terminate the contract and to take appropriate action against the contractor.

03. **Security Deposit (SD):** Security deposit shall be 5% of contract value will be collected from the successful bidder **before start of the work** in the form of either EFT or Bank Guarantee. The S.D will be refunded to the contractor after satisfactory completion of the work and on production of no dues certificate. In case of non-satisfactory performance of the contract, BHEL shall have a right to cancel the contract & forfeiting the security deposit.
04. **Diesel Price Variation Clause:**
- a. The rates agreed between BHEL and the contractor will remain firm during the period of contract. However, for every Re1.00 (Re one) increase/decrease in diesel rate, PVC of Re 0.07 increase / decrease per KM will be payable. The retail price of diesel as on the date of opening of this enquiry available at <https://www.mypetrolprice.com/260/Diesel-price-in-Jhansi> for Jhansi region shall be considered for calculation of PVC. This increase / decrease will be done on monthly basis. Bidder to enclose screenshot of applicable diesel rate from <https://www.mypetrolprice.com/260/Diesel-price-in-Jhansi> with the bill.
 - b. The retail Sale Price of diesel existing of 1st of each month shall be applicable throughout the month. The rates shall be declared for the whole month. Diesel price on 1st of calendar month (1st Feb, 1st Mar., 1st Apr. etc.) will remain same up to end of current month (1st Feb. to 28th Feb, 1st Mar. to 31 Mar. etc.).
05. **Payment Terms:** Payment shall be made within 30 days after submission of cleared bill in all respect after deduction of statutory tax and duty if any. The bill will be submitted to executing department i.e. Hospital & hospital will make appropriate necessary corrections (if required) before forwarding the bills for payment to finance dept.
06. **Measurement of work:** Bills will have to be submitted along with a copy of logbook to BHEL Hospital Jhansi duly certified by user department.
07. Successful bidder will pay the Stamp Duty on Security Deposit as per Government rules.
08. For Ambulance the ordering / contract will be finalized on lowest technically qualified bidders only. The bidders quoting the lowest price shall be considered for ordering subject to price reasonability & techno-commercial suitability. In case of Tie in rate, L1 shall be finalized by draw & same shall be accepted to all parties.

09. The driver of the Ambulance should be well behaved and courteous with the patient and their attendant / family members / relatives. He should display restraint and wisdom in dealing with excited passengers. In case of misbehavior by the driver, a suitable penalty can be imposed for each occasion. In case there are multiple repetitions with a particular driver, he will have to be changed. The drivers should have valid LMV license during the contract.
10. The bidder will have to provide two pairs of uniform to each driver and one pair of black shoes. The shirt should have a label showing the name of the Firm on the left and a name plate pinned on the right side of the shirt showing the name of the driver. The driver will have to be provided with a mobile phone. He will keep the mobile phone charged and in fully operative condition.
11. The contact person mentioned in Part-‘A’ of this bid will have to meet the Hospital Incharge / hospital administration at least once every fortnight for obtaining feedback about the operation of the ambulance. The instructions issued by the Hospital Incharge / hospital administration will be noted down by the contact person in Two Copies, one each for the contractor and BHEL. Similarly, the contact person will meet the Hospital Incharge / hospital administration once every alternate month and discuss the issues for smooth running of the contract.
12. In case the vehicle goes out of U.P. State on BHEL duty, the service provider has to obtain road permit for the same. Expenditure incurred on this account shall be reimbursed along with the payment of bill on documentary proof.
13. The Ambulance will have to be maintained by the contractor in good running condition which includes at least the following:
 - i. Minimum noise of engine and body while running;
 - ii. Tyres with proper treads;
 - iii. Inflated Stepony; Working headlights, tail lamps, indicators, speedometer, milometer, temperature indicator etc; Proper paint on the outside; Good condition of bumpers;
 - iv. Upholstery in good condition including washed and ironed white seat covers;
 - v. Proper locking of all doors;
 - vi. Proper closing and opening of all windows;
 - vii. Dusting of dashboard, rear board, matting, windscreen, windows and body.
14. During out station trips, cash for fuel/driver's personal expenditure, other State permit charges etc. will have to be provided in advance by contractor

15. The contractor has to ensure that filling of the fuel in the vehicle is done from the petrol pump situated near BHEL. Otherwise the Kilometer covered by the vehicles for fuel filling will be in the account of contractor.
16. No unauthorized person should be allowed to travel in the Ambulance when on BHEL official duty. Failure to comply with this provision can result in non-payment of the trip.
17. The Contractor has to make an agreement with BHEL in the format prescribed only on Rs. 100/- Non-Judicial Stamp Paper.
18. The Contractor shall get the character & antecedents of his own drivers verified from District Magistrate's office and intimate the same to the management. Before deploying them to work.
19. The vehicle used for ambulance service should be : Tata Winger/Force Traveler /Maxi Van/Maruti Eeco or equivalent high roof model, **"2017 MODEL or Later (driven under 75,000 kms)"**, AC with Heater. The vehicles should be registered in the name of bidder only. The Ambulance shall be operated by Diesel only. The contractor should pay necessary taxes and other insurance payment and carry out exhaust emission test (once in six month). All the connected documents should be kept alive during the contract period.
20. The fuel tank should be always kept full and at any point of time, the level should not be less than 50% of tank capacity.
21. BHEL official shall carry out inspection of Ambulance offered and their decision regarding acceptance and rejection is final.
22. 24 hours availability of the ambulance should be ensured in BHEL, hospital controlled by Hospital staff to attend emergency cases at any time. The ambulance shall be deployed at BHEL, Hospital. The ambulance should work on all Sundays, all local and National holidays, i.e. it should work throughout the year without any break.
23. Drivers each shifts should be operated in 24 hours continuous service with mobile phone facility to contact in emergency and the normal shift timing will be 0800hrs. to 1600hrs, 1600hrs. to 0000hrs., and 0000hrs. to 0800hrs. Shift timing can be changed as per requirement of
