### STANDARD TECHNICAL SPECIFICATION

#### 2.1 TECHNICAL SPECIFICATION OF DC EARTHING SWITCH

The 4 Poles DC Earthing Switch shall be designed to earth DC link capacitors of the Traction system. The DC Earthing Switch has a Control lever aimed at controlling the move of breaking Knife from One end position (Operation) to other end position (Ground). The Control lever is blocked mechanically in a groove. By pulling out from the groove, the Control lever turns anti-clockwise thus making ground connection.

The DC Earthing switch shall be of proven design suitable for transportation application in Indian environmental conditions as attached in Section 3.3 of this specification.
