SCOPE OF WORK AND GENERAL TERMS & CONDITIONS:-

- 1. The scope of work involves ferrying BHEL-ESD employees from various parts of Bangalore to BHEL-ESD factory, located at Plot no. 98 at Electronics City, Phase 1, Hosur Road, Bangalore, Pin code 560100; and from factory back to respective Pick up/ drop points in different routes.
- 2. In case we need any additional vehicle, the same should be provided on the same terms and conditions. The total number of vehicles may be decreased or increased based, on our requirements by giving One Month's prior intimation to the vendor.
- 3. The vehicles are required to report at the <u>designated place of first pick-up point</u> of Each Route <u>fifteen minutes before the Trip commencement time</u>.
- 4. The present factory timings are from 07.30 Hours to 16.36 Hours (Monday to Friday) and 07.30 Hours to 12.30 Hours (On Saturday). Arrival Time at BHEL ESD in morning & Departure Timings from BHEL ESD in Afternoon/ Evening are as follows:

a) Monday to Friday

Arrival: The vehicle MUST arrive at BHEL ESD at 7.25 AM in the morning EVERY DAY Departure: The Vehicles leave from BHEL ESD Gate at 16.45 hours in the evening

b) Saturdays

Arrival: The vehicle MUST arrive at BHEL ESD at 7.25 AM in the morning EVERY DAY Departure: The Vehicle leave from BHEL ESD Gate at 12.40 hours in the evening

In case of any change in timings, the same will be informed to the vendor within SEVEN DAYS notice/ Or ONE DAY in case of Sudden Emergency instances.

- 5. The Pick-up and Drop points are subject to change based on our requirement. BHEL-ESD reserves the right of changing the routes of the various vehicles
- 6. ONE Number of Tempo Traveller with Driver will be retained at ESD for official use for local trips after the morning trip to factory, within the daily working time of BHEL-ESD. Other vehicles may leave the premises and report back by 3.30 PM (1530 Hours) on Weekdays (Monday to Friday) and by 11.30 AM on Saturdays, for the afternoon/ Return trip. Choice of which Route vehicle is to be retained will be the discretion

of BHEL-ESD. The Vehicle that is to be RETAINED for Additional Trips – SHOULD NOT leave ESD premises, without authorized permission from BHEL-ESD HR.

- 7. The company reserves the right to use the vehicle at its discretion. Denial of performing any trip, would be viewed seriously and attracts penalty <u>as per clause- 13</u> irrespective of the reasons.
- 8. All the vehicles provided must be of year 2017 model or later.
- 9. Drivers will strictly adhere to instruction and directions issued by BHEL when the vehicles are on duty and at our command. Strict discipline shall be ensured by contractor. The contractor shall be responsible for behavior of his driver at company premises.
- 10. Contractor shall be responsible for ensuring coverage of Drivers for all statutory regulations including personal accident insurance etc. BHEL shall not be responsible for any consequences arising on account of any violation of any statutory provisions, rules and regulations by the service provider.
- 11. Name & contact details of your Staff/Representatives (**Mobile, Landline** & E mail), to be contacted, during any exigencies or for clarification, have to be furnished to BHEL.
- 12. In case of any breakdown of running vehicle, alternate arrangement should be made within half-an-hour to fulfill the contractual terms.
- 13 Failure to make alternate arrangements will result on levying of Penalty as under:
 - a. If the vehicle has not reported at first Pick-Up Point [Breakdown before reaching FIRST PICCKUP point] and reaches the factory as required, the penalty is 50% of the daily Slab rate.
 - b. If the vehicle is NOT available at our disposal for half-a-day and less i.e. half of the specified slab hours & less [tolerance of 15 minutes] the penalty is 75% of the daily Slab rate.
 - c. If the above failure [half-a-day] occurs more than once in a calendar month then the penalty will be 25% of the daily Slab rate in addition to the above penalty, for the second and subsequent failures.
 - d. If the vehicle is not available at our disposal for more than half of slab hours it will be treated as full day and the penalty is 125% of the daily rate, if the above failure [full day] occurs more than once in a calendar month then penalty will be 50% of the daily slab rate in addition to the above penalty for the second and subsequent failures.
 - e. If the vehicle is not available after doing part of work during first or second half and no alternate arrangement is made within half-an-hour then penalty will be as per "b" & "c".
 - f. If the vehicle is available at ESD premises, but without Driver, it will attract all the above said penalty ["b" to "e"].

14. Pre-Qualification CRITERIA for qualifying in the techno commercial bid:

a. The Contractor should be registered as per rules under relevant law for this activity (Copy of valid registration certificate to be enclosed) with an established office, having Landline Phone Numbers/ Mobile Numbers & E mailing facility).

- b. The Contractor must submit copy of GST Registration Certificate
- **c.** Average annual financial turnover during the last three years ending 31st March of 2020, should be **approx. Rs.24 lakhs**/- [30% of estimated value].
- **d. Experience:** The Contractor must have the experience of having successfully completed/executed contract/s of providing Tempo/Force Traveller (TT) and Buses or similar vehicle on hire basis [contracts] during the last seven years ending 31st March 2021, as under:
 - i) 3 completed contract works of providing TTs/Buses on hire basis of value not less than 40% of our estimated value i.e. **Rs.31 lakhs/-.**

OR

ii) 2 completed contract works of providing TTs on hire basis of value not less than the 50% of our estimated value i.e. approx. **Rs. 39 lakhs/-.**

- iii) 1 completed contract work of providing TTs on hire basis of value not less than the 80% of our estimated value i.e. **Rs. 62 lakhs/-.**
- **e. Certificates:** Copy of completion/performance certificates indicating the value of the work or copy of the Work Order/Purchase Order, along with the satisfactory completion/performance certificates of service from previous employers should be submitted. (Services provided to other BHEL Units, their performance will be taken into account while evaluating their technical capability).

If any Contractor is not fulfilling any of the conditions given above from (14-a) to (14-e), the offer will be summarily rejected.

- 15. The Rates quoted **MUST** be inclusive of charges towards fuel, wages, all statutory permits, Insurance, maintenance of vehicle, statutory payments/ Road/ RTO taxes (excluding applicable GST) PLUS any additional charges/ discounts owing to the Price Variation Clause (depending on increase/decrease of fuel prices, during the contract period). Applicable GST should be quoted separately.
- 16. **PRICE VARIATION CLAUSE (PVC):**
- (i) The rates finalized will be firm during the contract period.
- (ii) In case of change in fuel prices, a change in the rate will be allowed subject to documentary evidence, regarding such change
- (ii) Revised Rates as per PVC will be effective ONLY from 1st day of subsequent month. For e.g. if average Fuel price change has happened during the month of August 2021, then the Revised Rates as per PVC (based on the latest fuel rate) will be given effect from 1st September 2021 only).
- (iv) The basis of calculation for PVC Clause will be the fuel price at the time of opening of Technical bid.
- (v) The fuel price variation clause will be applicable for extra running Kilometers too.
- (vi) Price variation clause will be applicable only when there is increase/decrease in fuel price (regular diesel price) per Litre to the tune of one rupee or more compared to previously considered rate.

- 17. Trip sheet should be maintained by properly recording time, kilometers on daily basis and obtain the signature from authorized person (identified/nominated by us) of that particular route.
- 18. Bill for payment shall be submitted once in a month along with the trip sheets and Two sets of Invoice which will be settled in about 30 days period.
- 19. SLAB of EACH Vehicle (Bus or TT) will be in terms of ACTUAL DISTANCE in Kms, calculation for the billing will be from <u>FIRST PICKUP POINT to BHEL-ESD</u> and from <u>BHEL-ESD to LAST DROP point</u>.
- **20.** Billing for extra Kms (Additional Kilometers over and beyond that vehicle's SLAB) would be accounted for <u>on Monthly basis over and above that Vehicle's MONTHLY</u> COMBINED SLAB.

For Example,

If a vehicle is on 90 KMs Slab and

Vehicle is utilized for Extra Distance of 40 Kms & 50 Kms on different days that month Number of working days in that month being 25

...Then calculation of Extra KMs would be done that month as below:

- 21. All valid records/documents like RC Book, Vehicle permit, Insurance, Driving License of Drivers, Emission certificate etc., should be produced whenever required by us for verification. Vehicles should be in good plying condition and all statutory requirements of RTO, etc., should be complied with.
- 22. The company reserves the right to terminate the contract if the performance is not satisfactory. Either party can also give a notice of one month to terminate this contract during the currency of the contract period.
- 23. Earnest Money Deposit

The tenderer shall submit Earnest Money Deposit as prescribed above. EMD shall not carry any interest. EMD by the Tenderer will be forfeited if:

- i. After opening the tender, the tenderer revokes his tender within the validity period or increases his earlier quoted rates.
- ii. The successful tenderer does not commence the work within the period as per LOI / Contract. In case the LOI / contract is silent in this regard, then within 15 days after award of contract.
- iii. EMD given by all unsuccessful tenderers shall be refunded normally within fifteen days of acceptance of award of work by the successful tenderer.

Security Deposit

On award of the contract, the successful tenderer should furnish **5** % of the contract value as Security Deposit to BHEL before start of the contract.

Security Deposit may be furnished in any one of the following forms:

- i) Only NEFT (as permissible under the Income Tax Act.
- ii) Pay Order, Demand Draft/ Electronic Fund Transfer in favour of BHEL
- iii) Securities available from Post Offices such as National Savings Certificates, Kisan Vikas Patras etc. (Certificates should be held in the name of Contractor furnishing the security and duly pledged in favour of BHEL and discharged on the back).
- iv) Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL.
- v) Fixed Deposit Receipt issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. (FDR should be in the name of the contractor, A/C BHEL).
- vi) Securities available from Indian Post offices such as National Savings Certificates, Kisan Vikas Patras etc. (held in the name of Contractor furnishing the security and duly endorsed/ hypothecated/ pledged, as applicable, in favour of BHEL)
- vii) Security deposit can also be recovered at the rate of 10% from the running bills. However in such cases at least 50% of the Security Deposit should be collected before start of the work and the balance 50% may be recovered from the running bills.
- viii) EMD of the successful tenderer can be converted/ adjusted against the security deposit.
- ix) The security deposit shall not carry any interest.

(Note: Acceptance of Security Deposit against SI. No. (iv) and (vi) above will be subject to hypothecation or endorsement on the documents in favor of BHEL. However, BHEL will not be liable or responsible in any manner for the collection of interest or renewal of the documents or in any other matter connected therewith). Security deposit shall be refunded to the contractor on successful completion of the contract.
