SCOPE & SPECIAL TERMS AND CONDITIONS OF THE CONTRACT

Following are the scope, special terms and conditions of the contract.

1.0) NAME OF THE WORK:

Supply of vehicle on hiring basis for used of BHEL MSTPP Project works.

2.0) SCOPE OF WORK:

Areas: As per Reporting instruction by the authorized Officer/Engineer of BHEL to report the vehicle at Project Site, Khulna City, Jessore Airport, Bhomra Border, Benapole Border or any other location.

Job Details: As per details given below: -

- a) Providing different types of Vehicle on Monthly Hire Basis, Daily Basis or only pick up and drop from fixed places, as per the requirement of BHEL.
- b) Providing different vehicles to pick and drop to prominent location like land border, Jessore Airport, etc.
- c) All the vehicles deployed must have air-conditioning system installed and vehicles must always be in good condition.
- 3.0) Immediate requirement of the Vehicles to be deployed on monthly basis w.e.f 01.01.2023, are given in Annexure III. Other vehicles will be ordered from time to time as per the requirement, during the validity of the contract period and the price shall remain valid for 07 months for the L1 bidder against each vehicle.
- 4.0) L1 against each type of vehicle will be decided separately.
- 5.0) Bidder should ensure that they will be able to provide vehicle on Daily or Pick up Drop basis in a short notice of 12 hours and monthly basis in a notice of 3 days and in case of failure for 3 times their contract will be liable to terminate without any notice and vehicle arranged by BHEL shall be recovered from their pending bill with 30% overhead.
- 6.0) It is not mandatory to provide price for all the vehicle as per qty. mentioned in Vol–III. Bidder should quote the price for any type of vehicle meeting the full quantity of that particular type of vehicle, which they will be able to provide
- 7.0) Fuel charges shall be reimbursed or paid at per prevailing market rates of fuels.
- 8.0) Fuel charges shall be fixed @ Km mileage / per litre for different category of vehicles as detailed below:

9.0) Mileage for the above schedule has been fixed, considering vehicle running in air conditioner during the summer period and heater running during the winter period, at all times, whenever used. Hence, vehicle must run on Air-conditioner / Heaters, at all times. If at any time, air conditioner is found or reported to be faulty or not functioning, a fine/penalty of an amount of BDT. 200.00 /- per day shall be imposed, till the air-conditioner is repaired or replaced in working condition.

- 10.0) For vehicles hired on monthy hire basis with overtime, overtime rate shall be @ BDT. 40.00 /- (Forty) per hour beyond 10 hours normal duty.
- 11.0) The contractor shall comply with all statutory rules, regulations etc. as applicable.
- 12.0) The contractor shall pay all taxes fees, license charges deposit duties, royalty commissions or other charges which may be levied on account of his operation in executing the contract to the concerned authorities. In case BHEL is forced to pay any of such taxes / charges, BHEL shall have the right to recover the same from the contractor either from his bill or otherwise as deemed fit.
- **13.0)** The contractor shall be responsible for the proper behavior of the drivers at the place of work and observance of all regulations by the staff employed by him.
- **14.0)** The contractor shall ensure that no damage is caused to any person, property of other parties working at the place of work. If any such damage is caused, it is the responsibility of the contractor to make good the losses or to compensate for the same.
- 15.0) All safety rules and codes applied by BHEL at the place of work shall be observed by the contractor without exception. The contractor shall be responsible for the safety of the cars / vehicles and work to be performed by him and shall maintain all protection necessary for the purpose. The contractor shall also take precaution as may be indicated from time to time by BHEL with a view to prevent pilferage, accidents, fire hazard/hijack of car, vehicle, driver etc and due precaution shall be taken against fore seen or unseen hazards and atmospheric conditions.
- **16.0)** The contractor shall be responsible to arrange Gate Pass of vehicle and driver and its timely renewal.
- 17.0) The contractor shall be directly responsible for payment of wages to his workmen/driver/s by 7th of the following month. If there is any delay in submission & settlement of bill due to any reason whatsoever, payment must not be delayed beyond 7th.
- **18.0)** The bidder must have his own /telephone and mobile facilities so that he can be contacted as and when necessary.
- 19.0) The drivers must be provided with a working mobile phone. If the owner fails to provide mobile phone a sum of BDT. 500/- will be deducted from the monthly bill. If the driver keeps the mobile switched off or does not attend call a penal charge @ BDT 500 per day will be recovered.
- **20.0)** The bidder shall maintain our logbook for recording relevant details and must be in possession of valid driving license of commercial cars as well as be able to do minor repairs of cars and attend to break downs. Also, he should have experience in driving on highways.
- 21.0) Driver's of car (s) must be smart, neatly dressed with the uniforms and shoes to be provided by the contractor at his own cost. The driver provided by the contractor, of the said car(s) should not be engaged for any other job during the tenancy of this contract.
- **22.0)** Car parking fees for official duties will be reimbursed on monthly basis on production of valid parking slips / vouchers and certified by concerned authority.

- Total car maintenance of whatever nature, repair charges and other expenses towards 23.0) consumables like Mobil/gear oil etc. in respect of the cars are to be fully incurred and borne by the contractor.
