13. Indigenous bidders have to quote freight charges in percentage of their quoted Total ex-works prices.
14. Bidders must submit Un-Priced offer in BHEL Price format duly filled mentioning the word "Quoted" in place of actual price given in price bid.
15. Fan Foundation shall be supported on vibration isolation system consisting of steel helical springs and viscous dampers.
16. The vendor shall guarantee the performance of steel helical spring and viscous dampers for 24 months from the date of commissioning of each machine which shall be termed as "Guarantee Period".
17. BHEL reserves the right to finalize Prices by conducting Reverse Auction or by conventional way of price bid opening (Refer Clause No. 13.0 of Instruction to Bidder, Volume-I, GCC Rev. 06). This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Non-submission of 'online sealed bid' by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue."



- a) **Approval of bidder by the BHEL.**

Same shall be taken up by BHEL with customer based on the credentials/reference list. Hence Bidders are requested to submit the following (as part of their credentials) on or before technical bid Part-I opening:-

 - Bidders are requested to fill up their details in NTPC format for Main & Sub – Supplier Questionnaire attached with enquiry.
21. **Indigenous bidders to indicate their import content (CIF) in their price bid. No ceiling limit for CIF consumption is being put at the time of enquiry. However the same will be reviewed during evaluation of offers and bidders will be informed accordingly.**
22. The evaluation of the offer shall be done based on **overall FOR site price basis.**
