For Supervision of E & C: - Supervision of Erection & Commissioning shall be as per site requirement. However, vendors will be given one month advance intimation to report at project site.

17. BHEL reserves the right to finalize Prices by conducting RA or by conventional way of price bid opening, which will be decided after techno-commercial evaluation (refer Clause No. 13.0 of Volume-I, GCC Rev. 06). 18. **Bidders to note that BFP foundation shall be supported on vibration isolation system consisting of steel helical springs and viscous dampers.**
19. **Bidders to guarantee the performance of steel helical spring and viscous dampers for 24 months from the date of commissioning of each machine which shall be termed as "Guarantee Period".**
