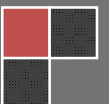

7.0 Deviation with respect to tender clauses and additional clauses/suggestions in Techno-commercial bid / Price bid shall NOT be considered by BHEL. Bidders are requested to positively comply with the same.

8.0 BHEL reserves the right to accept or reject any or all Offers without assigning any reasons thereof. BHEL also reserves the right to cancel the Tender wholly or partly without assigning any reason thereof. Also BHEL shall not entertain any correspondence from bidders in this matter (except for the refund of EMD).

9.0 Assessment of Capacity of Bidders:
Bidders capacity for executing the job under tender shall be assessed 'LOAD' wise and 'PERFORMANCE' wise as per the following:

- I. **LOAD**: Load takes into consideration **ALL** the contracts of the Bidder under execution with BHEL Regions, irrespective of whether they are similar to the tendered scope or not. The 'Load' is the sum of the unit wise identified packages (refer Table-1) for contracts with BHEL Regions. The cut off month for reckoning 'Load' shall be the month, two (2) months preceding the month corresponding to the 'latest date of bid submission', in the following manner:

(Note: For example if latest bid submission is in Aug 2011, then the 'load' shall be calculated upto and inclusive of June 2011)

- i). **Total number of Packages**

Total number of Packages in hand = P
Where

- P is the sum of all unit wise identified packages under execution with BHEL Regions as of the cut off month defined above, including packages yet to be commenced.

- ii) **Weightage "A" assigned to bidders based on Total number of Packages 'P':**

- a) If 'P' = 0-9, : "A" will be equal to '4'
- b) If 'P' = 10-18, : "A" will be equal to '3'
- c) If 'P' = 19-36, : "A" will be equal to '2'
- d) If 'P' = 37-60, : "A" will be equal to '1'
- e) If 'P' is above 60 : "A" will be equal to '0'

- II. **PERFORMANCE**: Here 'Monthly Performance' of the bidder for all the packages (**under execution/** executed during the 'Period of Assessment' in all the Power Sector Regions of BHEL) **SIMILAR** to the packages covered under the tendered scope, excepting packages not commenced shall be taken into consideration. The 'Period of Assessment' shall be 6 months preceding the cut off month. The cut off

- i). Calculation of Overall 'Performance Rating' for 'similar Package/Packages' for the tendered scope under execution at Power Sector Regions:
This shall be obtained by summing up the 'Monthly Performance Evaluation' scores obtained by the bidder in all Regions for all the similar Package/packages', divided by the total number of Package months for which evaluation should have been done, as per procedure below:
- a) $P_1, P_2, P_3, P_4, P_5, \dots P_N$ etc be the packages (**under execution/** executed during the 'Period of Assessment' in all Regions) **SIMILAR** to the packages covered under the tendered scope, excepting packages not commenced. Total number of similar packages for all Regions = P_T (ie $P_T = P_1 + P_2 + P_3 + P_4 + \dots P_N$)
 - b) Number of Months ' T_1 ' for which 'Monthly Performance Evaluation' as per relevant formats, should have been done in the 'Period of Assessment' for the corresponding similar package P_1 . Similarly T_2 for package P_2, T_3 for package P_3 , etc for the tendered scope. Now calculate cumulative total months ' T_T ' for total similar Packages ' P_T ' for all Regions (i.e $T_T = T_1 + T_2 + T_3 + T_4 + \dots T_N$)
 - c) Sum ' S_1 ' of 'Monthly Performance Evaluation' Scores ($S_{1-1}, S_{1-2}, S_{1-3}, S_{1-4}, S_{1-5}, \dots S_{1-N}$) for similar package P_1 , for the 'period of assessment' ' T_1 ' (i.e $S_1 = S_{1-1} + S_{1-2} + S_{1-3} + S_{1-4} + S_{1-5} + \dots S_{1-N}$). Similarly S_2 for package P_2 for period T_2 , S_3 for package P_3 for period T_3 , etc for the tendered scope for all Regions. ii) Weightage “B” assigned to bidders based on Overall Performance Rating (R_{BHEL}) at Power Sector Regions, for the respective Package:

- a) If $R_{BHEL} \geq 80\%$, “B” will be equal to ‘6’
- b) If $R_{BHEL} \geq 75\% < 80\%$, “B” will be equal to ‘5’
- c) If $R_{BHEL} \geq 70\% < 75\%$, “B” will be equal to ‘4’
- d) If $R_{BHEL} \geq 65\% < 70\%$, “B” will be equal to ‘3’
- e) If $R_{BHEL} \geq 60\% < 65\%$, “B” will be equal to ‘2’
- f) If $R_{BHEL} < 60\%$, “B” will be equal to ‘0’

III. ‘Assessment of Capacity of Bidder’ to be Qualified for the tender:

Shall be based on the sum of the weightages obtained in ‘LOAD’ (A) and ‘PERFORMANCE’ (B) as below:

- a) If the sum (A+B) is 6 or above for each of the applicable Package, then the Bidder is considered ‘Qualified’ for the tender
- b) If the sum (A+B) is less than 6 for any of the applicable Package, then the Bidder is considered ‘NOT Qualified’ for the tender

IV. Explanatory note:

- a) Similar package means Boiler or ESP or Piping or Turbine or Civil or Structure or Electrical or CI, etc at the individual level irrespective of rating of Plant, and irrespective of whether the subject tender is a single package or as part of combined/composite packages. Normally Boiler, ESP, Piping, Turbine, Electrical, CI, Civil, Structure, etc is considered individual level of package. For example in case the tendered scope is a Boiler Vertical Package comprising of Boiler, ESP and Power Cycle Piping (i.e the ‘identified packages as per Table-1 below), the ‘PERFORMANCE’ part against sl no II above, needs to be evaluated considering all the identified packages (ie Boiler, ESP and Power Cycle Piping) and finally the Bidder’s capacity to execute the tendered scope is assessed in line with III above

- c) Vendors who are first timers to any BHEL Region, may be considered subject to satisfying other tender conditions. Eligibility of the party for the next tender of any package in that Region, shall be subject to the bidder satisfying the 'Assessment of Capacity of Bidder' for a period of first **nine months** after commencement of work or contract duration whatever is lesser.

In case the first timer is executing any other packages in any BHEL Region, then the performance evaluation will be based on the data available for the other packages though not similar, for the 'Period of assessment', for the purpose of 'Assessment of Capacity of Bidder'

2.0 SCOPE OF WORK

2.0.1 PART A: RENOVATION WORKS

The scope of work comprises of but not limited to the following: -

- a) Renovation/Repairs of damaged Closed Storage shed (60m x 15m) – 1 No. comprising of Brick masonry works and AC sheeted roof with tubular truss& purlins.
- b) Renovation/Repairs of damaged Semi closed Storage shed (60m x 15m) – 3 Nos. comprising of structural columns, side runners, tubular truss& purlins, AC sheeted roof.

2.0.2 PART B: LEFT OVER WORKS (by previous agency)

2.2 Responsibility of the Contractor

2.2.1

The contractor shall engage all the unskilled, skilled and especially skilled labor including fabricators, welders and fitters etc. and supervisory staff. Only trained and competent personnel with previous experience in the job shall be employed. However, BHEL reserves the right to decide on the suitability of the workers and other personnel who will be employed by the contractor. BHEL reserves the right to insist on removal of any employee of the contractor at any time, if they found him unsuitable. The contractor shall be bound to follow the instruction of BHEL.

2.2.2

All the materials like steel, rolled shutters, trusses, structural members, foundation bolts, MS bars, painting materials, AC Sheets, MS square bar and necessary electric goods etc. whichever are to be supplied by the contractor shall be as per the specification mentioned in the tender/Indian standard specification. The contractor is required to quote their rates inclusive of cost of all materials, labor, etc. BHEL reserves the right to inspect and reject any material not found satisfactory.

2.3 General

2.3.1

During execution of the job, it is very essential that proper and adequate inspection should be made constantly by the contractor to maintain quality of workmanship and to ensure that deviations from BHEL drawings not exceed the permissible limits, which shall be approved by BHEL.

The work though not specifically mentioned either in the drawings or in the tender specification but are needed to complete the work as per site requirement & instruction of Engineer are also in the scope of this contract & to be erected to the entire satisfaction, for which the payment shall be released as per the respective item rate of **Rate Schedule**. **If the item is not available in the rate schedule the rate shall be derived as per CPWD- DSR-2012 rate schedule latest version with applicable escalation / cost index published by CPWD.**

2.3.6

The contractor shall provide and maintain at his own cost all T & P for carrying out the work. The T & P shall be for fabrication of the structures and for the purpose of erection of columns, trusses, purlins, bracings etc complete.

2.4

The tentative drawings and specifications will form part of the tender documents. BHEL reserves the right to modify/alter the tender drawings, if necessary during the actual execution at site.

2.4.1

Specification for Civil Works for renovation of storage sheds and left over works of internal electrification of storage sheds.

Standard specifications for various items of work for building construction as per the relevant IS-codes (latest edition) shall be applicable for this work. The work has to be executed as per standard specification and drawings to the satisfaction of BHEL. However, the following Drawings/Sketches are to be read along with specifications and shall be treated as in the scope of work. Please refer **Appendix – IX for drawings**.

2.4.2

These drawings are indicative and strictly for tendering purpose, only meant to give an idea to tenderers about nature of job. If any changes in the section, truss, columns etc. are felt necessary by BHEL Engineer to suit the site requirement, the same shall be done by contractor as per revised sketches/drawings given by BHEL engineer. Contractor shall ensure/ascertain the stability, safety of the said work. Any modification/variation from the said drawings, if necessary as suggested by the contractor will have to be approved by BHEL in writing.

2.5 Electrical Installations

2.5.1

The electrical installation shall generally be carried out in conformity with the requirements of the Indian Electricity Act, 1910 as amended up to date and the Indian electricity rules, 1956 framed there under and also the relevant regulations of the electric supply authority concerned as well as IS: 732-1963 (revised). **Before commencement of work Contractor has to submit for approval of BHEL detail electrical layout drawings prepared by experienced & licensed electrical agency/engineer indicating the cable route, internal/external panels, DBs, cable sizing, fittings & fixtures, Earthing etc. in line with the BOQ for all the store sheds.**

2.5.2

Good workmanship is an essential requirement for compliance with the rules in the code. The work shall be carried out under the direct supervision of a person holding a valid certificate of competency issued by the state government concerned for the type of work involved.

2.5.3

The distribution fuse boards shall be located as near as possible to the center of the load they are intended to control.

2.5.4

All main switches shall be of metal clad enclosed pattern, which shall be fixed at close proximity to the point of entry of supply.

2.5.5

Main and branch distribution boards shall be in accordance with Indian standard 732-1963 "code of practice for electrical wiring installation".

2.5.6

PVC conduit wiring system should be adopted throughout and all conduit pipes/channel shall be conforming to latest IS.

2.5.7

Approved and good quality copper wire with adequate current carrying capacity/voltage rating with proper insulation as per IS should be used for the entire electrical wiring/installation.

2.5.8

The service connection from outside mains to the switchboard inside the building shall also be carried out by the contractor.

2.6 Earthing

2.6.1

All earthing system shall be in accordance with IS: 3043-1966 "code of practice for earthing".

2.6.2

The installation and earthing shall generally be carried out in accordance with the Indian electricity rules 1956 as amended from time to time and the relevant regulations of the electricity supply authority concerned.

2.6.3

All plugs and sockets shall be of three-pin type, one of the pins being connected to earth.

2.6.4

Bodies of all electrical appliances shall be earthed by the use of three pin plugs. The covers of the regulators if of metallic construction shall be earthed by means of a separate earth wire. A separate earth wire shall be used for earthing these appliances.

2.6.5

All earth wires and earth continuity conductors shall be of copper/galvanized iron. They shall be either stranded or solid bars of flat rectangular strips and may be hard, provided, due care is taken to avoid corrosion and mechanical damage to it. Inter connections of earth continuity conductors and main and branch earth wires shall be made in such a way that reliable and good electrical connections are permanently ensured.

2.6.6

The neutral conductor shall not be used as earth wire.

2.6.7

Welded, bolted and clamped joints only are permissible. For stranded conductor, sleeve connectors are permissible. Bolted connectors and their screws shall be protected against any possible corrosion.

2.6.8

The path of the earth wire shall, as far as possible, be out of reach of any person and shall be visible for inspection.

2.6.9

The galvanized iron pipe electrodes shall not be smaller than 38mm internal diameter and shall not be less than 3.5M in length and shall, as far as possible, be embedded below permanent moisture level and shall be one piece only without any joints.

2.7 GENERAL NOTES FOR STEEL WORKS

2.7.1 STEEL/ IRON WORK

Rolling shutters (as per IS 6248):- All the rolling shutters as per standard specifications/IS code and drawings and as instructed by engineer-in-charge shall be supplied and fixed with all accessories and fittings for easy mechanical operation from inside and outside. The rolling shutters shall be manufactured with adequate thickness to avoid any damage/buckling due to heavy wind or storm.

Contractor shall arrange for shop inspection for all rolling shutters, trusses etc. if fabricated outside the plant before delivery at site for engineer's clearance.

2.8 PAINTING

All the steel items such as roof trusses, columns, purlins etc. shall be supplied with **one coat of red oxide primer, two coats of synthetic enamel paint of blue color** of approved color and quality shall be applied after fixing in position to achieve uniform finishing. Rates shall be quoted taking into account cost of painting for steel work.

6.1.1 INITIAL MOBILIZATION AND TENTATIVE SCHEDULE

Contractor shall reach site, make his site establishment and be ready to commence the work within two weeks from the date of fax Letter of Intent or as per directions of Construction Manager/ Project Manager of BHEL.

The contractor has to subsequently augment his resources in such a manner that the entire renovation works are completed within 4 (Four) months including electrification of all the sheds.

TAXES, DUTIES, LEVIES (ConsolidatedRev 00 dated 07/06/2012)

8.1 'Enabling Works'

The contractor shall pay all (save the specific exclusions as enumerated in this contract) taxes, fees, license charges, deposits, duties, tools, royalty, commissions or other charges which may be levied on the input goods & services consumed and output goods & services delivered in course of his operations in executing the contract. In case BHEL is forced to pay any of such taxes, BHEL shall have the right to recover the same from his bills or otherwise as deemed fit. (i.e. **rates quoted by bidder shall be inclusive of Service Tax, VAT/WCT and all other taxes and duties**)

8.2 New Taxes/Levies

In case the Government imposes any new levy/tax on the output service/ goods/work after award of the contract, the same shall be reimbursed by BHEL at actual.

In case any new tax/levy/duty etc. becomes applicable after the date of Bidder's offer, the Bidder/Contractor must convey its impact on his price duly substantiated by documentary evidence in support of the same **before opening of Price Bid**. Claim for any such impact after opening the Price Bid will not be considered by BHEL for reimbursement of tax or reassessment of offer.

No reimbursement/recovery on account of increase/reduction in the rate of taxes, levies, duties etc. on input goods/services/work shall be made. Such impact shall be taken care of by the Price Variation/Adjustment Clause (PVC) if any. In case PVC is not applicable for the contract, Bidder has to make his own assessment of the impact of future variation if any, in rates of taxes/duties/ levies etc. in his price bid.

8.3

BUILDING & OTHER CONSTRUCTION WORKERS (REGULATION OF EMPLOYMENT AND CONDITIONS OF SERVICE) ACT, 1996 (BOCW Act) AND RULES OF 1998 READ WITH BUILDING & OTHER CONSTRUCTION WORKERS CESS Act, 1996 & CESS RULES, 1998.

In case any portion of work involves execution through building or construction workers, then compliance to the above titled Acts shall be ensured by the contractor and contractor shall obtain license and deposit the cess under the Act. In the circumstances it may be ensured as under:-

- i. It shall be the sole responsibility of the contractor in the capacity of employer to forthwith (within a period of 15 days from the award of work) apply for a licence to the Competent Authority under the BOCW Act and obtain proper certificate thereof by specifying the scope of its work. It shall also be responsibility of the contractor to furnish a copy of such certificate of licence / permission to BHEL within a period of one month from the date of award of contract.
- ii. It shall be the sole responsibility of the contractor as employer to ensure compliance of all the statutory obligations under these act and rules including that of payment / deposit of 1% cess on the extant of work involving building or construction workers engaged by the contractor within a period of one month from the receipt of payment.
- iii. It shall be the responsibility of the sub-contractor to furnish the receipts / challans towards deposit of the cess together with the number, name and other details of beneficiaries (building workers) engaged by the sub-contractor during the preceding month.
- iv. It shall be the absolute responsibility of the sub-contractor to make payment of all statutory payments & compensations to its workers including that is provided under the Workmen's Compensation Act, 1923.
