Scope of work

A. SCOPE OF WORK:

Name of work: Grass cutting and removal of the same at material storage yard, along road side, boundary wall, around offices and buildings etc for fire prevention measure for **04 months** at Patratu Stage -I (3 x 800MW)

Location: The Project area is located at Patratu, 34km from Ranchi (State capital of Jharkhand). It is well connected by SH-2 from Ranchi to Patratu via Pithoria. Project site is also connected with Ramgarh via State Highway. Work has to be carried out inside the plant premises adhering to all the gate pass/SAFETY procedures comprising Medical, Safety and HR clearance of workers/Operators.

Scope of work: The scope of work includes-

1. Mobilization of required equipment's & Manpower, Tractor, Dumper (Min 14 cum capacity). All the mobilization and de mobilization cost is in the scope of agency and no separate cost will be paid on this account. All the equipment shall have documents details as described in individual equipment's scope below and should qualify the checklist of BHEL Safety dept. Minimum deployment period of any equipment's will be seven(7) days. Quantity of days engaged will be worked on pro rata basis for the days engaged and will be converted to month.
2. Agency to maintain the log book of each vehicle and get it certified daily from BHEL officers/EIC daily by 6:30PM.
3. For the emergent works, agency has to deploy the equipment as soon as possible within five hours to meet the function/objectives of contract.
4. Agency has to arrange diesel for smooth operation of all the equipment's engaged in subject contract at their own cost.
5. Smooth functioning of contract ensuring all the co-ordination with working agencies near working area.
6. Though the duration of work is for FOUR (04) months, BHEL reserves the right to get the contract extended further depending on the site condition and works requirement.

B. CONDITIONS OF EQUIPMENTS:

All the vehicles deployed in the subject contract shall be in workable condition and shall qualify all the parameters/ checklist mentioned in BHEL Safe department. The nature of works(anywhere) inside the plant area will be like:

1. Grass cutting and removal of the same at material storage yard, along road side, boundary wall, around offices and buildings etc for fire prevention measure.
2. No movement of workers standing/sitting through tractor trolley is permitted. Safe movement of tractor with respect to manual loading is fully in the scope of agency. Proper working of Hydraulic arrangements of tractor has to be ensured by the agency all the time.
3. All the workers deployed under the contract shall be enabled to do road cleaning, slush cleaning/working in confined areas, levelling the earth, manual excavation (all the tools for excavation to be provided by agency), lifting of all serviceable materials/scrap, housekeeping, cleaning with brooms/clothes, miscellaneous civil works etc. as well. Also supervisor engaged under this item shall do photos of works performed under the contract and to send frequently to EIC representative.
4. All the vehicles shall have speedometer indicating the lead/mileage measurement & for excavators the digital-meters indicating the hours of engine run.

C. AREA OF WORK:

Engagement of Manpower:

Manpower deployed in this item have to fulfil the Safety, Medical & HR clearance as per CLIMS. They will be deployed inside plant area for Housekeeping, Earth cutting, road cleaning, Housekeeping, any other miscellaneous civil works instructed by EIC/EIC representative. They will be engaged at any area/structure inside the BHEL at all elevation. All the safety PPEs are to be provided by the agency. Minimum wage payment with the entitlement to be paid by the agency as per the latest prevailing guidelines of Central/State Govt. & BHEL Circulars. If the wage rates are revised during the course of contract , the same will be subject to revision.

Engagement of Supervisor/Skilled Manpower:

Apart from the above conditions of manpower, manpower engaged under this item shall have work qualification or any ITI etc. Agency has to produce the document for qualification regarding rigging, education experience etc. of workers under this item. These workers are also be able to handle all the documents like register/attendance maintenance and equipment available/working area details in register. If they are not able to maintain the data as prescribed by EIC/EIC representative, agency shall replace the particular manpower. They shall have knowledge of safety and supervise the safety of equipment and workers working under the contract. For any near miss/unsafe act/unsafe observation under the contract , penalty of supervision equivalent to fortnight wages shall be recovered from agency bills. Hiring of Tractor with Trolley:

Deployment of 1 no of Tractor with hydraulic trolley unloading facility (capacity 3 cubic mtr) with & fuel, for transportation of earth/scrap /coal/mill reject/or any other material from designated areas. Generally day duty timing of tractor shall be from morning 9:00AM to Evening 6:00 PM. However timing of Day basis will be decided by EIC himself based on the urgency of work . Loading in tractor may be done using human manpower or mechanical means. Contractor should submit the copy of the Drivers' License, Registration Documents of the vehicle, Insurance paper of the vehicle, to the EIC/ Area Engineer at the beginning of the Contract. Contractor should ensure availability of tractor for 8 hrs on each BOQ day (excluding lunch time/breakdown time). Quantity will be proportionately reduced in case of breakdown .Decision of EIC will be final.

The area of work of Deployment of Tractor & Manpower for urgent works to be done FOR PERIOD OF SIX MONTHS (From date of commencement of work at site). On requirement basis . As and when required , the agency will be notified in writing with mobilization date. Minimum time for mobilization is 7 days. Minimum period of mobilization is also seven(7) days.

PENALTY:

For breakdown more than 04 hours during operation, additional 25% of hiring charges for break down period shall be recovered from the running bill as penalty if equipment fails in case of requirement. In case of non-availability of the Machinery & Equipment for more than 4 hrs, recovery shall be made @ twice the hourly hiring charges.

Non-Submission of statutory document to EIC will as mentioned will lead to penalty at the rate of Rs 500.00 per day but not more than Rs 5000.00.

The agency should take care to safeguard equipment/property of BHEL located in vicinity of the working area. In case of damage to any equipment/property of BHEL, due to accident caused by reasons attributable to the agency's labours, the agency shall bear the cost of repair of such damaged equipment/property. However, such recoveries shall not exceed 2% of the value of contract on any one occasion and cumulative total of such deductions shall not exceed 5% of the total value of the contract during his tenure.

E. TERMS & CONDITIONS OF CONTRACT

1. All the work shall be carried out as per BOQ, Specification, GCC, BHEL Safety rules specifications , IS codes and as per directions of Engineer-in-Charge.
2. SAFETY- Agency should ensure the morning TBT for all its workers and operators engaged for every day. TBT registers are to be strictly maintained by the agency for everyday countersigned by EIC representative. For a concerned month, collective scan has to be submitted along with the BILL.
3. **Payment Terms- The payment shall be made once in a month against certified RA bills. No advance payments shall be made by BHEL.**
4. The contractor shall be whole and sole custodian of the all equipment's and materials and should provide adequate work force/ resources for all the work.
5. Labour Laws- The contracting agency shall comply with all necessary labour laws, safety norms, BHEL Safety rules and other statutory requirement.
6. Insurance coverage- The contracting agency shall arrange for Insurance coverage for the Hydraulic excavator and dumpers, Backhoe loaders, tractors the manpower deployed, and third party liability. BHEL shall not have any liability what so ever in this regard. Any loss or damage of property / material / equipment of BHEL or other agencies due to negligence of the crew employed by the agency shall be recovered from the agency. No insurance is applicable on both electrical and diesel dewatering pumps.
7. VARIATION: Individual items on the contract may vary to any extent (no limits on positive and negative side). Overall contract value on the positive side is 0% ie overall Deviation value limit of the work is 0%. There is no limit of the value on negative side (as the work is being executed on requirement basis).
8. DEFECT LIABILITY PERIOD- NOT APPLICABLE.
9. Quoted rates will be firm during extended period of the contract.

12. Water for the work is in the scope of contractor. No separate payment to be made by BHEL/ BHEL on this account.
13. Lodging & Boarding-The contracting agency shall arrange for lodging & boarding of his staff and crewmembers, at their own cost outside plant area.
14. The contractor has to remove all unserviceable/ scrap materials from respective site before handing over of the work as per instruction of EIC.
15. CLIMS (Contract Labour Integrated Management System) is in practice in PVUNL/ BHEL. All the workers/Engineers gate pass are strictly to be entered in CLIMS system with required data. Labours/Workers/Engineers are to undergo Medical/Safety/HR Clearance in CLIMS system for enabling physical entry into the plant.
16. Payment of wages to operators/workers/ labours shall be not less than the minimum wages as per law. 15. **TDS under GST shall be deducted at prevailing rates on applicable value from the running bills.**
16. **TCS under Income Tax 1961 has been implemented with effect from 1st October 2020 for every seller having turnover more than threshold limit during financial year immediately preceding**

financial year in which the sale of goods is carried out, who receives any amount as consideration for sale of any goods of the value or aggregate of such value exceeding threshold limit other than export of goods or who is already covered under other provision of section 206C, collect from the buyer, TCS as per applicable rates of the sale consideration exceeding threshold limit subject to following conditions

- i. Buyer shall be as per clause (a) of section 206C- (1H)
- ii. Seller shall be as per clause (b) of section 206C- (1H)
- iii. No TCS is to be collected, if the seller is liable to collect TCS under other provision of section 206C or the buyer is liable to deduct TDS under any provision of the Act and has deducted such amount.

If Successful Bidder is falling under the purview of TCS then he has to submit a declaration in that respect along with relevant financial statements before the start of work or if bidder is falling under preview of TCS during the work in progress then bidder is compulsorily required to submit relevant financial statement in the beginning of the respective FY.

For TCS claim, vendor has to submit relevant documents required as per Income Tax Act.

ANNEXURE-2

BOCW Act & Cess Act

Bidder may please note that the sub-contractor/bidder of BHEL engaging building or construction worker in connection with building or other construction work, are required to follow the procedures enumerated below:

1. It shall be the sole responsibility of the contractor as employer to ensure compliance of all the statutory obligations under the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 and the Building and other Construction Workers' Welfare Cess Act, 1996 and the rules made thereunder.
2. It shall be sole responsibility of the contractor engaging Building Workers in connection with the building or other construction works in the capacity of employer to apply and obtain registration certificate specifying the scope of work under the relevant provisions of the Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 from the appropriate Authorities.

3. It shall be responsibility of the contractor to furnish a copy of such Registration Certificate within a period of one month from the date of commencement of Work.
4. It is responsibility of the contractor to register under the Building and other Construction Workers' Welfare Cess Act, 1996 and deposit the required Cess for the purposes of the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 at such rate as the Central Government may , by notification in the Official Gazette, from time to time specify. However, before registering and deposit of Cess under the Building and other Construction Workers' Welfare Cess Act, 1996, the contractor will seek written prior approval from the Construction Manager.
5. It shall be sole responsibility of the contractor as employer to get registered every Building Worker, who is between the age of 18 to 60 years of age and who has been engaged in any building or other construction work for not less than ninety days during the preceding twelve months as Beneficiary under the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996.
6. It shall be sole responsibility of the contractor as employer to maintain all the registers, records, notices and submit returns under the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 and the Building and other Construction Workers' Welfare Cess Act, 1996 and the rules made thereunder.
7. It shall be sole responsibility of the contractor as employer to provide notice of poisoning or occupation notifiable diseases, to report of accident and dangerous occurrences to the concerned authorities under the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 and the rules made thereunder and to make payment of all statutory payments & compensation under the Employees' Compensation Act, 1923.
8. It shall be the responsibility of the sub-contractor as employer to make payment/deposit of applicable cess amount on the extent of work involving building or construction workers engaged by the sub-contractor within a period of one month from the receipt of payment. It shall also be responsibility of the Contractor to furnish BHEL on monthly basis, Receipts/ Challans towards Deposit of the Cess under the Building and other Construction Workers' Welfare Cess Act, 1996 and the rules made thereunder along with following statistics :
 - (i) Number of Building Workers employed during preceding one month.
 - (ii) Number of Building workers registered as Beneficiary during preceding one month.
 - (iii) Disbursement of Wages made to the Building Workers for preceding wage month.
 - (iv) Remittance of Contribution of Beneficiaries made during the preceding month
9. BHEL shall reimburse the contractor the Cess amount deposited for the purposes of the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 under the Building and other Construction Workers' Welfare Cess Act, 1996 and the rules made thereunder. However, BHEL shall not reimburse the Fee paid towards the registration of establishment, fees paid towards registration of Beneficiaries and Contribution of Beneficiaries remitted.
10. It shall be responsibility of the Building Worker engaged by the Contractor and registered as a beneficiary under the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 to contribute to the Fund at such rate per mensem as may be specified by the State government by notification in the Official Gazette. Where such beneficiary authorizes the contractor being his employer to deduct his contribution from his monthly wages and to remit the same, the contractor shall remit such contribution to the Building and other construction Workers' Welfare Board in such manner as may be directed by the Board , within the fifteen days from such deduction.

11. Bidders may please note that though the quoted price is exclusive of BOCW (which will be reimbursed by BHEL as per sub-clause 9 above) , however, If at any point of time during the contract period, non-compliance of the provisions of the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 and the Building and other Construction Workers' Welfare Cess Act, 1996 and the rules made thereunder is observed, BHEL reserves the right to deduct the applicable cess (1%) on the contract value and penalty (if any, imposed by Cess Authorities) from the payables on account of non-compliance.
12. The contractor shall declare to undertake any liability or claim arising out of employment of building workers and shall indemnify BHEL from all consequences / liabilities / penalties in case of non-compliance of the provisions of the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 and the Building and other Construction Workers' Welfare Cess Act, 1996 and the rules made thereunder.
