### 11.0 Penalties:

### For Late Collection of documents:

The documents shall be collected as per Clause 7.0 of this document. In case of any late collection of documents a penalty shall be levied equivalent to 1% per day subject to maximum of 10% of the quantum of that particular consignment.

### For Late Delivery of Documents:

a) All documents collected must be delivered as per Clause 7.0 of this document. In case of late delivery, a penalty shall be levied equivalent to 10% of the quantum of billing of the respective late delivered consignment.

### For Loss or Damage or Non-Delivery:
