ii). <u>Calculation of Overall 'Performance Rating'</u> (**R**_{BHEL}) in case at least 6 evaluation scores for 'similar Packages' for the tendered scope ARE NOT AVAILABLE, during the 'Period of Assessment':

This shall be obtained by summing up the 'Monthly Performance Evaluation' scores obtained by the bidder in all Regions for ALL the packages, divided by the total number of Package months for which evaluation should have been done. iv). <u>Performance Systems</u>: The performance rating as mentioned in II (i) and (ii) above, shall be calculated as per Online Systems i.e. Contractor Performance Evaluation System (CPES) and Safety Performance Evaluation System (HSEPES). iii). Bidders who have not been evaluated for at least six package months in the last 24 months preceding and including the Cut-off month in the online BHEL system for contractor performance evaluation in BHEL PS Regions, shall be considered "NEW VENDOR".

In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
- V. An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
- VI. The successful bidder shall not be allowed to sub-contract works to any contractor from a country which shares a land border with India unless such contractor is registered with the Competent Authority.

 - **2.7.9.1** Provision of Penalty in case of slippage of Intermediate Milestones:
 - i) Two major Intermediate Milestones are mentioned as M1 & M2 in Chapter VI: Time Schedule of Vol IA Technical Conditions of Contract.
 - ii) In case of slippage of these identified Intermediate Milestones, Delay Analysis shall be carried out on achievement of each of these two Intermediate Milestones in reference to Form 14.
 - iii) In case delay in achieving M1 Milestone is solely attributable to the contractor, 0.5% per week of Executable Contract Value*, limited to maximum 2% of Executable Contract Value, will be withheld.
 - iv) In case delay in achieving M2 Milestone is solely attributable to the contractor, 0.5% per week of Executable Contract Value*, limited to maximum 3% of Executable Contract Value, will be withheld.
 - v) Amount already withheld, if any against slippage of M1 milestone, shall be released only if there is no delay attributable to contractor in achievement of M2 Milestone.
 - vi) Amount required to be withheld on account of slippage of identified intermediate milestone(s) shall be withheld out of respective milestone payment and balance amount (if any) shall be withheld @10% of RA Bill amount from subsequent RA bills.
 - vii) Final deduction towards LD (if applicable as per clause 2.7.9 above), on account of delay attributable to contractor shall be based on final delay analysis on completion / closure of contract. Withheld amount, if any due to slippage of identified intermediate milestone(s) shall be adjusted against LD or released as the case may be.
 - viii) In case of termination of contract due to any reason attributable to contractor before completion of work, the amount already withheld against slippage of intermediate milestones shall not be released and be converted into recovery.

1.2 Scope of Work:

Dismantling of Closed Storage Sheds & office sheds at sparing sites (excluding foundation), transportation and receipt unloading at receiving site, cleaning the materials, painting and reerection including supply of additional materials as required to re-erect the closed storage sheds and PEB office sheds and Handing over excluding execution of civil foundation works.

- 1.2.1 The existing Two (02 Nos.) 60m x 15m closed sheds, one number Approx. 780 SQM PEB office shed are to be dismantled at Wanakbori TPS Project site, and Two no.s 40mx10m PEB office sheds from Uppur Project site including office furniture, air conditioners, electrical fixtures, wiring for LAN & electrical circuits etc., transported and re-erection at the receiving site.
- 1.2.2 The closed storage shed/office shed must be dismantled in such a manner that all the materials are in re erectable condition. The condition of materials shall be verified and certified by BHEL engineer at the dismantling site before loading. Based on the certification, the conditions shall be cross checked at the receiving site by BHEL engineer.
- 1.2.3 Any damage of material during transit of materials shall be the responsibility of the bidder and shall be replaced at no extra charges.
- 1.2.4 After dismantling, the debris must be disposed at locations nearby the site office as per instruction of BHEL engineer.
- 1.2.5 All fasteners, accessories, electrical wiring, fittings, appliances must be removed very cautiously so that they can be re used again.
- 1.2.6 The dismantled closed shed/office shed must be packed, loaded at the Sparing Sites, transported and unloaded at the Receiving Site.
- 1.2.7 The foundation and PCC flooring works for the sheds is EXCLUDED from the scope of the contractor.
- 1.2.8 The entire closed shed, electrical fittings etc. & entire office shed along with toilet block & water tank structures, furniture, electrical items must be re-erected at the receiving site. Materials like fasteners and accessories, electrical fittings, wiring & cabling etc. which are found to be damaged/non-usable shall be supplied by the bidder. Bidder shall visit site and quote a lump sum rate for the supply of these items under relevant category in the rate schedule.
- 1.2.9 All materials additionally supplied by the bidder shall confirm to relevant IS standards. The supporting documents shall be provided to BHEL engineer upon his instructions.
- 1.2.10 Construction of brickwork up to the height of 600mm all-round the closed storage shed including plaster and painting is in the scope of bidder. No separate payment shall me made for the same.
- 1.2.11 Additional painting wherever required (structural steel, cladding sheet, etc.) as per instructions of BHEL engineer is within bidder's scope. No separate payment shall me made for the same.
- 1.2.12 All excess materials shall be handed over to BHEL and stacked/disposed as per instructions of BHEL engineer in earmarked area/yard which might be within a radius of 3-4 km from site office.

- 1.2.13 Bidders may take note of the following points while sending their offers:
 - i) The materials received from dismantling and transportation of the closed storage sheds/office sheds from sparing site shall be checked for the quality for re-use, shall be cleaned and repaired to the extent possible as per the instruction of BHEL engineer in charge. Further, the additionally required materials to complete the erection of closed storage shed / office shed as per the specifications & drawings, shall be supplied by the contractor within the quoted price.
 - ii) The quoted prices shall include transit freight, handling at site, assembly and erection.
 - iii) Quoted Price shall be inclusive of all the above.
- 1.2.14 Bidder to facilitate shifting of almirah, documents & fixing of 1 no. AC from the existing office to the nearby identified location within the sparing site premises. The overall quoted price shall be inclusive of this work.

1.3 Salient Information about each closed storage shed:

- 1.3.1 This information is only indicative to provide a broad outlook of the existing closed storage shed /office shed.
- 1.3.2 Size of existing Closed Sheds (Wanakbori Site) 15M c/c X 60M c/c X 6.0 M (approximate)
- 1.3.3 Size of office Shed (Wanakbori Site- 1 No.) 780SQM Approx.
- 1.3.4 Size of existing PEB office shed (Uppur Site- 2 No. s)- 10M c/c X 40M c/c X 4.0 M (approximate)
- 1.3.5 Clear Height of closed Shed (between FFL & Bottom of truss / Structural Member) 6.0M
- 1.3.6 Clear Height of Office Sheds (between FFL & Bottom of False Ceiling) 3.0M
- 1.3.7 Columns shall be spanning 6.0 M c/c long span & 5.0 M c/c short span for Closed Store sheds
- 1.3.8 All the works of sheds are of pressed steel sections and all side cladding/ roof sheets shall be fitted in such a way that they can be removed at any point of time.
- 1.3.9 Sliding doors- Manual type with provision for lock and key (4.65 M Width x 5 M Height) is provided at front entrance of each covered shed at center location. Suitable arrangement shall be made for easy operation of gates (gear operated).
- 1.3.10 One man-entry gate is provided at one side of each shed (front entrance by the side of sliding door).
- 1.3.11 HDPE/UPVC Rain Water Down Pipe to be provided with suitable gutters all around.

1.4 Information about office sheds shall be obtained from enclosed drawings.

1.5 Salient Information about erection procedure of Store Sheds:

1.5.1 All fabrication and erection of structures must be executed according to the specification and drawings. Erection of trusses is true to line and level and aligned properly, as per drawing and instruction of Engineer In-charge. The roof truss must have bolted joints at crown and at both ends.

- 1.5.2 Structural/ steel members will have 2 coats of Zinc Chromate primer minimum 25 micron DFT at shop and 25 micron DFT after erection followed by 2 coats of synthetic enamel paint (if not pre-coated)- minimum 25 micron (DFT) of each coat of approved make and shade to achieve an even shade over steel sections already having primer coats and keeping overall DFT with primer not less than 110 microns.
- 1.5.3 All materials, additionally supplied for structural steel works have to be supplied by the contractor and necessary test certificates of the materials procured for this work must be submitted for scrutiny.
- 1.5.4 All accessories like G.I. bolts, EPDM washers and nuts complete required for the work must be from reputed manufacturer. All bolts, nuts (IS 4759) shall be galvanised (hot dip) min. 270gm/m2. Galvanised spring/plain washer shall be as per IS 1573.
- 1.5.5 Since these are detachable sheds & to be in repetitive use at other locations, proper marking (permanent) shall be made for identification to ease re-erection.
- 1.5.6 Cladding: Roof and Side Cladding Galvalume Sheet confirming to ASTM A 792 of thickness 0.47mm with zinc coating not less than 150gm/Sq.m (both side mass) of 550Mpa (min) of approved make. Translucent (Poly Carbonate) sheet of approved make are provided for alternative bays on roofs (10% of the roof sheeting area). Both roof and side cladding are to be made "Water Tight.". Purlins for wall & roof cladding shall be 'z' shape made-up with pressed steel.
- 1.5.7 Structural steel and Roof and Side Cladding with Galvalume Sheets, dismantled and diverted from the sparing site shall be checked for the re-use, properly cleaned out of rust and necessary painting shall be carried out as per above specification, drawings and relevant IS standards. No separate payment shall be made for additional painting works.
- 1.5.8 BHEL Logo-1 no shall be painted in front of the entrance just above the sliding door.
- 1.5.9 Ventilators 900 mm (W) x 600 mm (H) are provided at a height of 4.5m from FFL, made of suitable Aluminium section.
- 1.5.10 Suitable long span shelve system is provided throughout the length of both opposite longitudinal spans of closed sheds. It should have two shelves(wood) with one shorter top & one wider middle rack at height of 600mm from floor adding to a total height of 1200mm. The shelves shall be design to withstand SKU loading (not less than 125 Kg/Sq.M) with suitable angle section. The width of top shelf shall be of 600mm & intermediate/middle shelf is 750mm.

1.6 Salient Information about electrical works of Store Sheds:

- 1.6.1 All electrical works including wiring shall be dismantled from the existing shed such that they can be re-used. Items over and above this shall be supplied and erected by the bidder as per requirement. A lump sum rate shall be quoted for the same under relevant category in the rate schedule.
- 1.6.2 Supply & installation of electrical items are to be carried out strictly as per specification and executed through licensed electricians.
- 1.6.3 A closed storage shed typically consists of the following electrical fittings and appliances,

- (i) Main switch (30A TPN), ELCB, wires, conduit, tees, bends, clamps, JBs, Switch boards, earthing wires etc. for 18 nos. Medium Bay LED luminaries of 90 watt with fittings.
- (ii) Main wiring points 2.5 Sq mm copper wire. Light, Fan & 5A points 1.5 Sq mm copper wire. 15/20 A points 2.5 Sq mm copper wire.
- (iii) Outside the shed 1nos LED lamp at the entrance.
- (iv) Exhaust Fans 2 nos of size 600mm of suitable capacity on both sides on the gable ends
- (v) 4 Nos. of 24/25 W LED floodlight and fittings to be installed at each corner of storage shed.
- (vi) Outdoor Light distribution Board for outside lights at outside of the shed.

2.1 WORKS BY OTHERS

No work under the specification will be provided by any agency other than the contractor unless specifically mentioned elsewhere in the contract. Following work is excluded from this scope of work: -

- 1) Civil Works of Foundation
- 2) Civil works of flooring & finishing
- 3) Civil Works of plumbing & sanitation

2.2 **SITE VISIT**

Contractor should visit project site, to acquaint himself with the conditions prevailing at site and in and around the plant premises, together with all the statutory, obligatory, mandatory requirements of various authorities before submission of the bid.

2.3 <u>Carrying out work by BHEL</u>

BHEL reserves the right to withdraw/restrict/alter the quantum of works as per clause No. 2.7 of GCC.

NOTE:

Contractor has to make him well conversant with the Customer specification. In case of ambiguity between BHEL and customer specification, customer specification shall prevail.

2.4 Construction Power:

- 2.4.1 Construction power (three phase, 415 V/ 440 V) will be provided near the site at a distance of approx. 500M on chargeable basis (source of construction power shall be provided at two locations). Further distribution shall be arranged by the contractor at his own cost and services. Contractor shall be responsible for fulfillment of all requirements including statutory requirements in this regard. Contractor shall deploy and install required energy meter, cables, fuses, LT distribution boards, switchboards, bus bars, earthing arrangements, protection devices i.e, required capacity ELCB/RCCB in outgoing feeders and any other installation as specified by statutory authority/act. Contractor shall also obtain approvals of appropriate authority and pay necessary fees, levies etc towards the clearance of such installations, prior to use. Sufficient power factor compensation equipments like capacitor shall be provided by contractor for reactive loads like welding machines etc. In case of any fine/penalty on account of low power factor, same shall be shared by contractor proportionately according to power consumption.
- 2.4.2 Providing all arrangements for distribution of construction power at various locations as per bidder's requirements from the supply point of owner/BHEL. Contractor shall make necessary arrangements for onward distribution of

- construction power taking due care of surrounding construction activities like movement of cranes & vehicles, civil work, fabrication/construction/assembly/ erection etc. and safety of personnel. It may become necessary to relocate some of the installations to facilitate work by other agencies or by him.
- 2.4.3 It shall be the responsibility of the Contractor to provide, maintain the complete installation on the load side of the supply with due regard to the safety requirements at site. All cabling and installations shall comply in all respects with the appropriate statutory requirements. The installation and maintenance of this shall be done by licensed and experienced electrician.
- 2.4.4 While reasonable efforts will be made to ensure continuous electric power supply, interruptions cannot be ruled out and no claim from the Contractor shall be entertained on this account such as idle labor, extension of time etc. The Contractor shall adjust his working shift accordingly and deploy additional manpower, if necessary, so as to achieve the target.
- 2.4.5 Contractor shall be well equipped with back-up power supply arrangement like DG set and diesel operated welding machine etc to tackle situations arising due to failure of supplied power, so as to ensure continuity and completion of critical processes that are underway at the time of power failure or important activities planned in immediate future.
- 2.4.6 BHEL is not responsible for any loss or damage to the Contractor's equipment as a result of variations in voltage or frequency or interruptions in power supply.
- 2.4.7 Contractor is advised to maintain the calibrated energy measuring instruments and use their system as efficiently as possible. to maintain the HT side input energy meter reading and LT side outgoing energy meter reading to sub-contractors as equal. In case there is any difference between the sum of the LT side meter readings of all sub-contractors and the HT side meter reading of M/s NTPC, same shall be distributed proportionately among all sub-contractors working during the respective calendar month.
- 2.4.8 The bidder will have to Procure & install General mobile illumination system during construction right from start of his work. This system will include temporary pole lighting, portable lighting towers with DG back-up, within the quoted price. The illumination should be such that minimum illumination requirement as specified by Indian standards for general illumination is maintained. Arrangement of sufficient lighting inside chimney at various platform levels during flue can erection, expansion compensator fixing and other related works inside chimney etc.
- 2.4.9 The charges only for the actual energy consumed by the contractor shall be recovered based on prevalent rate of DISCOM.

GENERAL: -

If any other voltage level (other than normally available) is required, the same shall be arranged by the contractor from power supply as above. Contractor will have to provide at his own cost necessary calibrated energy meters (tamper proof, suitably housed in a weather proof box with lock & key arrangement) at point of power supply along with calibration certificate from authorized / accredited agency for working out the power consumption. In case of recalibration required for any reason the necessary charges including replacement by calibrated meters is to be borne by the contractor. Supply of electricity shall be governed by Indian Electricity Act and Installation Rules and other Rules and Regulation as applicable. The contractor shall ensure usage of electricity in an efficient manner and the same may be audited by BHEL time to time. In case of any major deviation from normally accepted norms is observed, BHEL will reserve the right to impose penalty as deemed fit for such cases.

2.5 Construction water:

Contractor shall make all arrangements himself for the supply of construction water as well as potable water for labour and other personnel at the work site/colony. Bidder has to make his own arrangement for supply of construction water including bore-wells, water tanker etc. However, draw of construction/ potable water from the bore-well shall be permitted if found suitable and allowed by customer. Any statutory clearance required shall be obtained by the contractor. Assistance, if required shall be provided by the BHEL/NTPC.

2.6 General:

- 2.6.1 E way Bills to be arranged by contractor whenever required.
- 2.6.2 All works shall be carried out in proper workmen like manner. Items of works covered by the following specification shall be carried out as per the best practices and according to the direction of the Engineer In-charge / BHEL, Site Engineer and to his satisfaction. Unless otherwise specified in this section or in the description of item, the cost of stage of works mentioned here under shall be deemed to have been included in the rates of items provided in the schedule.
- 2.6.3 Bidders may take note of the following points while sending their offers:
 - (i) The quoted prices shall include transit freight (for materials supplied new), handling at site, assembly and erection.
 - (ii) Bidders are requested to visit both –Sparing and Receiving sites to see the site condition, prevailing local laws etc. No claim shall be entertained to lack of knowledge of site condition.
 - (iii) The materials and workmanship must be of good quality and accepted standards and specifications. The site engineer reserves the right to reject any material not up to the specification. All taxes, levies and duties on construction materials will be on bidder's account. After completion of work, the building and areas around them should be cleared of all rubbish, debris etc. and handed over in fit condition for occupation.

- 2.6.4 Scope of work covered under this specification requires quality workmanship, engineering and construction management. The contractor shall ensure timely completion of work. The contractor shall have adequate tools, measuring instruments, etc. in his possession. He shall also have adequate trained, qualified and experienced engineers, supervisory staff and skilled personnel. The manpower deployment identified by contractor shall match with above scope of works.
- 2.6.5 It is not the intent to specify herein all details of material. Any item related this work not covered by this but necessary to complete the system will be deemed to have been included in the scope of the work.
- 2.6.6 Site testing wherever required shall be carried out for all items / materials installed by the contractor to ensure proper installation and functioning in accordance with drawings, specifications and manufacturer's recommendations.
- 2.6.7 The work shall be executed under the usual conditions without affecting the plant construction and in conjunction with other operations and contracting agencies at site. The contractor and his personnel shall co-operate with the personnel of other agencies, co-ordinate his work with others and proceed in a manner that shall not delay or hinder the progress of work as a whole.
- 2.6.8 The Contractor may have to execute work in such a place and condition where other agencies also will be under such circumstances. The contractor shall co-operate with other contractors and agencies so that various activities can be carried out simultaneously in order to achieve an early completion.
- 2.6.9 All the work shall be carried out as per instructions of BHEL engineer. BHEL engineer's decision regarding the correctness of the work and method of working shall be final and binding on the contractor.
- 2.6.10 The contractor will be responsible for the safe custody and proper accounting of all materials in connection with the work.
- 2.6.11 The contractor must obtain the signature and permission of the security personnel of the customer for bringing any of their materials inside the site premises. Without the Entry Gate Pass these materials will not be allowed to be taken outside.
- 2.6.12 Contractor shall retain all T&Ps, Material handling equipment, etc. at site as per advice of BHEL engineer and same shall be taken out from site only after getting the clearances from Engineer in charge.
- 2.6.13 The contractor at his cost shall arrange necessary security measures for adequate protection of his machinery, equipment, tools, materials etc. BHEL shall not be responsible for any loss or damage to the contractor's construction equipment and materials. The contractor may consult the Engineer-in-Charge on the arrangements made for general site security for protection of his machinery equipment tools etc.
- 2.6.14 Any wrong erection shall be removed and re-erected promptly to comply with the design requirements to the satisfaction of Site Engineer.
- 2.6.15 Contractor has to work in close co-ordination with other erection agency at site. BHEL engineer will co-ordinate area clearance. In a project of such magnitude, it is possible that the area clearance may be less / more at a particular given time. Activities and erection program have to be planned in such a way that the milestones are achieved as

per schedule/ plans. Contractor shall arrange & augment the resources accordingly.

- 2.6.16 Contractor shall remove all scrap materials periodically generated from his working area in and around power station and collect the same at one place earmarked for the same. Failure to collect the scrap is likely to lead to accidents and as such BHEL reserves the right to collect and remove the scrap at contractor's risk and cost if there is any failure on the part of contractor in this respect. All the package materials, including special transporting frames, etc. shall be returned to the BHEL stores by the contractor.
- 2.6.17 The contractor is strictly prohibited from using BHEL's regular components like angles, channels, beams, plates, pipe / tubes, and handrails etc. for any temporary supporting or scaffolding works. Contractor shall arrange himself all such materials. In case of such misuse of BHEL materials, a sum as determined by BHEL engineer will be recovered from the contractor's bill. The decision of BHEL engineer is final and binding on the contractor.
- 2.6.18 No member of the already erected structure / platform, pipes, grills, platform, other component and auxiliaries should be cut without specific approval of BHEL engineer.
- 2.6.19 Crane operators deployed by the contractor shall be tested by BHEL before he is allowed to operate the cranes.
- 2.6.20 On Completion of work, all the temporary buildings, structures, pipe lines, cable etc. shall be dismantled and leveled and debris shall be removed as per instruction of BHEL by the contractor at his cost. In the event of his failure to do so, the expenditure towards clearance of the same will be recovered from the contractor. The decision of BHEL Engineer in this regard is final.
- 2.6.21 It is the responsibility of the contractor to do the alignment, checking, etc. if necessary, repeatedly to satisfy BHEL Engineer with all the necessary tools and tackles, manpower etc. without any extra cost. Also the contractor should ensure that the alignment is not disturbed afterwards.
- 2.6.22 The contractor shall ensure that his premises are always kept clean and tidy to the extent possible. Any untidiness noted on the part of the contractor shall be brought to the attention of the contractor's site representative who shall take immediate action to clean the surroundings to the satisfaction of the Engineer-in-Charge.

7.1 Progressive Payment / Final Payment:

The payments for works under the scope of this contract shall be as per clause no 2.6; clause 2.22; clause 2.23 of General Conditions of Contract and Chapter X of Special Conditions of Contract. However, Clause No. 10.5 on RA Bill Payments, in Volume-IB, Chapter-X of SCC, is revised as under:

The payable dues against running bills will be eligible for payment beyond 30 days of submission of running bill complete in all respects with all documents and accepted by engineer-in-Charge. It is the responsibility of the contractor to make his own arrangements for making timely payments towards labour wages, statutory payments, outstanding dues etc. and other dues in the meanwhile.

- 1. All taxes excluding GST, GST Cess & BOCW Cess but including, Royalties, fees, license, deposits, commission, any State or Central Levy and other charges whatsoever, if any, shall be borne by you and shall not be payable extra.
- 2. Any increase of the taxes excluding GST, GST Cess & BOCW **Cess**, at any stage during execution including extension of the contract shall have to be borne by the contractor. 3. **GST**:

The successful bidder shall furnish proof of GST registration .GST along with Cess (as applicable) legally leviable & payable by the successful bidder as per GST Law, shall be paid by BHEL. Hence Bidder shall not include GST along with Cess (as applicable) in their quoted price.

- 4. GST charged in the Tax Invoice/Debit note by the contractor shall be released separately to the contractor only after contractor files the outward supply details in GSTR-1 on GSTN portal and input tax credit of such invoice is matched with corresponding details of outward supply of the contractor and has paid the GST at the time of filing the monthly return
- 5. E-invoicing under GST has been implemented with effect from 1st October 2020 for all the taxable persons having turnover more than the threshold limit in any preceding financial year from 2017-18 onwards. Therefore, for all the taxable persons falling under the purview of E-invoice, it is mandatory to mention a valid unique Invoice Reference No. (IRN) and QR code as generated from E-Invoicing portal of the Government for the purpose of issuing a valid Tax Invoice. Only an E-invoice issued in the manner prescribed under rule 48(4) of CGST Rules shall be treated as valid invoice for reimbursement of GST amount.
 - If the successful Bidder is not falling under the purview of E-Invoicing then he has to submit a declaration in that respect along with relevant financial statements.
- 6. Bidder shall note that the GST Tax Invoice complying with GST Invoice Rules (Section 31 of GST Act & Rules referred there under) wherein the 'Bill To' details will as below:

- 7. Bidder to immediately intimate on the day of removal of Goods (in case of any supply of goods) to BHEL along with all relevant details and a scanned copy of Tax Invoice to below email ids to enable BHEL to meet its GST related compliances:-
 - Email id ---- to be intimated later on.
 - In case of delay in submission of the abovementioned documents on the date of dispatch, BHEL may incur penalty /interest for not adhering to Invoicing Rules under GST Law. The same will be liable to be recovered from the successful bidder, if such delay is not attributable to BHEL.
- 8. In case of raising any Supplementary Tax Invoice (Debit / Credit Note) Bidder shall issue the same containing all the details as referred to in Section 34 read with Rule 53.
- 9. Bidder shall note that in case GST credit is delayed/ denied to BHEL due to delayed / non receipt of goods and /or tax invoice or expiry of the timeline prescribed in GST Law for availing such ITC, or any other reasons not attributable to BHEL, GST amount shall be recoverable from the vendor along with interest levied / leviable on BHEL, as the case may be.
- 10. Bidder shall upload the Invoices raised on BHEL in GSTR-1 within the prescribed time as given in the GST Act. Bidder shall note that in case of delay in declaring such invoice in your return and GST credit availed by BHEL is denied or reversed subsequently as per GST Law, GST amount paid by BHEL towards such ITC reversal as per GST law shall be recoverable from the bidder along with interest levied / leviable on BHEL.
- 11. Way Bill: Successful Bidder to arrange for way bill / e-waybill for any transfer of goods for the execution of the contract.
 - The Bidder has to make their own arrangement at their cost for completing the formalities, if required, with Issuing Authorities, for bringing materials, plants & machinery at site for execution of the works under this contract, Road Permit/ Way Bill, if required, shall be arranged by the contractor and BHEL will not supply any Road Permit/ Way Bill for this purpose.
- 12. **New taxes and duties**:-Any New taxes & duties, if imposed subsequent to due date of offer submission as per NIT & TCN, by statutory authority during contract period including extension, if the same is not attributable to you, shall be reimbursed by BHEL on production of relevant supporting document to the satisfaction of BHEL. However, you shall obtain prior approval from BHEL before depositing new taxes and duties.
 - Benefits and/or abolition of all existing taxes must be passed on to BHEL against new Taxes, if any, proposed to be introduced at a later date.

In case any new tax/levy/duty etc. becomes applicable after the date of bidder's offer but before opening of the price bid, the bidder must convey its impact on his price duly substantiated by documentary evidence in support of the same before opening of the price bids. Claim for any such impact after opening the price bid will not be considered by BHEL for reimbursement of tax or reassessment of offer.

- 13. For transportation work, bidder shall declare in his quotation whether he is registered under GST, if yes, whether he intends to claim GST on forward charge basis. In absence of this declaration, BHEL will proceed further with the assumption that bidder intends not to claim GST on forward charge basis. However, in case of GST registered transporter, the amount to the extent of goods and service tax will be retained till BHEL avails the credit of GST. Further, transporter shall issue tax invoice which inter alia includes gross weight of the consignment, name of the consigner and the consignee, registration number of vehicle in which the goods are transported, details of goods transported, details of place of origin and destination, GSTIN of the person liable for paying tax whether as consigner, consignee or goods transport agency, and also containing other information as mentioned under rule 46.
- 14. TDS under Income Tax shall be deducted at prevailing rates on gross invoice value from the running bills unless exemption certificate from the appropriate authority/ authorities is furnished.
- 15. TDS under GST shall be deducted at prevailing rates on applicable value from the running bills.
- 16. TCS under Income Tax 1961 has been implemented with effect from 1st October 2020 for every seller having turnover more than threshold limit during financial year immediately preceding financial year in which the sale of goods is carried out, who receives any amount as consideration for sale of any goods of the value or aggregate of such value exceeding threshold limit other than export of goods or who is already covered under other provision of section 206C, collect from the buyer, TCS as per applicable rates of the sale consideration exceeding threshold limit subject to following conditions
 - i. Buyer shall be as per clause (a) of section 206C- (1H)
 - ii. Seller shall be as per clause (b) of section 206C- (1H)

iii. No TCS is to be collected, if the seller is liable to collect TCS under other provision of section 206C or the buyer is liable to deduct TDS under any provision of the Act and has deducted such amount.

If Successful Bidder is falling under the purview of TCS then he has to submit a declaration in that respect along with relevant financial statements before the start of work or if bidder is falling under preview of TCS during the work in progress then bidder is compulsorily required to submit relevant financial statement in the beginning of the respective FY.

ANNEXURE-2

BOCW Act & Cess Act

Bidder may please note that the sub-contractor/bidder of BHEL engaging building or construction worker in connection with building or other construction work, are required to follow the procedures enumerated below:

- 1. It shall be the sole responsibility of the contractor as employer to ensure compliance of all the statutory obligations under the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 and the Building and other Construction Workers' Welfare Cess Act, 1996 and the rules made thereunder.
- 2. It shall be sole responsibility of the contractor engaging Building Workers in connection with the building or other construction works in the capacity of employer to apply and

- obtain registration certificate specifying the scope of work under the relevant provisions of the Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 from the appropriate Authorities.
- 3. It shall be responsibility of the contractor to furnish a copy of such Registration Certificate within a period of one month from the date of commencement of Work.
- 4. It is responsibility of the contractor to register under the Building and other Construction Workers' Welfare Cess Act, 1996 and deposit the required Cess for the purposes of the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 at such rate as the Central Government may, by notification in the Official Gazette, from time to time specify. However, before registering and deposit of Cess under the Building and other Construction Workers' Welfare Cess Act, 1996, the contractor will seek written prior approval from the Construction Manager.
- 5. It shall be sole responsibility of the contractor as employer to get registered every Building Worker, who is between the age of 18 to 60 years of age and who has been engaged in any building or other construction work for not less than ninety days during the preceding twelve months as Beneficiary under the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996.
- 6. It shall be sole responsibility of the contractor as employer to maintain all the registers, records, notices and submit returns under the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 and the Building and other Construction Workers' Welfare Cess Act, 1996 and the rules made thereunder.
- 7. It shall be sole responsibility of the contractor as employer to provide notice of poisoning or occupation notifiable diseases, to report of accident and dangerous occurrences to the concerned authorities under the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 and the rules made thereunder and to make payment of all statutory payments & compensation under the Employees' Compensation Act, 1923.
- 8. It shall be the responsibility of the sub-contractor as employer to make payment/deposit of applicable cess amount on the extent of work involving building or construction workers engaged by the sub-contractor within a period of one month from the receipt of payment. It shall also be responsibility of the Contractor to furnish BHEL on monthly basis, Receipts/ Challans towards Deposit of the Cess under the Building and other Construction Workers' Welfare Cess Act, 1996 and the rules made thereunder along with following statistics:
 - (i) Number of Building Workers employed during preceding one month.
 - (ii) Number of Building workers registered as Beneficiary during preceding one month.
 - (iii)Disbursement of Wages made to the Building Workers for preceding wage month.

- (iv) Remittance of Contribution of Beneficiaries made during the preceding month
- 9. BHEL shall reimburse the contractor the Cess amount deposited for the purposes of the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 under the Building and other Construction Workers' Welfare Cess Act, 1996 and the rules made thereunder. However, BHEL shall not reimburse the Fee paid towards the registration of establishment, fees paid towards registration of Beneficiaries and Contribution of Beneficiaries remitted.
- 10. It shall be responsibility of the Building Worker engaged by the Contractor and registered as a beneficiary under the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 to contribute to the Fund at such rate per mensem as may be specified by the State government by notification in the Official Gazette. Where such beneficiary authorizes the contractor being his employer to deduct his contribution from his monthly wages and to remit the same, the contractor shall remit such contribution to the Building and other construction Workers' Welfare Board in such manner as may be directed by the Board, within the fifteen days from such deduction.
- 11. Bidders may please note that though the quoted price is exclusive of BOCW (which will be reimbursed by BHEL as per sub-clause 9 above), however, If at any point of time during the contract period, non-compliance of the provisions of the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 and the Building and other Construction Workers' Welfare Cess Act, 1996 and the rules made thereunder is observed, BHEL reserves the right to deduct the applicable cess (1%) on the contract value and penalty (if any, imposed by Cess Authorities) from the payables on account of non-compliance.
- 12. The contractor shall declare to undertake any liability or claim arising out of employment of building workers and shall indemnify BHEL from all consequences / liabilities / penalties in case of non-compliance of the provisions of the Building and other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 and the Building and other Construction Workers' Welfare Cess Act, 1996 and the rules made thereunder.

- 1. <u>Bidders shall quote Total Lump-sum Price for the entire scope of work in</u> **Rupees in VOL II PRICE BID at BHEL E-procurement Portal.** Any other entry elsewhere in the offer of the bidder shall be treated as Null and Void.
- 2. This Total Lump-sum Price shall be distributed based on the BHEL fixed percentage weightages w.r.t the total Total Lump-sum Price quoted by the bidder for the subject tender.
- 3. BHEL has pre-fixed the Weightage/Factor as detailed above in this chapter for deriving the Unit Rates. By multiplying BHEL pre-fixed the Weightages / Factor and the total prices derived in sl no. 2 above; unit rate of individual items shall be derived. Unit Rate/Item Rate thus arrived shall be rounded off to two decimal places.
- 4. Based on the quantities of individual item and the item rates arrived in Sl No 3 above, the total amount for individual items shall be derived. Total amount thus derived shall be rounded off to two decimal places.
- 5. Grand Total amount for the work shall be derived by BHEL by summing up respective total amounts.
- 6. Bidders to note that this is an item rate contract. Payment shall be made for the actual quantities of work executed at the unit rate arrived at as per Sl No.3 above.
