3.8.	If the bidder gives wrong information in his tender or creates conditions favorable for the acceptance of his tender, BHEL reserves the right to reject such tender at any stage.
3.9.	For the works which are continuous in nature, and which require regular interaction and monitoring, the bidder shall have an Office/Establishment in Bengaluru. Absence of such an arrangement may lead to disqualification of the Tenderer.

ANNEXURE – I SCOPE OF WORK

Sub: Special Instructions for Tender for Sub Contract Grinding of Insulators.

1. Cutting, grinding and finishing the porcelain insulator shells at sub contractor's works as per the drawing and technical instructions issued by BHEL/SBD time to time.
2. The contractor has to collect the insulator shells from BHEL-SBD premises as per the instructions given by the sub-contract cell as and when called for. The quantity allotted insulators has to be lifted safely with proper documentation viz., Sub-Contract Material Issue Voucher-SMIV, VAT forms, drawings, technical instructions etc, and safely transporting the same to sub-contractors works at their own cost.
3. Carry out the cutting, grinding and finishing operations as instructed and as per the drawings and other documents provided. The sub-contractor has to always confirm the requirements and if in doubt shall stop the work and consult officer-in-charge.
4. The sub-contractor has to observe the quality of the insulator before commencing the work, if any defective/damaged observed the same shall not be processed until concurrence is obtained from BHEL-SBD.
5. Further, if the sub-contractor observes any variation/abnormality in the insulators, the work has to be stopped and the same has to be brought to the notice of officer-in-charge for further action.
6. The Sub-contractor has to have all the requisite facilities for carrying out the subject work including jigs, fixtures, measuring instruments etc., and the specific requirements shall be arranged in consultation with officer-in-charge.
7. The sub-contractor has to return the ground insulators as per the return date mentioned in SMIV along with Delivery Chelan duly endorsed from security gate and also SMIV returnable copy acknowledged by security.
8. Sub-contractor has to provide two copies of the dimensional sheets and inspection report for every batch of insulators and every item processed.
9. Sub-contractor is responsible for the quality and completeness of the work entrusted. In case of any rework on ground insulators at any point of time, the sub-contractor is liable to collect the same from BHEL works again and carrying out the rework and return the reworked ground insulators. Rework if any is to be carried out at the works of sub-contractor.
10. The sub-contractor has to return all the collars, cut pieces and ground powder to BHEL –SBD along with the insulators and deposit the same at scrap disposal yard with due information to officer-in-charge.
11. The Sub-contractor has to ensure safe loading, unloading, transportation and handling of insulators during the entire process of sub-contract work from the time the insulators are handed over and till it is returned back to BHEL-SBD. Porcelain insulators being a fragile item, adequate care has to be taken by sub-contractors so that to avoid any damages. Transporting the insulators along with other item which may cause damage to insulators is not permitted.
12. BHEL will not be responsible for any road accidents during transportation of insulators and sub-contractors have to take enough care in transporting the insulators safely without any damage.
13. The vehicle used for transport shall be in good condition and have valid licenses and permits for transporting the insulators from BHEL-SBD premises and back, Sub-contractor has to ensure that the vehicle along with the insulators are not held/taken into custody by statutory authorities for any offence, failing which the sub-contractors will be held responsible and the consequent damages will be recovered from the security deposit and out standings due to the sub-contractor.



14. Any revision and or alternations in the drawing which calls for minor changes in the quantum of work to be carried out shall be full filled by sub-contractors in discussion with officer-in-charge.
15. The contract period can be extended for one more year on mutual agreement between BHEL - SBD management and the sub-contractor.
16. Violation of any scope of sub-contract works or rules and regulations of company's requirement, BHEL-SBD management will have the right to withdraw the sub-contract works at any point of time without any notice.
17. The insulator lot taken for grinding must be ground and returned back to BHEL-SBD within 7 days from the date of handover of lot.

INSTRUCTIONS/PROCEDURE TO VENDORS FOR GRINDING OF INSULATORS

1. Study the drawing of given insulator for all the grinding dimensions.
2. Check lathe setting and adjust if necessary.
3. Check the cut off wheel and grinding wheel for cracks before using.
4. Fix the cutting wheel to the wheel post.
5. Select the proper mandrel set.
6. Fix the mandrel inside the bore of the bushing.
7. Through the mandrel accurately.
8. Mount the bushing on the lathe between centers.
9. Switch on the coolant system wherever applicable.
10. Complete the cutting and grinding operation so as to finish the bushing shell as per the drawing. Use micrometer where tolerance on diameter is less than 0.1mm.
11. Unload the bushing from lathe.
12. Clean the lathe, keep the mandrel set and drawings and other tools in their respective storage places.
13. In case any variation in dimensions w.r.t drawing observed consult In-charge before start of the cutting.
14. Always Handle the Insulators carefully to avoid chipping and breakage.
15. Check and ensure the dimensions and cleanliness of the Insulators before delivery of the products and before offering to Quality Control.


