# PRICE BID

## Chapter-I: Instructions to the Bidder

- 1.1 Bidders to quote their most competitive total rate either for Category-I or Category-II or both for Category-I and Category-II as terms (both in figure and in words) in prescribed format of **"Price Bid"**.
- 1.2 Before filling the 'price', the bidder shall go through the detailed specification as well as Scope of Work as specified in relevant Clause of this tender.
- 1.3 Contractor shall fully understand the description and scope of work before quoting. The scope of work and responsibility of the contractor as mentioned under these specifications shall be covered within the quoted / finally accepted rates.
- 1.4 Service charges per day will be paid for 10 hours per day. Agency shall be available for work minimum 10 hours per day including one-hour brake. Generally, the work is to be carried out as per the BHEL timings at site. However, depending upon the requirements / exigencies, the job is to be continued beyond normal working hours. Sometimes round the clock, tenderer should provide required man power to meet the needs as part of contract and the payment for the extended hours of work will be made proportionately at the accepted service charges per day.

Rate per Hour = Rate per day / 10 Hours.

- 1.5 One-time Travelling Charges for to and fro movement from bidder's location to site (for commencement of works) and from site to bidder's location (after completion of work) is payable to the bidder and will be reimbursed at actual cost incurred as certified by BHEL Site Engineer-In-Charge. However, the maximum limit for travel charges will be limited to AC-III tier train fare for Engineer & to Second Sleeper train fare for technician.
- 1.6 Service charges shall be payable whenever the services are provided during the holidays. Service charges shall be payable as per the accepted rates for service.
- 1.7 Certificate shall be obtained from the Engineer-in-charge of BHEL for Non provision of local conveyance at site. Local conveyance charges as applicable will be paid based on the certificate received from Engineer-in-Charge.
- 1.8 Service charges during journey period will be paid 50% of the applicable service charges on journey period.
- 1.9 Service charges shall not be payable when there is no work on holidays. However, accommodation charges shall be payable if the services are commenced and continued before and after holidays.
- 1.10 No accommodation charges will be paid at sites if the distance between site and Vendor's works is less than 40KM. However, in the event of emergency works, if the vendor has to stay back and continue their work round the clock, accommodations charges may be considered
- 1.11 Service charges shall be payable for the idle period during regular working days provided the reasons for idleness not attributable to the contractor and attributable to BHEL.
- 1.12 Unskilled workers, if required shall be provided by BHEL/BHEL Sub contractor free of cost, at the discretion of Engineer-in-Charge.
