04	<p><b>TAXES &amp; DUTIES:</b></p> <p><b>4.1</b> The Supplier/Vendor shall pay all (save the specific exclusions as enumerated in this clause) taxes, fees, license, charges, deposits, duties, tools, royalty, commissions, other charges, etc. which may be levied on the input goods &amp; services consumed and output goods &amp; services delivered in course of his operations in executing the contract. In case BHEL is forced to pay any of such taxes/duties, BHEL shall have the right to recover the same from his bills or otherwise as deemed fit along with the applicable overheads @5% and interest on the total value (i.e. amount paid by BHEL + overhead).</p>	

<p>However, provisions regarding <b>GST</b> on output supply (goods/service) and TDS/TCS as per Income Tax Act shall be as per following clauses.</p> <p><b>4.2 GST (Goods and Services Tax)</b></p> <p><b>4.2.1</b> GST as applicable on output supply (goods/services) are excluded from Supplier/Vendor's scope; therefore, contractor's price/rates shall be exclusive of GST. Reimbursement of GST is subject to compliance of following terms and conditions. BHEL shall have the right to deny payment of GST and to recover any loss to BHEL on account of tax, interest, penalty etc. for non-compliance of any of the following condition.</p> <p><b>4.2.2</b> The admissibility of GST, taxes and duties referred in this chapter or elsewhere in the contract shall be limited to direct transactions between BHEL &amp; its Supplier/Vendor. BHEL shall not consider GST on any transaction other than the direct transaction between BHEL &amp; its Supplier/Vendor.</p> <p><b>4.2.3</b> Supplier/Vendor shall obtain prior written consent of BHEL before billing the amount towards such taxes. Where the GST laws permit more than one option or methodology for discharging the liability of tax/levy/duty, BHEL shall have the right to adopt the appropriate one considering the amount of tax liability on BHEL/Client as well as procedural simplicity with regard to assessment of the liability. The option chosen by BHEL shall be binding on the Contractor for discharging the obligation of BHEL in respect of the tax liability to the Supplier/Vendor.</p> <p><b>4.2.4</b> Supplier/Vendor has to submit GST registration certificate of the concerned state. Supplier/Vendor also needs to ensure that the submitted GST registration certificate should be in active status during the entire contract period.</p> <p><b>4.2.5</b> Supplier/Vendor has to issue Invoice/Debit Note/Credit Note indicating HSN/SAC code, Description, Value, Rate, applicable tax and other particulars in compliance with the provisions of relevant GST Act and Rules made thereunder.</p> <p><b>4.2.6</b> Supplier/Vendor has to submit GST compliant invoice within the due date of invoice as per GST Law. In case of delay, BHEL reserves the right of denial of GST payment if there occurs any hardship to BHEL in claiming the input thereof. In case of final invoice/ bill, contractor has to submit proof of such return within fifteen days from the due date of relevant return.</li><li>f) Respective invoice has appeared in BHEL's GSTR - 2A for the month corresponding to the month of invoice and in GSTR-2B of the month in which such invoices has been reported by the contractor along with status of ITC availability as "YES" in GSTR-2B. Alternatively, BG of appropriate value may be furnished which shall be valid at least one month beyond the due date of confirmation of relevant payment of GST on GSTN portal or sufficient security is available to adjust the financial impact in case of any default by the Supplier/Vendor.</li><li>g) Supplier/Vendor has to submit an undertaking confirming the payment of all due GST in respect of invoices pertaining to BHEL.</li></ul> <p><b>4.2.9</b> Any financial loss arises to BHEL on account of failure or delay in submission of any document as per contract/purchase order/work order at the time of submission of Tax invoice to BHEL, shall be deducted from Supplier/Vendor's bill or otherwise as deemed fit.</p> <p><b>4.2.10</b> TDS as applicable under GST law shall be deducted from Supplier/Vendor's bill.</p>

<p><b>4.2.11</b> Supplier/Vendor shall comply with the provisions of e-way bill wherever applicable. Further wherever provisions of GST Act permits, all the e-way bills, road permits etc. required for transportation of goods needs to be arranged by the contractor.</p> <p><b>4.2.12</b> Supplier/Vendor shall be solely responsible for discharging his GST liability according to the provisions of GST Law and BHEL will not entertain any claim of GST/interest/penalty or any other liability on account of failure of Supplier/Vendor in complying the provisions of GST Law or discharging the GST liability in a manner laid down thereunder.</p> <p><b>4.2.13</b> In case declaration of any invoice is delayed by the vendor in his GST return or any invoice is subsequently amended/ altered/ deleted on GSTN portal which results in any adverse financial implication on BHEL, the financial impact thereof including interest/penalty shall be recovered from the Supplier/Vendor's due payment.</p> <p><b>4.2.14</b> Any denial of input credit to BHEL or arising of any tax liability on BHEL due to non-compliance of GST Law by the Supplier/Vendor in any manner, will be recovered along with liability on account of interest and penalty (if any) from the payments due to the Supplier/Vendor.</p> <p><b>4.2.15</b> In the event of any ambiguity in GST law with respect to availability of input credit of GST charged on the invoice raised by the contractor or with respect to any other matter having impact on BHEL, BHEL's decision shall be final and binding on the Supplier/Vendor.</p> <p><b>4.2.16 Variation in Taxes &amp; Duties:</b></p> <p>Any upward variation in GST shall be considered for reimbursement provided supply of goods and services are made within schedule date stipulated in the contract or approved extended schedule for the reason solely attributable to BHEL. However downward variation shall be subject to adjustment as per actual GST applicability.</p> <p>In case the Government imposes any new levy/tax on the output service/goods after price bid opening, the same shall be reimbursed by BHEL at actual. The reimbursement under this clause is restricted to the direct transaction between BHEL and its Supplier/Vendor only and within the contractual delivery period only.</p> <p>In case any new tax/levy/duty etc. becomes applicable after the date of Bidder's offer but before opening of the price Bid, the Bidder/ Supplier/Vendor must convey its impact on his price duly substantiated by documentary evidence in support of the same before opening of price bid. In case of rejection at any stage, Supplier/Vendor shall be liable to replace the materials at his own cost.</p> <p>Vendor should raise inspection call for BHEL / TPI inspection at least 4 days in advance to the planned date of inspection. If customer inspection is envisaged at vendor's works, vendor should give inspection call at least 7 days in advance to the planned date of inspection.</p>

Wherein the period as stipulated in the notice issued under clause 14.1 has expired and Supplier/Vendor has failed to remedy the breach, BHEL will have the right to terminate the contract on the ground of "Breach of Contract" without any further notice to contractor.</li> <li>ii. Upon termination of contract, BHEL shall be entitled to recover an amount equivalent to 10% of the Contract Value for the damages on account of breach of contract committed by the Supplier/Vendor. This amount shall be recovered by way of encashing the security instruments like performance bank guarantee etc available with BHEL against the said contract. In case the value of the security instruments available is less than 10% of the contract value, the balance amount shall be recovered from other financial remedies (i.e. available bills of the Supplier/Vendor, retention amount, from the money due to the Supplier/Vendor etc. with BHEL) or the other legal remedies shall be pursued.</li> <li>iii. wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is 10% of the contract value or more, such security instruments to the extent of 10% contract value will be encashed. 

**6.0 Blank & Material Properties of Valve Cover:**

Rough machined casting of Valve Cover, including pre-requisite semi-finish/finish machining operations such as the front reference face of the bore and steady supporting diameter, will be provided. These machining operations are necessary to prepare the Valve Cover for ejector drilling and counter boring operations on the CNC Lathe.

The rough machined casting of Valve Covers are made of G17CrMoV5-10 material grade steel, possessing exceptional mechanical properties. The material has a 0.2% proof stress of  $\geq 440$  N/Sq.mm, ultimate tensile strength (UTS) of 590-780 N/Sq.mm, %EI ( $l=5d$ ) of  $\geq 15\%$ , %Ra of  $\geq 40\%$ , and impact strength of  $\geq 27J$ .

The chemical composition, as per EN 10213, includes precise percentages of various elements to ensure the desired material characteristics.

**7.0 Acceptance and Set/Lot Supply Criterion: -**

**7.1** The vendor tool trial shall be conducted after PO placement for the package/packages against which the vendor is declared L1. The vendor shall arrange one number of tool head, along with sufficient consumables (inserts, pads, cartridges, and screws), of the qualified package, on a returnable basis and free of cost, for conducting machining trials prior to complete supply. After successful completion of the trial, the vendor shall supply the complete scope of supply as per Clause No. 2.0. Further, if PO has been placed to the vendor for two or more packages, the vendor shall bring the one number of tool head corresponding to the highest diameter, along with sufficient consumables (inserts, pads, cartridges, and screws), for conducting the trial.

**7.2** The outer and inner tubes (424.2.819 & 424.2.869 of Sandvik equivalent) will be provided by BHEL for mounting the ejector head for trial. Vendor to ensure compatibility of drilling heads with existing tubes. For ensuring the compatibility vendor can visit and study the existing ejector drilling system.

**7.3** The trial shall involve the successful machining of one deep hole on the Valve Cover using the tool head and consumables supplied for the trial (without wear and tear), as per the machining strategy mentioned in Clause 1.0, while meeting all drawing accuracy and dimensional requirements.

**7.4** The vendor must keep additional consumables (Inserts, Pads, Cartridge, Screws), of each type readily available to ensure uninterrupted trial machining and avoid any delays in project completion, as per the scope defined in the tender.

**7.5** In the event of damage to any item during the trial—due to improper tool selection or cutting parameters, unsuitable tool or adaptor supply, or improper tool-adaptor fitting the vendor shall replace the affected items at no financial cost to BHEL.

**7.6** The vendor shall be permitted to supply the complete package as per Clause 2.0 only after successful completion of the trial.

**7.7** The head and consumable used during the successful trial (if undamaged) may be included as part of the final supply.

**7.8** Payment for the complete supply under Clause 2.0 shall be made only after successful trial and acceptance of complete supply.

**8.0** During implementation, if the tools recommended by vendor could not be established in one go, without interruption, they may be given maximum two further chances to improve upon and establish the machining without interruption through change of tool/insert grade.

**9.0** The complete machining process will be performed on the CNC Lathe SOC 1100mm, manufactured by M/s Karats Japan, utilizing the CNC programs provided by BHEL. These programs will be developed based on the inputs provided by the vendor. The CNC Lathe possesses significant specifications, including:



These specifications ensure the machine is capable of handling the complex machining operations required for the Valve Cover with precision and efficiency.

- 10.0** Vendor must ensure compatibility with existing remaining system and confirm.
- 11.0** One complete tooling set/package should be procured from single source for compatibility reason.
- 12.0** The insert geometry & grade should be suitable for smooth chip flow and productive machining & chip breaking.
- 13.0** If vendor requires any clarification, they may discuss with BHEL for any clarifications prior to submission of their offer to avoid any gaps at later stage.
- 14.0** Vendors should submit offers, complete in all respect i.e. with all tool drawings for all special items, copies of catalogue pages for all standard items, list of consumables/spares for each tool etc. Prices of individual items should be mentioned in the commercial offer.
