PACKING & MARKING

The material shall be supplied as liquid in cylinders or tank cars of approved design. The cylinders shall conform to the 'Gas Cylinder Rules - 1940' of the Government of India with such modifications as may be ordered from time to time by the Chief Inspector of Explosives, Government of India or other duly constituted authority. The tank cars shall conform to the specification as approved by the appropriate authorities of Indian Railways or other duly constituted authority. The cylinders shall also be marked with BIS certification mark.

The cylinder ground colour shall be black and the colour band shall be signal red and golden yellow (colour code No 537, 356 of IS 5).

All cylinders shall be securely tagged with the following information:
