Qualifying criteria for the new vendors -Pre-qualification creteria

1. The supply shall be as per our Specification RAH-513 Rev 00 & RAH-519 Rev 00 only. Deviation if any, the "deviation summary " shall be submitted for our technical evaluation.
2. The Bidder is required to meet the proven-ness criteria for Multimedia cleaning device for Air Preheater application as per criteria stipulated below.

The Bidder should have previously designed, manufactured and supplied "Retractable type multimedia cleaning device with Control system" for Air Preheater application in a Boiler or Gas to Gas heater application in a Flue Gas Desulfurization system. The device should be capable of cleaning the heating elements using High pressure water, Steam & Air.

The device should have been designed for operating not less than 200 Kg/cm²(g) for Water and 12 Kg/cm²(g) at 300 deg C for Steam and flue gas at 100 deg C around the lance. It shall be in successful operation in at least one (1) plant for a period of not less than one (1) year on the date of techno-commercial bid opening.

3. The following information should be submitted by the vendor where the Multimedia cleaning device has been supplied:
 - a. Name of the customer & Project details where the Cleaning device is supplied.
 - b. Water pressure & Steam pressure for which the device is designed for
 - c. Complete postal address of the customer.
