

PRE QUALIFICATION REQUIREMENT
For SET SCREW BALL BEARING 3-15/16” (63H)320

QUALIFICATION CRITERIA:

The Bidder must satisfy the following Qualification Criteria for participating in the Tender.

- (1) Only those vendors, who have supplied SET SCREW BALL BEARING (63H) or equivalent to any Govt/Private organizations in the past 2 years (On the Date of Opening of tender), should quote.
- (2) Vendor should be a designer & manufacturer of set screw ball bearings, In case of authorized Indian representative for foreign manufacturers (OEM), they have to submit authorization letter from their Principle.
- (3) Product catalogue should be submitted along with the enquiry.
- (4) Supplier should have production capability of minimum 900Nos of Bearings per annum.
- (5) Name of the customers / companies where SET SCREW BALL BEARING or similar items have been supplied with complete postal address.

Bidder shall submit documents in support of possessing qualifying requirements as under, duly self-certified and stamped by the authorized signatory.

- (ii) Certified Photocopies of work orders issued by the Customer containing details of bill of quantities/schedule of rates and certificates for proof of satisfactory completion of work.
- (iii) Certified Photo copies of Audited profit and loss account accompanied by relevant schedules for turn over figures.
