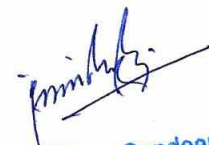

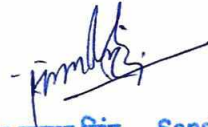

1. Rates have to be **quoted FOR BHEL Rudrapur basis** only with 100% payment after **supply & Receipt** of material at BHEL and within 45 days subject to successful **Installation** of Camera. Any deviation in payment terms will be loaded @ (SBI Prime Lending Rate on technical bid opening date +6)% annual interest for comparing standing
 2. The validity period of the quotation must be for 3 months from the date of quotation.
 3. **Supply & Installation** of the CCTV Camera at BHEL Rudrapur within **04 weeks** from the date of placement of Purchase Order.
 4. All items to be installed at different buildings (2 CCTV at Canteen and 01 near water tank) in BHEL Rudrapur.
 5. In case of any deviation in delivery terms, loading on offer will be done (0.5 % per week, maximum up to 10 %) for comparing standing.
 6. Late Delivery penalty shall be applicable @0.5% per week.
 7. Supplier has to **submit performance Bank guarantee @10 % of PO value** from the date of acceptance by BHEL (Date of successful Installation & commissioning of CCTV Camera). PBG shall be furnished in a prescribed format and from one of the consortium banks of BHEL. PBG shall be valid up to 60 days beyond warranty/guarantee period. Format of PBG is attached for reference.
 8. Warranty-minimum Two year onsite warranty is required from the date of successful installation of CCTV Camera.
 9. Offers to be submitted in **Two part bid** system i.e. in **two separate envelopes** subscribed as:
 - (I) **Technical bid containing technical offer along with Commercial Term and conditions + un-priced copy of the price bid only.**
 - (II) **Price bid containing only price of the items.**Seal both the envelopes separately and put them in a **third envelop**.
- Offers submitted in single bid shall not be considered.** ←
- 10. **Points mentioned in Annexure-'A' are mandatory and pre-qualification requirements** for qualifying in this tender. If any bidder fails to submit confirmation and relevant documents against mentioned points his offer will be liable to reject.
 11. Supplier shall confirm compliance of following:
 - a. **Annexure-I (Scope of supply).**
 - b. **Annexure-II (Item Specifications-4 pages).**
 - c. **Annexure-III (Special terms & conditions)**
 - d. **Annexure-IV (Tender Terms & Conditions)**Send all the above Annexures along with your **technical offer i.e. with part I (signed & stamped)** else offer shall be liable to reject.
 12. Supplier shall submit catalogue of Equipment (if any) along with offer (Along with techno-commercial bid)
 13. Test certificates required with material.
