1) QUALIFYING CRITERIA

Qualifying conditions cum Eligibility Criteria for works contract to carry out operations in Detail machine shop for the period valid up to 30-JUN-2020.

The bidders should fulfill following qualifying criteria:

- 1.1) Bidders should submit relevant documents like IT return, GSTIN, Labour License, ESI, PF in Techno-commercial bid.
- 1.2) Minimum Average Annual Financial Turnover of firm during last 3 financial years to be **Rs. 3.11 lakhs** /-, Audited balance sheet , profit/loss statement for the last 3 years to be submitted.
- 1.3) The bidder should have the experience of having successfully completed similar work order in industry or an establishment of Government/ Public / Private sector during April 2012 To September 2019 (Copy of work order & corresponding completion/Experience certificate in prescribed format to be submitted in proof of experience) attached page 2 of 2 Annexure-A

Three similar completed works of contract value not less than **4.14 Lakhs.**

Or

Two similar completed works of contract value not less than **5.17 Lakhs.**

Or

One similar completed works of contract value not less than **8.28 Lakhs.**

In case of similar works executed in the private sector, TDS certificate regarding the fulfillment of work order has to be submitted along with the work completion certificate.

Similar work means carrying out Lathe machining operations in machine shop specially focused on machining of detail components of steam turbines, nuclear turbines, naval turbines, manufactured detail components with .

Supporting document list for similar work executed

- a) The bidding firms shall submit the works order copies & its completion certificates to prove the desired experience. The works completion certificate for previous work execution in BHEL should be submitted as per the prescribed format in Annexure A duly approved by an executive not below the rank of DGM & certified through HR. In case of similar works executed in the private sector, TDS certificate regarding the fulfillment of work order has to be submitted along with the work completion certificate. Only the firms meeting the above requirements shall be qualified technically for further processing of tender i.e. the price bid will be opened for technically qualified parties only.
