1.1	Bidder must be original Manufacturer of DMC BLOCK. Offers of traders/stockiest/Agent shall not be considered.	
1.2	Bidder must have in-house necessary manufacturing facilities and testing facilities for manufacturing of DMC BLOCKS.	
1.3	Bidder must have manufactured & supplied at least One Thousand(1000 nos.) DMC Block during the last three years. Bidders has to submit proof of supply as purchase orders or excise invoice.
