Sealed tenders are invited under two part bids systems (part-1- Techno commercial bid and part-2- price bid). The agencies who are authorized by Atomic Energy Regulatory Board can be participated. Documentary poof has to be submitted under techno commercial bid in support of authorization by AERB.

The offer shall reach in the **Tender Box, 1st floor, Kasturba Hospital Habibganj, BHEL Bhopal, P.O. – Habibganj - 462024, M.P.** Up to 11.00 am on or before the due date and shall be opened on the same day at 2.00 pm. Details of the tender are as follows:-

1) SCOPE OF WORK: The party shall undertake to carry out the following services with respect to the subject system/equipment.

- 1.1) Quality assurance test and AERB (Atomic Energy Regulatory Board) registration of 07 nos X-ray machines installed in Kasturba Hospital BHEL Bhopal.
- 1.1) After the quality assurance test, certificate along with the status of the x-ray machines shall be furnished. The sticker/certificate should clearly mention the date of test and the status of the machines and the next date of test/calibration.

2) Reason for work contract:-

- 2.1) The purpose of QA program is to ensure the accuracy of the diagnosis.
- 2.2) As per AERB the minimum radiation dose should be delivered to the patient to achieve the objectives of diagnostic or interventional procedure.
- 2.3) x-ray machines should perform satisfactory in compliance with safety standards specified by the AERB.

3) Qualification Criteria:-

3.1 Agency should be registered with AERB for carrying out the quality assurance test and registration. Documents in this regard shall be supplied by contractor along with the offer.

4) TERMS OF PAYMENT: The payment shall be made as under:

3.1) 100% against completion of the work.

3.2) The payment shall be subject to deduction of income tax at source as per the applicable rules of Department of Income tax.

5) EMD and security deposit :- EMD of Rs 3145/- (exclusive of GST) shall be deposited through EFT in favor of BHEL Bhopal. Security deposit @5% of the contract value shall be paid by the contracted party. This should be deposited by the party in advance or will be recovered from the payment to be released by BHEL.

6) STATUTORY REQUIREMENTS: In the event of award of contract, you will have to observe/perform all the laws/enactment of Central/State Government being in force for such type of work/services during the contract period. Details like your P.F. Account No., ESI Reg. No., Income tax PAN No allotted by the concerned authority, Documents regarding your GST Registration (Self attested) etc. are all to be furnished in your quotation.

7) COMPENSATION FOR DELAY: If the engineer/ technician is not deployed within 30 working days from the receipt of the formal WO/PO, penalty of ½ percent per week up to a maximum of 10 % of the work order value will be deducted.

8) Accepting authority reserves the right to reject any or all quotations without assigning any reason thereof.

9) Quotations must be valid for at least 60 days.

10) All the documents being sent herewith should be returned back to us duly signed on each paper along-with your offer.

11) The contractor will have to sign a contract agreement on stamp paper of Rs 500/- and all the details of the work order will have to be reproduced in it within a week from issue of wo.
