## **PREAMBLE OF PRICE BID**

1.0. This Price Bid consists of three Schedules:

### **1.1 Schedule A**

Schedule A consists of single Annexure:

**Bidders are requested to quote their rate in Percentage above/below/at Par for Annexure-I.**

### **1.2 Schedule B**

Schedule B gives the details of free issue materials given by BHEL.

### **1.3 Schedule C**

Schedule C gives the details of Tools & Tackles provided by BHEL on Chargeable Basis.

2.0 The work to be carried out under the contract shall, except as otherwise provided in tender conditions, include all labour, materials, tools, plant, equipment, and transport which may be required in preparation of and for full & entire execution and completion of the Works. The descriptions given in the Schedule of Quantities shall, unless otherwise stated, be held to include waste on materials, carriage and cartage, carrying in return of empties, hoisting, setting, fitting and fixing in position and all other labours necessary in and for the full and entire execution and completion as aforesaid in accordance with good practice and recognized principles as laid down in Technical Specification & elsewhere in Tender Specification.

3.0 The price bid should not contain any condition. Conditional price Bids shall be summarily rejected.

4.0 The bidder should not leave any column blank in Price Schedules.

5.0 Price Quoted shall include all taxes, & duties except GST.

6.0 **Unless otherwise specified in the items involving cement or reinforcement steel, these items shall be issued free of cost by BHEL.**

<b>Note :-</b>						
	1)	The work shall be executed at different locations in BHEL Township area.				
	2)	The machine with operating staff shall be called by BHEL on as and when required basis.				
	3)	The machine and the operating staff to be deployed by the contractor shall have first party insurance cover against any damage / breakage / injury / casualty / eventuality during the eviction activities. BHEL shall not be held responsible directly or indirectly for any damage/breakage/injury/casualty/eventuality caused to the machine / operating staff engaged by the contractor. No claim of the contractor shall, therefore, be entertained by BHEL in this regard.				
	4)	Minimum utilization time of the machine shall be reckoned as <b>four hours a day</b> .				
	5)	For eviction activity, the machine shall be required to report at the designated place of Sampada Bhawan, Hostel No 4 at any time of the day as instructed by BHEL and nothing extra over and above the awarded rate shall be payable to the contractor for work beyond normal working hours.				
	6)	The unit 'Hour' for measurement purpose shall be reckoned from reporting time up to completion of work at site / release of machine from site.				
	7)	A logbook shall be maintained to record hours of deployment which shall be duly certified by authorized personnel / official of BHEL for payment purpose.				

	8)	In addition to eviction activities, the machine may also be deployed / engaged for earthwork, levelling, loading, unloading, dismantling & demolishing works in BHEL Township on as and when required basis.
	9)	In case of non-deployment of the machine and the operating staff on specified day/time by the contractor in spite of instructions of BHEL, penalty shall be imposed at double the awarded rate for four hours.
		In case, such a default is repeated in future, the department may go in for termination of the contract at his risk and cost along with other penal action as deemed fit by the department such as non-consideration of the defaulting contractor in subsequent tender(s) etc.
	10)	In addition to first party insurance cover of the machine including the operating staff, it shall be provided/loaded with additional spare wheels, guarded wind screen (metallic mesh), first aid kit, fire extinguisher and safety gears (such as helmet, safety shoes, chest protector, safety glasses, etc.) for the operating staff.
		Providing all the above-mentioned safety features is mandatory. If these are not provided to the operating staff/machine, the contractor shall not be allowed to carry out eviction activity for which the contractor only shall be held responsible. In such a case, a minimum penalty of twice the awarded rate for four hours shall be imposed on the contractor.
		In case, such a default is repeated in future, the department may go in for termination of the contract at his risk and cost along with other penal action as deemed fit by the department such as non-consideration of the defaulting contractor in subsequent tender(s) etc.
