Schedule C gives the details of Tools & Tackles provided by BHEL on Chargeable Basis.

2.0 The work to be carried out under the contract shall, except as otherwise provided in tender conditions, include all labour, materials, tools, plant, equipment, and transport which may be required in preparation of and for full & entire execution and completion of the Works. The descriptions given in the Schedule of Quantities shall, unless otherwise stated, be held to include waste on materials, carriage and cartage, carrying in return of empties, hoisting, setting, fitting and fixing in position and all other labours necessary in and for the full and entire execution and completion as aforesaid in accordance with good practice and recognized principles as laid down in Technical Specification & elsewhere in Tender Specification.

3.0 The price bid should not contain any condition. Conditional price Bids shall be summarily rejected.

4.0 The bidder should not leave any column blank in Price Schedules.

5.0 Price Quoted shall include all taxes, & duties except GST.

6.0 **Unless otherwise specified in the items involving cement or reinforcement steel, these items shall be issued free of cost by BHEL.**

Capacity of tractor shall be 35 HP or more of standard make such as Escorts, HMT, Ferguson etc, which can carry water tanker of different capacities for water supply work on as and when required basis as per the direction of engineer-in-charge. 1	A Logbook shall be maintained on daily basis for the above item.				
2	In spite of instruction by Engineer-in-charge, if the contractor fails to deploy tractor in a shift, penalty will be imposed at double the awarded rate of the contract. Non-deployment of driver shall deemed to be non-deployment of tractor.				
3	Tractor model shall not be older than five years & it shall be in good running condition. For this, RTO registration copy along with other RTO papers shall be submitted to department for verification before actual deployment.				
4	Number of tractor to be deployed in the shift shall be minimum one and maximum three as per the instruction of engineer-in-charge.				
5	The contractor may be required to deploy tractor for supply of water on all days including Sundays and Holidays without extra cost to BHEL over and above the awarded rate.				
6	The tractor deployed shall not stand idle for want of fuel/maintenance/man power. In the event of the same, BHEL shall have the liberty to make alternate arrangement at contractor's risk & cost without any prior notice whatsoever as the work is essential in nature.				
7	Tractor & driver may be required to be deployed for supply of water in BHEL township as well as in satellite colonies of BHEL (up to a distances of 5 kms ). Supply of diesel will be in the scope of contractor. Tanker with water will be provided by BHEL.				
8	In case of break-down in the tractor, the contractor shall arrange for a substitute tractor or arrange to restore the break-down vehicle to working condition within a reasonable time (not more than 4.00 hours in any case), otherwise penalty shall be imposed against the contractor as mentioned below:- - If the time for restoration of services in case of the above said break-down exceeds 4.0 hours, deduction shall be made on pro-rata basis per hour delayed @ 1.50 times the awarded rate (considering a shift of 8 hours) subject to the condition that the work has suffered in the opinion of engineer-in-charge. - But if the time for restoration of services in case of the above said break-down exceeds 4.0 hours, deduction shall not be made from the contractor's bill subject to the condition that the work has, in spite of this default by the contractor, not suffered in the opinion of engineer-in-charge.				
9	The unit per shift means 8 working hours in a day.				
10	Helper will be provided by the department for surity of supply of water tanker at right place.
