(2) In case of delivery earlier than 30 days from scheduled delivery date (only if desired by BHEL through written request): Price will be calculated based on rates on the date one month prior to GST Invoice date.

(3) Any deviation w.r.t. PVC clause during execution of order may lead to rejection of material if not agreed thereof.

1. **If NALCO, Base rates** are not available on said date, then latest previous date on which both are available will be used.
